

**ARTICLES OF ORGANIZATION
OF
Bhammayans, LLC**

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Act"), files the following Articles of Organization with the probate office of the county in which the initial registered office of the limited liability company will be located and affirms that the facts stated herein are true and correct.

ARTICLE ONE

NAME

The name of the limited liability company is **Bhammayans, LLC** (THE
"COMPANY").

ARTICLE TWO

DURATION

The term of the Company shall be perpetual from the date of the filing of these Articles of Organization with the probate office of the county in which the initial registered office of the Company is located, unless the Company is earlier dissolved in accordance with the operating agreement of the Company or the Alabama Limited Liability Company Act.

ARTICLE THREE

Purposes, Objects, and Powers

The purposes, objects and powers of the Company are:

1. To own and operate a full service restaurant business and to supervise the operations thereof, and to provide services related thereto, including obtaining and protecting related property rights;

- (a) To engage in any lawful business, act or activity for which a Company may be organized under the Act, it being the purpose and intent of this Article III to invest the Company with the broadest purposes, objects and powers lawfully permitted a Company formed under the act.

ARTICLE FOUR

REGISTERED AGENT/OFFICE

The location and street address of the initial registered office of the Company is: 173 Green Park S. Pelham, AL 35124. The name of its initial registered agent at such address is: April Perez.

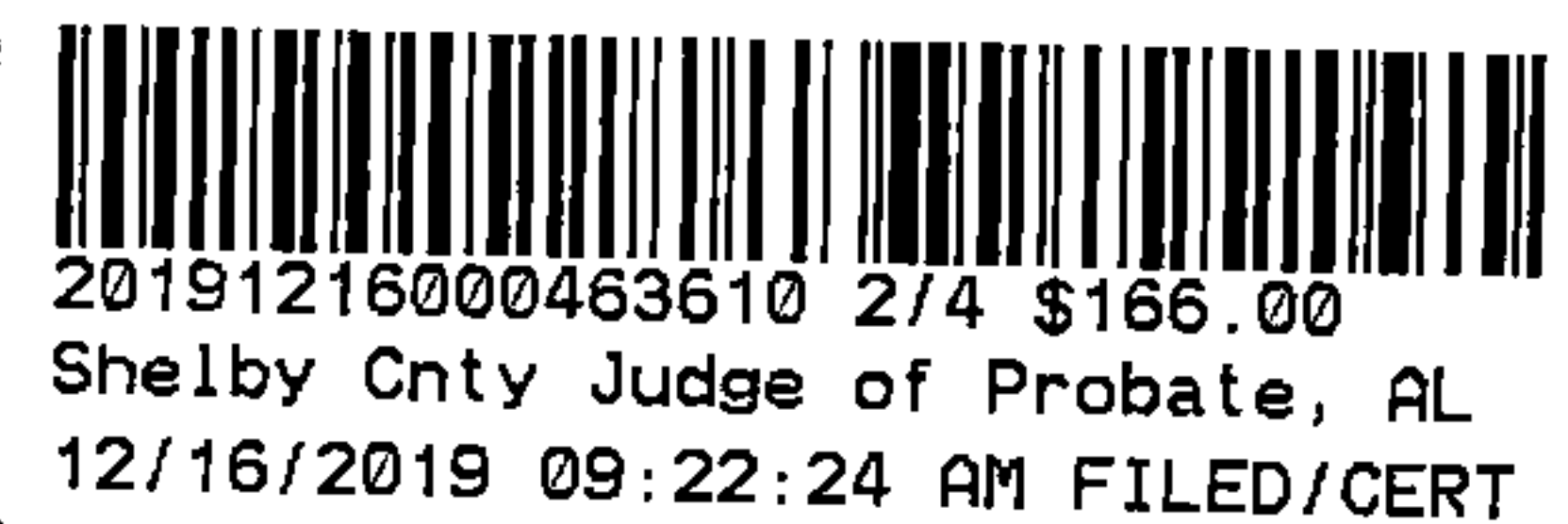
ARTICLE SIX

ADDITIONAL MEMBERS

The Company shall be managed by its members pursuant to the Act and the Operating Agreement. The property, business, and affairs of the Company shall be managed by, and its limited liability company powers exercised by its Member-Managers.

ARTICLE EIGHT

DISSOCIATION OF A MEMBER

The legal existence and business of the Company may be continued by the written consent of all the remaining members within 90 days after an event of dissociation of a member.

ARTICLE NINE

OPERATING AGREEMENT

The initial members intend to execute an Operating Agreement (as from time to time amended, and the "Operating Agreement") to regulate and establish the internal affairs of the Company, the conduct of its business, and the relations of its members. Upon the execution of the Operating Agreement by the initial members named herein, the Operating Agreement shall be incorporated into these Articles of Organization by this reference.
