The limited liability company is organized for the purpose of commercial and residential construction and contracting, and for the purpose of transacting any lawful business for which a limited liability company may be organized.

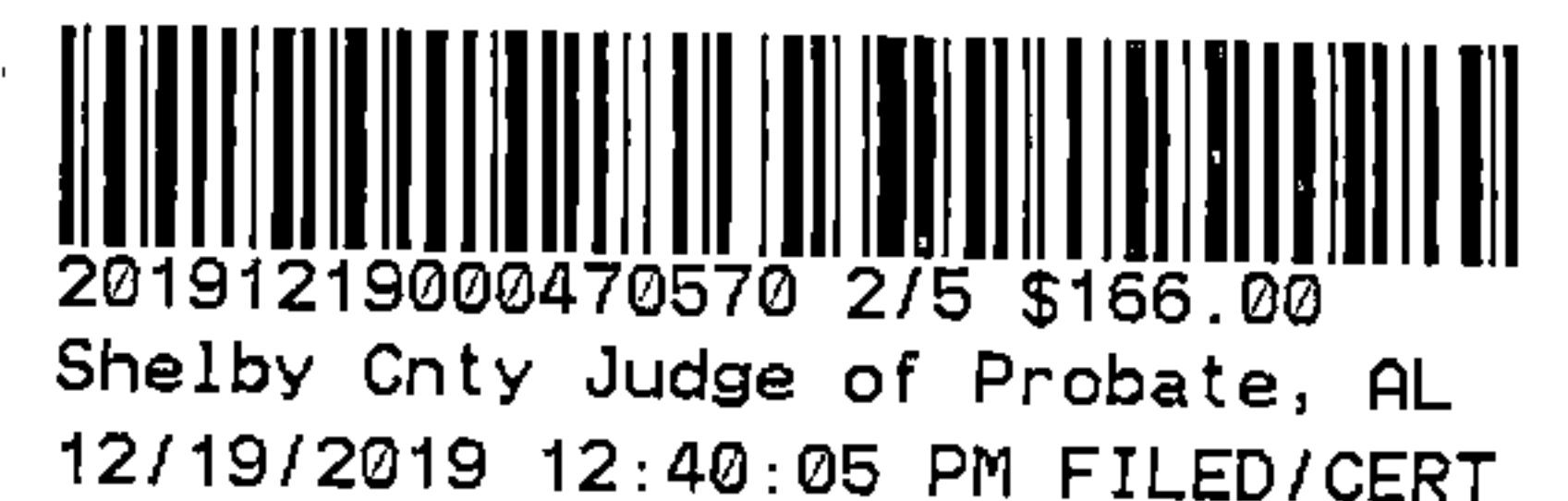
#### Article VII



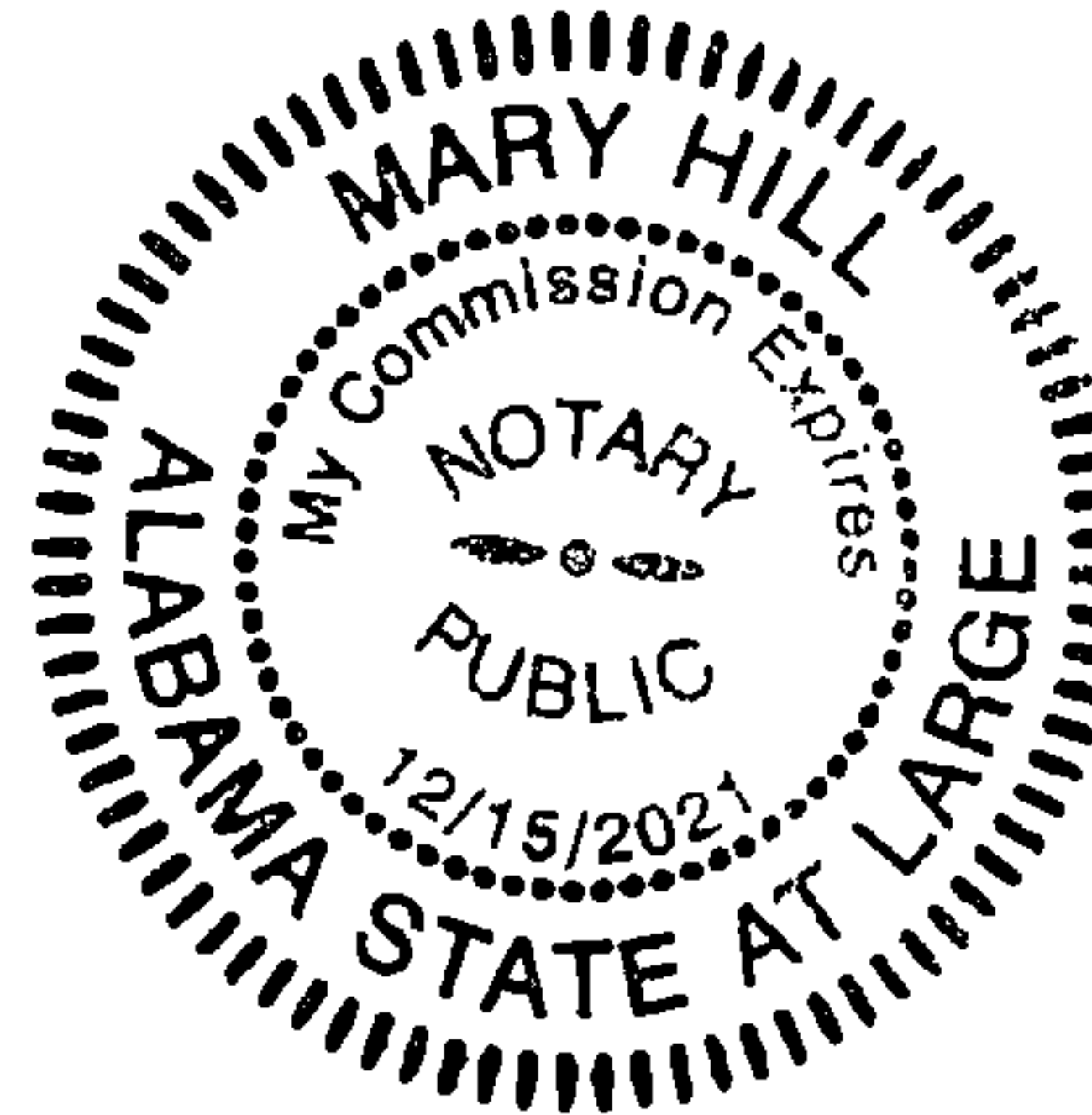

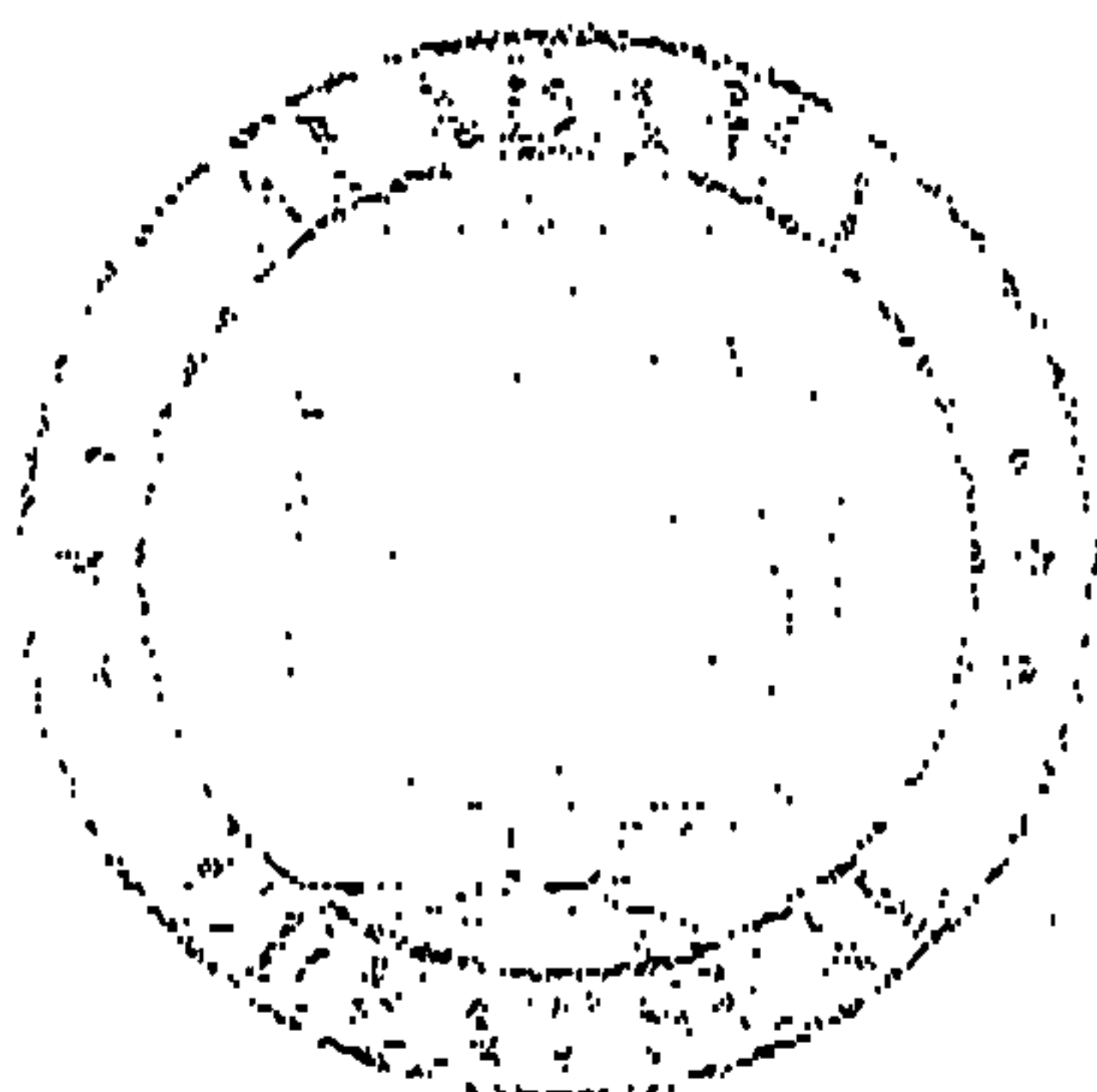
