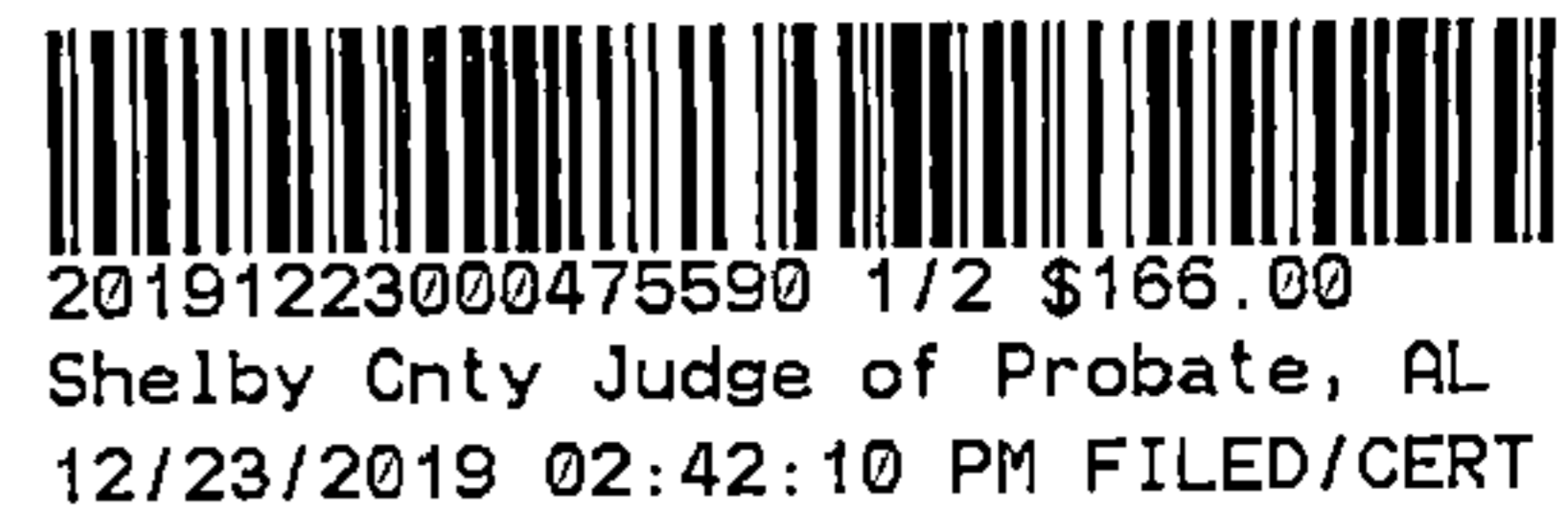

Instructions:

1. Contact the Office of the Secretary of State 334-242-5324 to reserve a corporate name.
2. To incorporate, file the original Articles of Organization and the Certificate of Name Reservation in the county where the Corporation's registered is located. The Secretary of State's filing fee is \$100. The Judge of Probate's filing fee is \$66.

Article II Duration of LLC is "perpetual" unless otherwise stated.

Article III The LLC has been organized for the following purpose:

The purpose for which this company is established is to engage in the transaction of any and all lawful business for which an organization may be established under the laws of the State of Alabama.
