WARRANTY DEED
Joint Tenancy With Right of Survivorship

KNOW ALL MEN BY THESE PRESENTS, that in consideration of **Two Hundred Eighty Six Thousand Six Hundred Dollars and No Cents (\$286,600.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Dale T. Bolena and Phyllis L. Bolena** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto **William Patrick Wright, Jaime Allison Wright, and William M. Wright** (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 33, according to the Survey of Woodvale, as recorded in Map Book 12, Pages 21 and 22, in the Probate Office of Shelby County, Alabama.

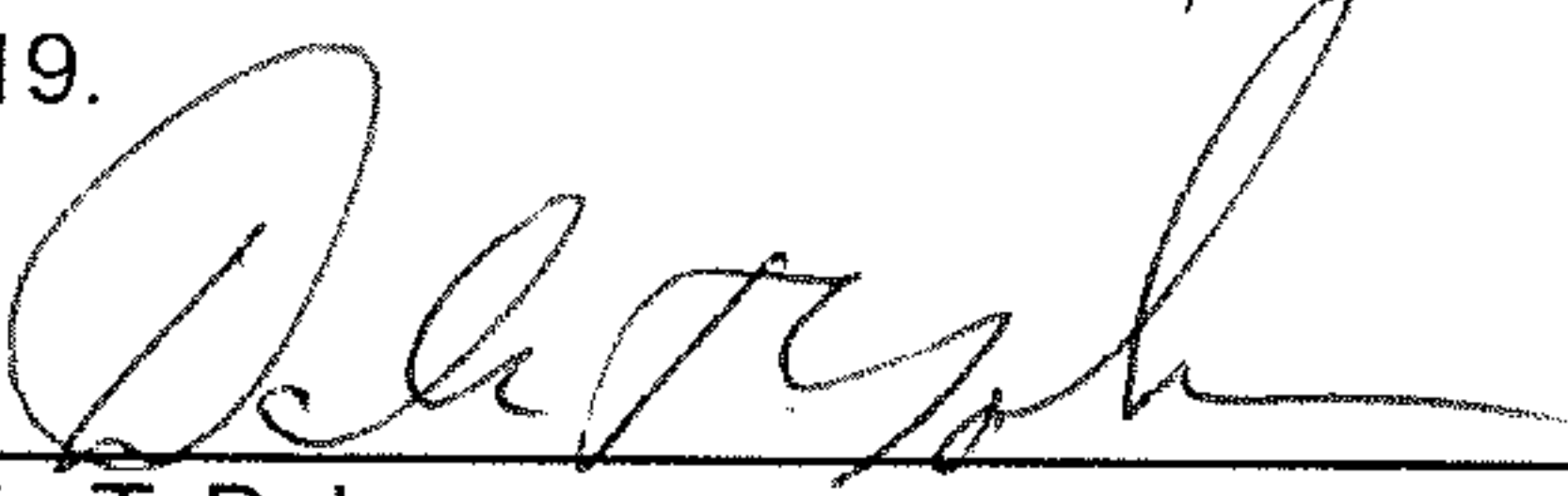

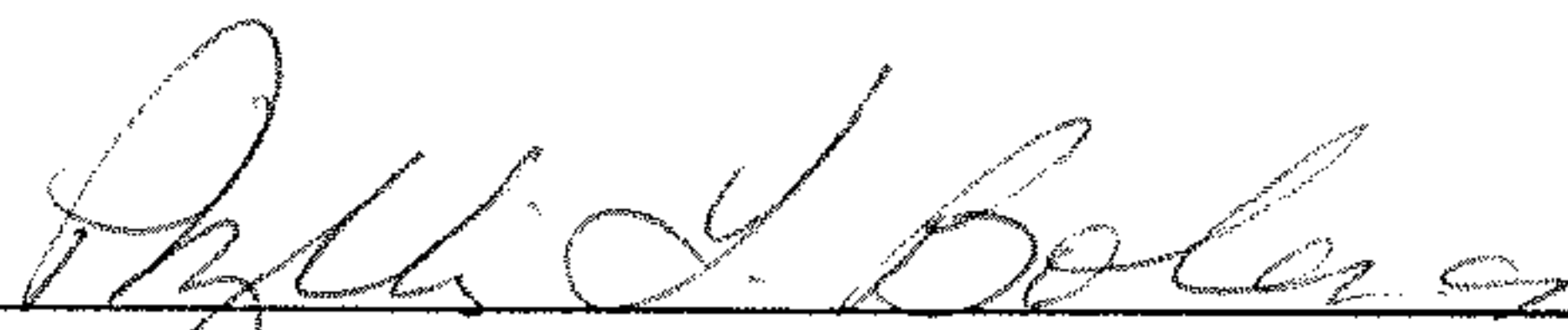
Note: \$254,833.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEES, their heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEES, their heirs, executors and assigns forever, against the lawful claims of all persons.

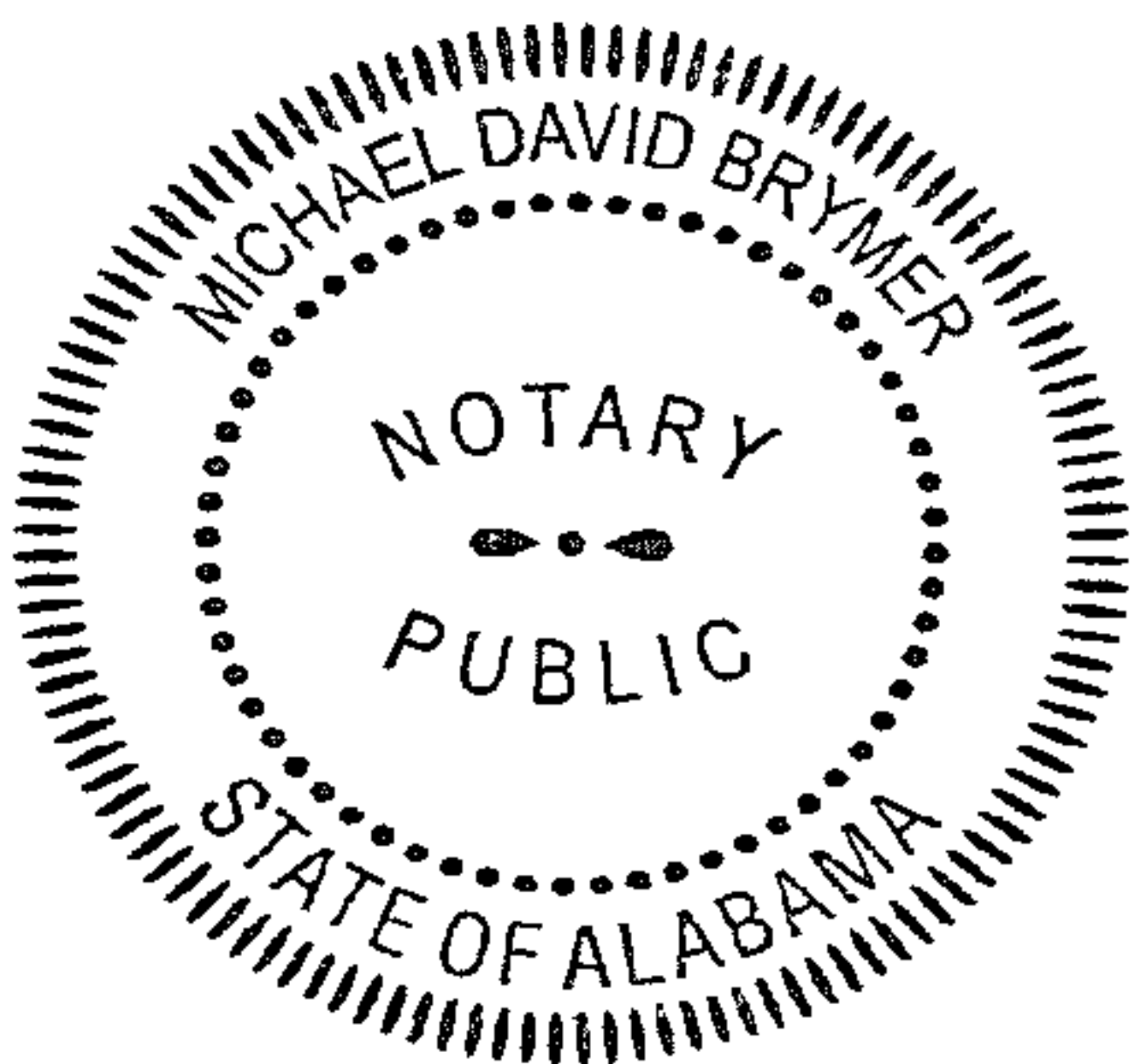

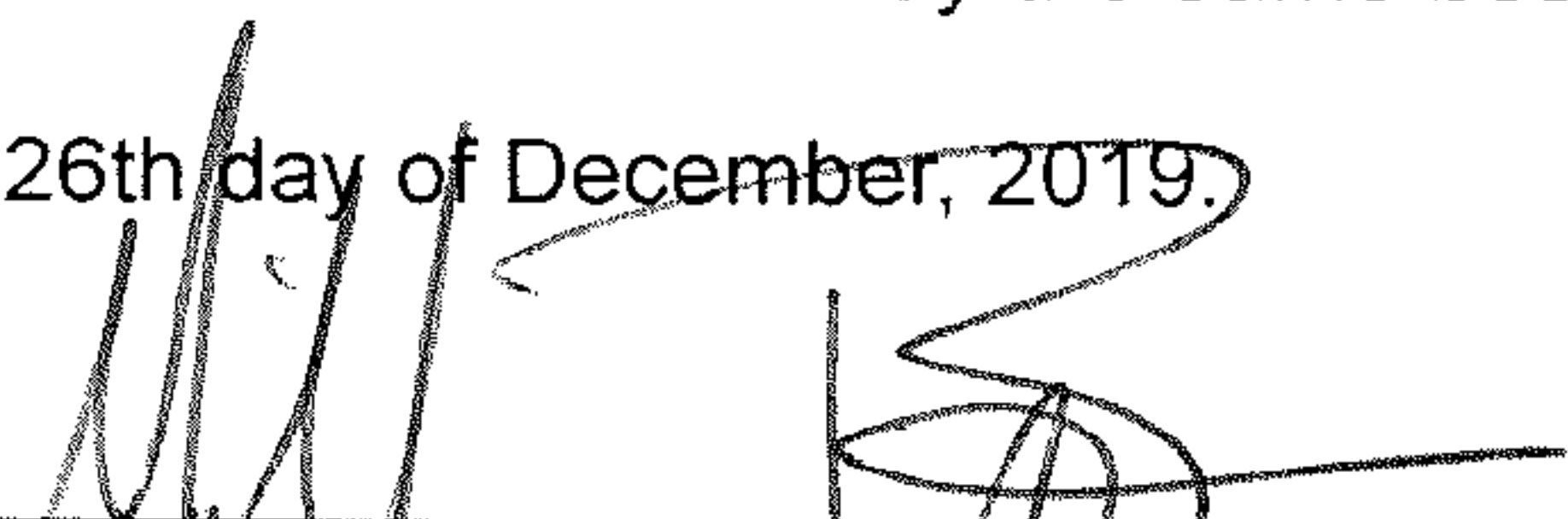

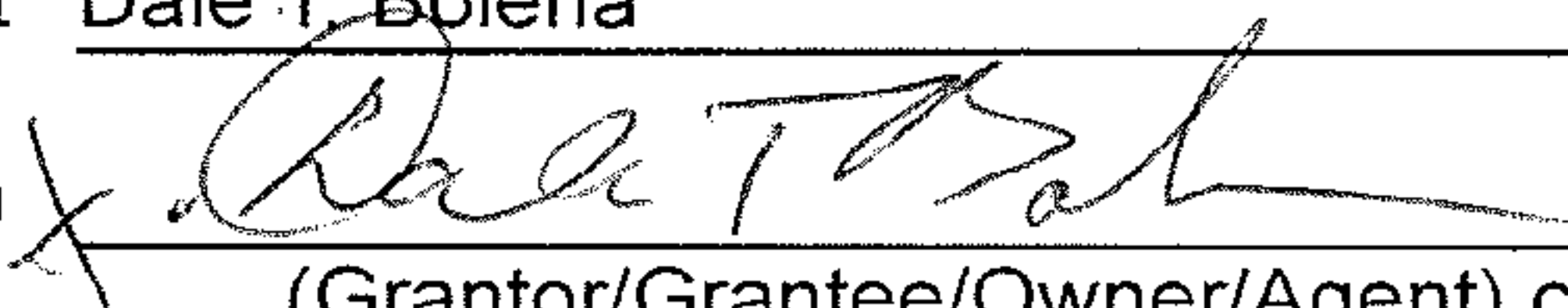
