WITNESSETH: That for and in consideration of the sum of Ten and No/100 Dollars (\$10.00), and other good and valuable consideration, in hand paid by said Grantee unto said Grantor, the receipt of which sum of money is hereby acknowledged, the said Grantor has bargained and sold, and by these presents does hereby grant, bargain, sell and convey unto the said Grantee, the following described real estate situated in Shelby County, Alabama, to-wit:

COMMENCE AT THE SE CORNER OF THE NW 1/4 OF THE SW 1/4 OF SECTION 29, TOWNSHIP 21 SOUTH, RANGE 2 WEST, SHELBY COUNTY, ALABAMA; THENCE N00°33'00"W ALONG THE 1/4 – 1/4 LINE, A DISTANCE OF 259.41' TO THE POINT OF BEGINNING; THENCE CONTINUE ALONG THE LAST DESCRIBED COURSE, A DISTANCE OF 140.00'; THENCE S09°27'0"W, A DISTANCE OF 295.47' TO A POINT, SAID POINT LYNG ON THE EASTERLY R.O.W. LINE OF INTERSTATE HIGHWAY #65, SAID POINT ALSO BEING THE BEGINNING ON A NON TANGENT CURVE TO THE RIGHT, HAVING A RADIUS OF 379.18', A CENTRAL ANGLE OF 05°42'43"; AND SUBTENDED BY A CHORD WHICH BEARS S34°38'01"W, AND A CHORD DISTANCE OF 37.38"; THENCE ALONG THE ARC OF SAID CURVE AND SAID R.O.W.
