WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Three Hundred Sixty-Seven Thousand Five Hundred and 00/100 Dollars (\$367,500.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Vernon Hydorn and his wife Dorothy Hydorn

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Robert McLester Ramsay, Jr. and Elizabeth Noojin Ramsay

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 383, according to the Survey of Caldwell Crossings, Third Sector, as recorded in Map Book 33, Page 154, in the Probate Office of Shelby County, Alabama

\$207,500.00 of the proceeds come from a mortgage recorded simultaneously herewith.

 - (3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

And we do for ourselves and for our heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

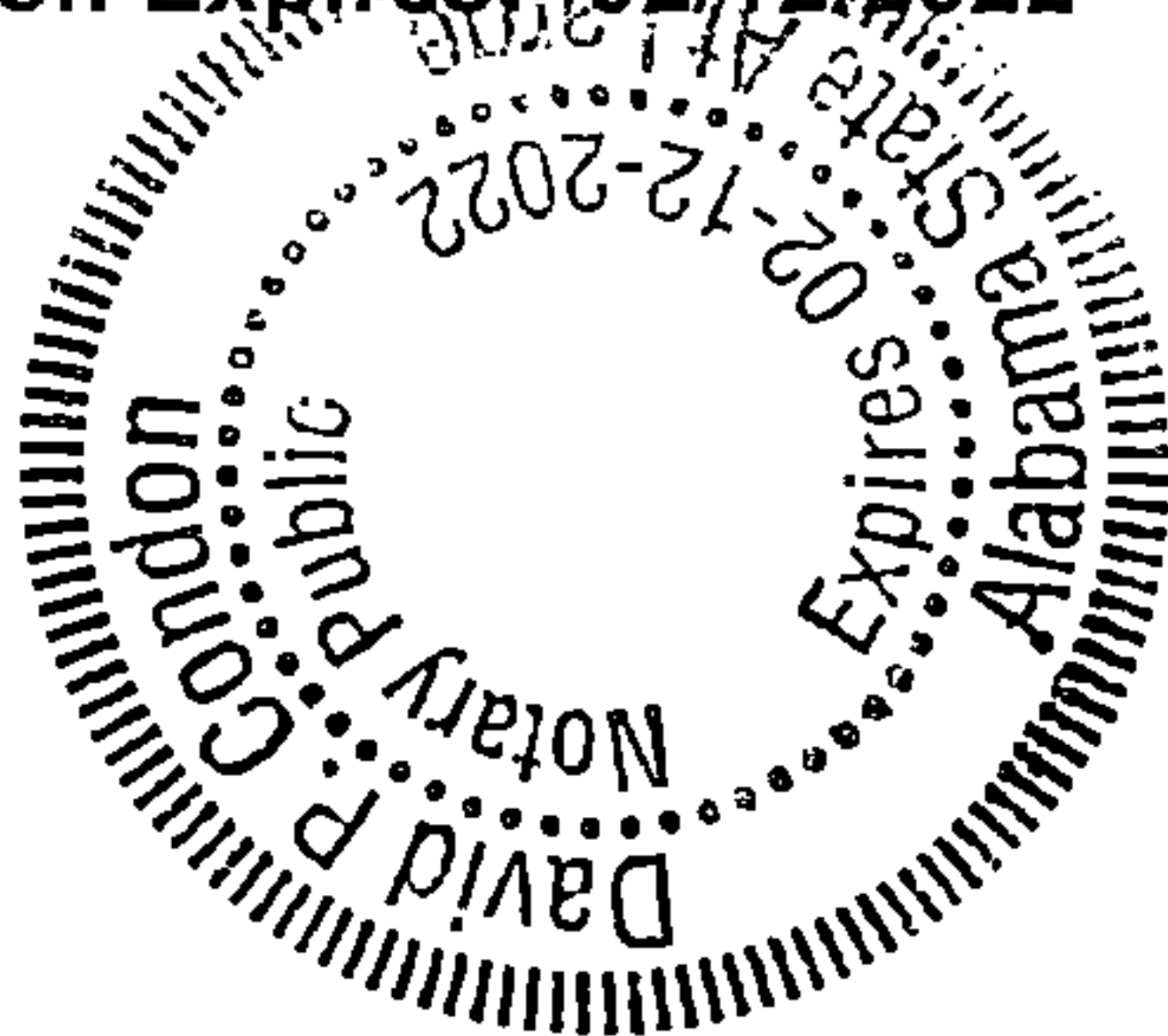
