This property does not constitute the homestead of the grantor as defined in §6-10-3, Code of Alabama (1975).

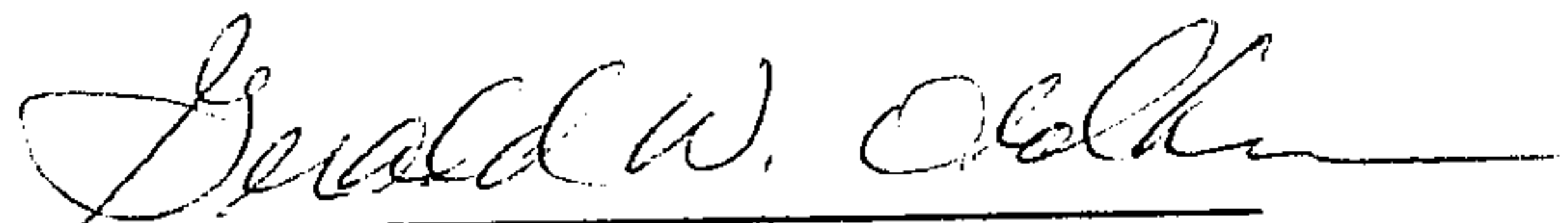
FONDA L. THOMAS is one and the same person as FONDA L. HIGGINS.

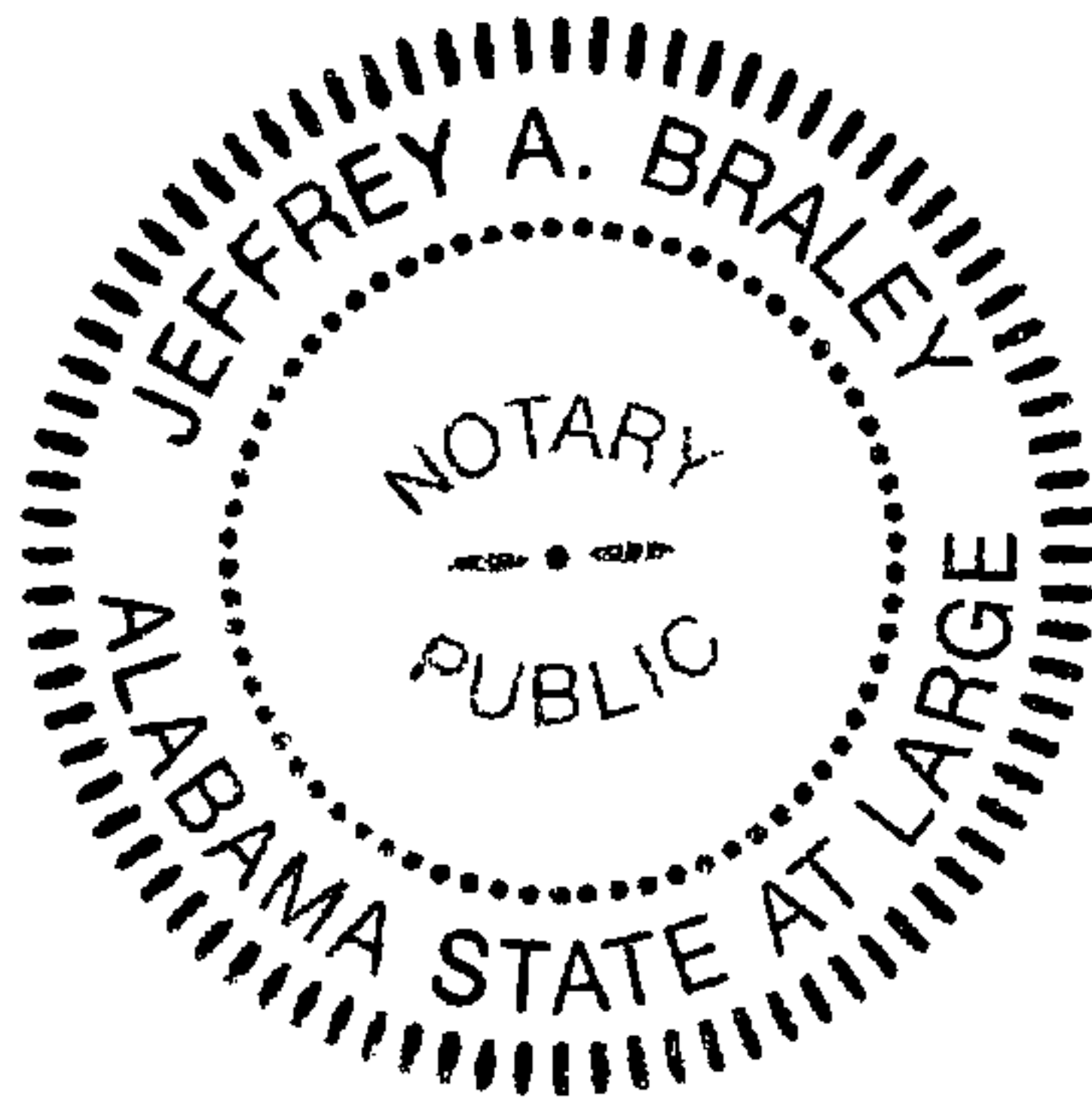
