(herein referred to as GRANTORS, whether one or more) do grant, bargain, sell and convey unto

**David M Lejeune and Ashlee B Logan Lejeune**

(herein referred to as GRANTEES, whether one or more), the following described real estate situated in **SHELBY** County, Alabama, to-wit:

**\$5,000.00** of the consideration was paid from a second mortgage loan being subordinate to the first mortgage.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of purchase money mortgages being executed simultaneously herewith.

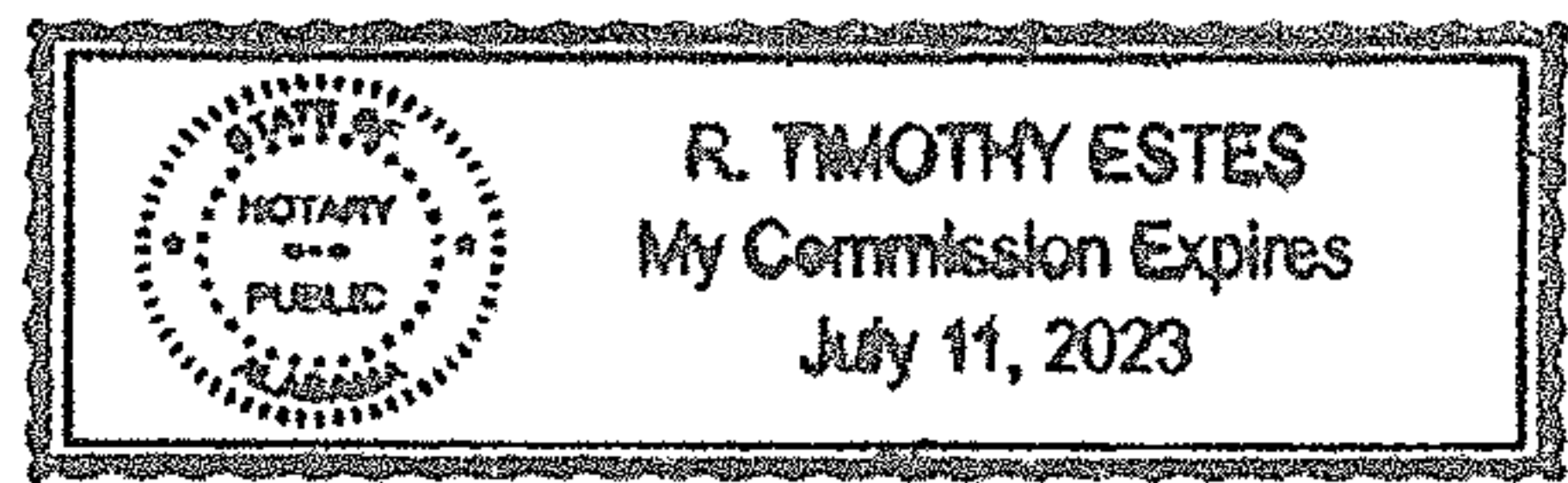


