

# **CERTIFICATE OF FORMATION**

## **Crystal Clear Consultants, LLC.**

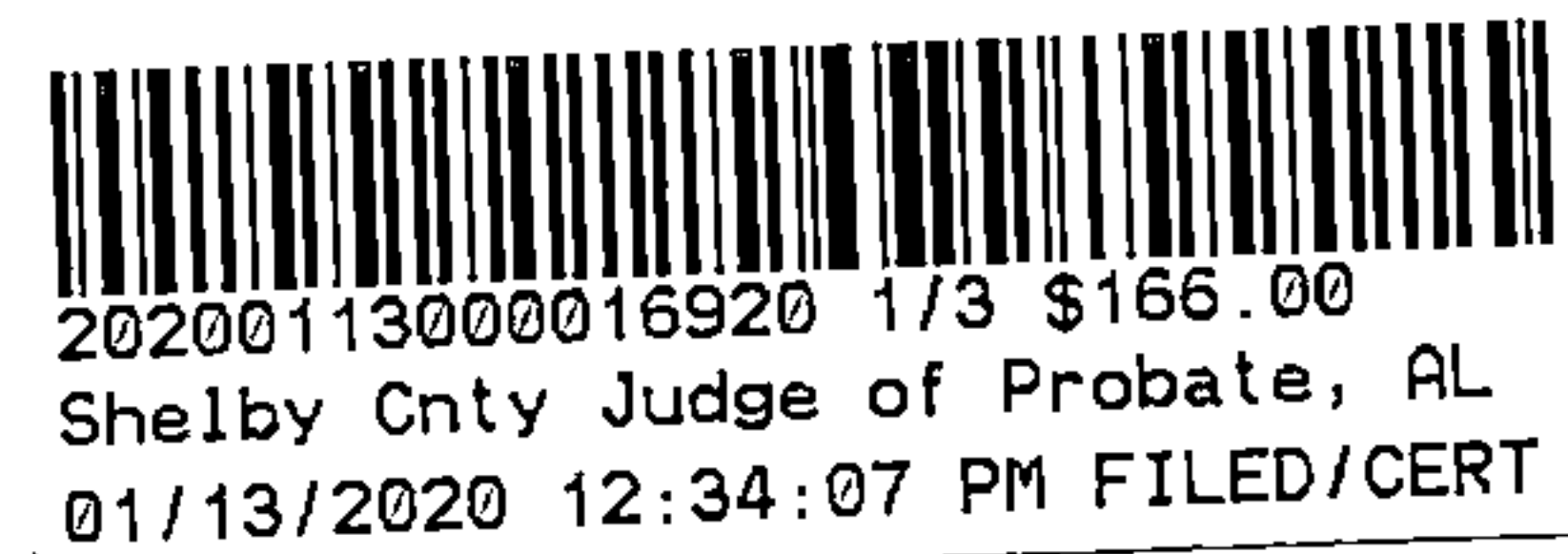

### **ARTICLE I**


