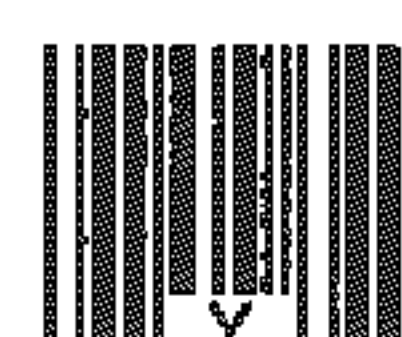
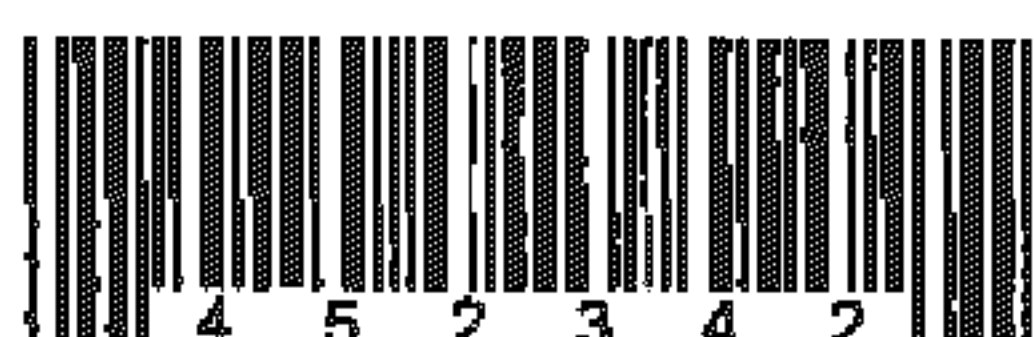
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of April, 2013, Brian S. Poston and wife, Kimberly Poston, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Amerigroup Mortgage Corporation a Division of Mortgage Investors Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20130503000181830, said mortgage having subsequently been transferred and assigned to Freedom Mortgage Corporation, by instrument recorded in Instrument Number 20190625000225380, in the aforesaid Probate Office ("Transferee"); and

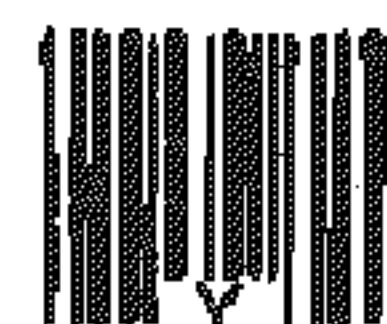

WHEREAS, Alavest LLC was the highest bidder and best bidder in the amount of Eighty-Seven Thousand One Hundred Forty-Seven And 00/100 Dollars (\$87,147.00) on the indebtedness secured by said mortgage, the said Freedom Mortgage Corporation, by and through Sirote & Permutt, P.C., as attorney for said Transferee, does hereby remise, release, quit claim and convey unto Alavest LLC all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama,

The property is being conveyed herein on an "as is, where is" basis subject to any easements, encumbrances, and exceptions reflected in the mortgage and those contained in the records of the Office of the Judge of Probate of the county where the above described property is situated; and furthermore, this property is being conveyed without warranty or recourse, express or implied, as to title, use and/or enjoyment and will be subject to the right of redemption of all parties entitled thereto; and by accepting this deed, Grantee releases any and all claims whatsoever against the law firm representing the Grantor hereunder and the auctioneer conducting said foreclosure sale; and furthermore, this conveyance is subject to being declared null and void in the event that the owner or a party claiming through the owner has filed a bankruptcy prior to the date of this foreclosure sale.

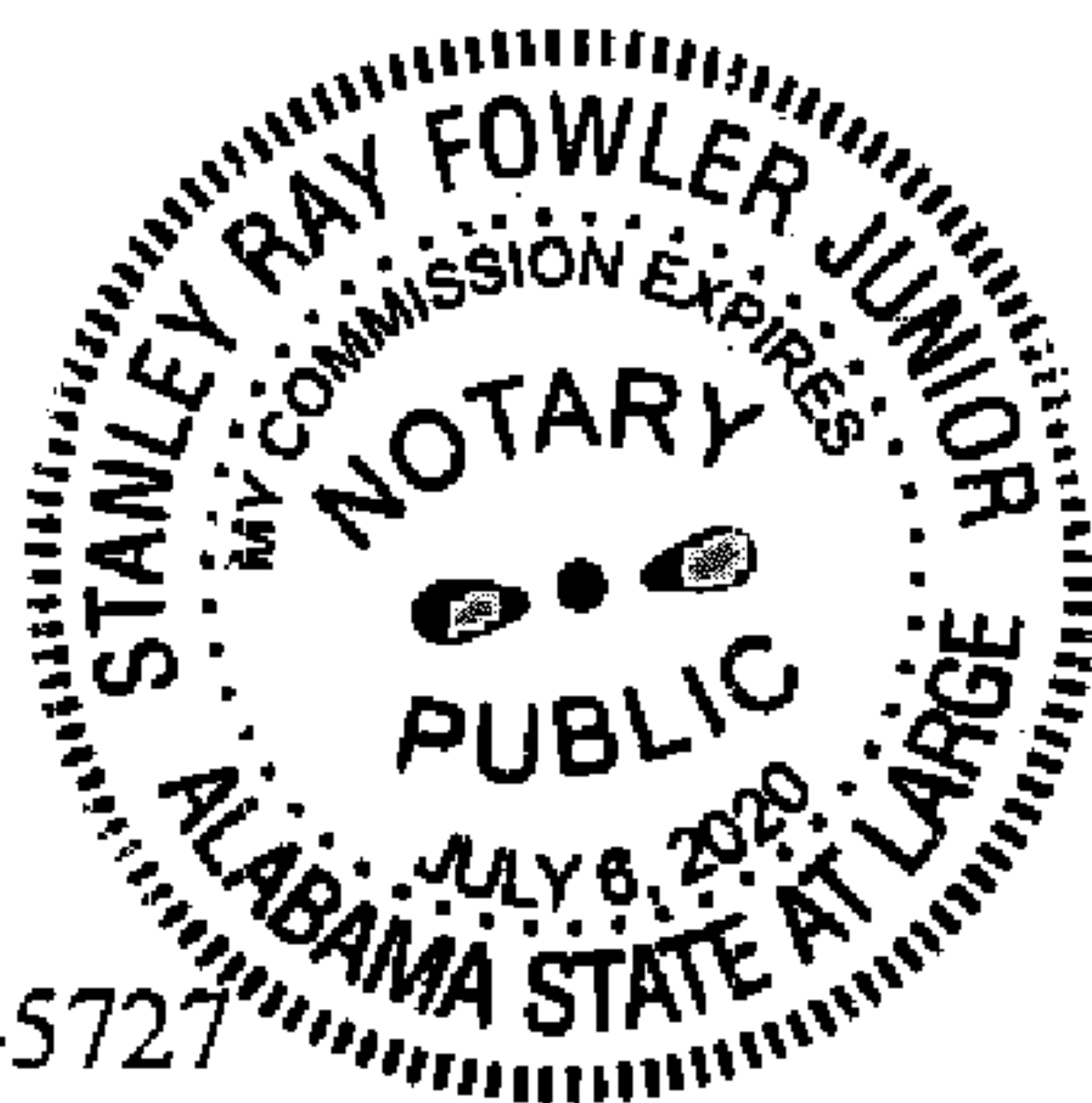
