STATEMENT OF LIEN

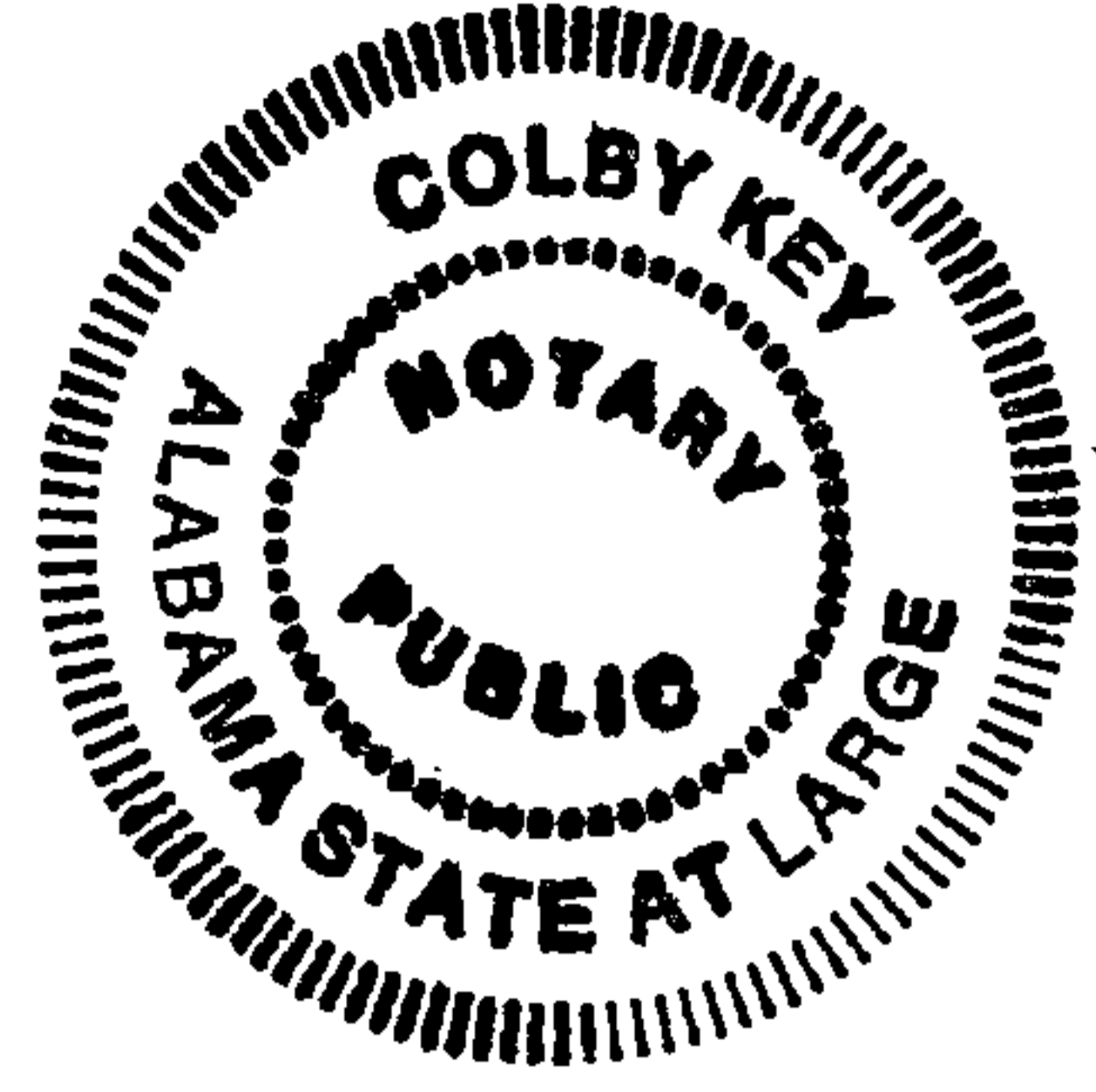
