The name of the owner of the said property is Sabrina Lewis and Michael A. Lewis.

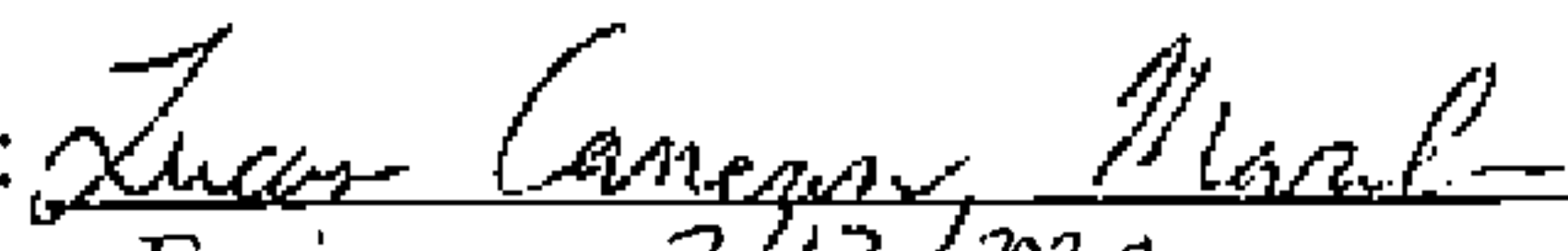
