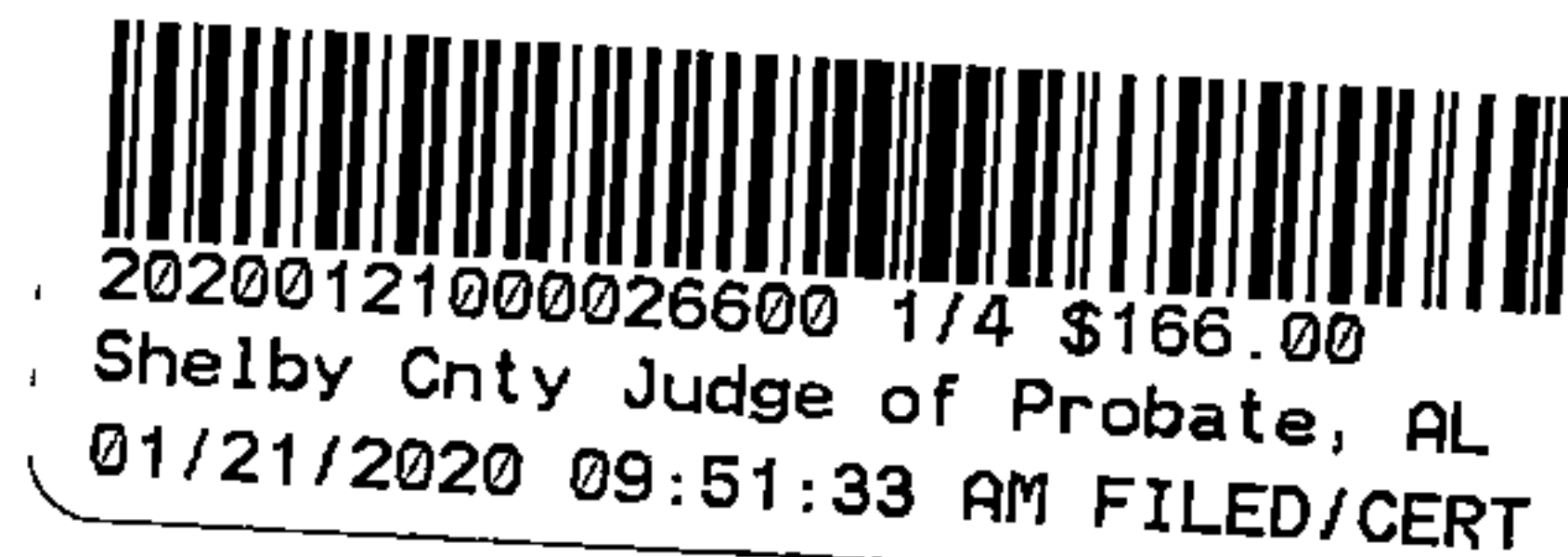




ARTICLES OF ORGANIZATION

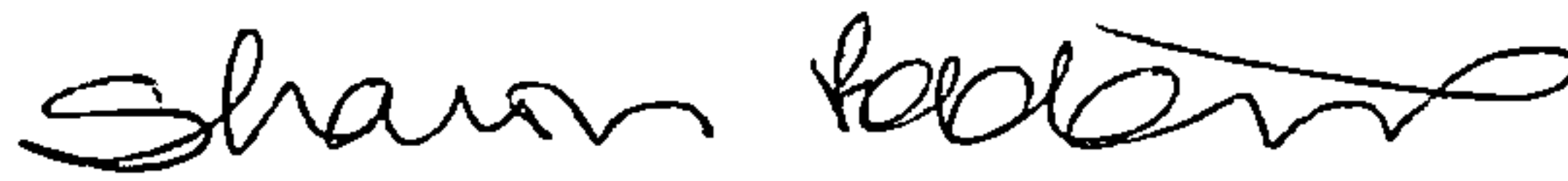
ARTICLE VIII
