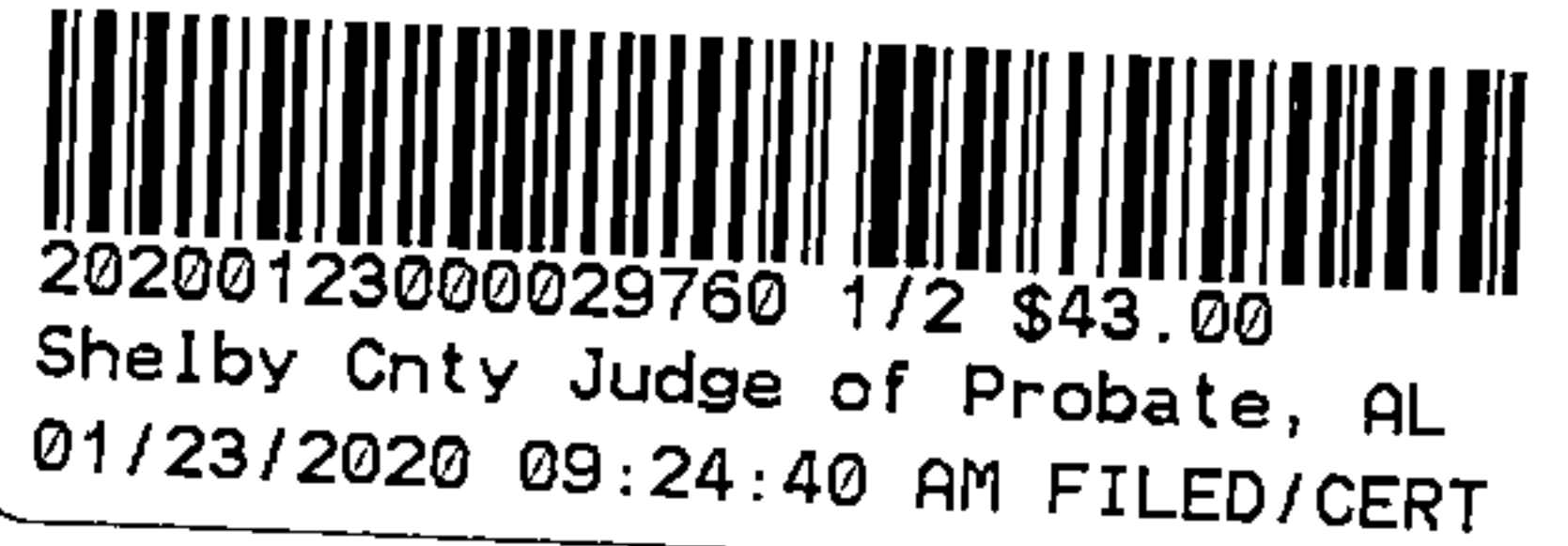

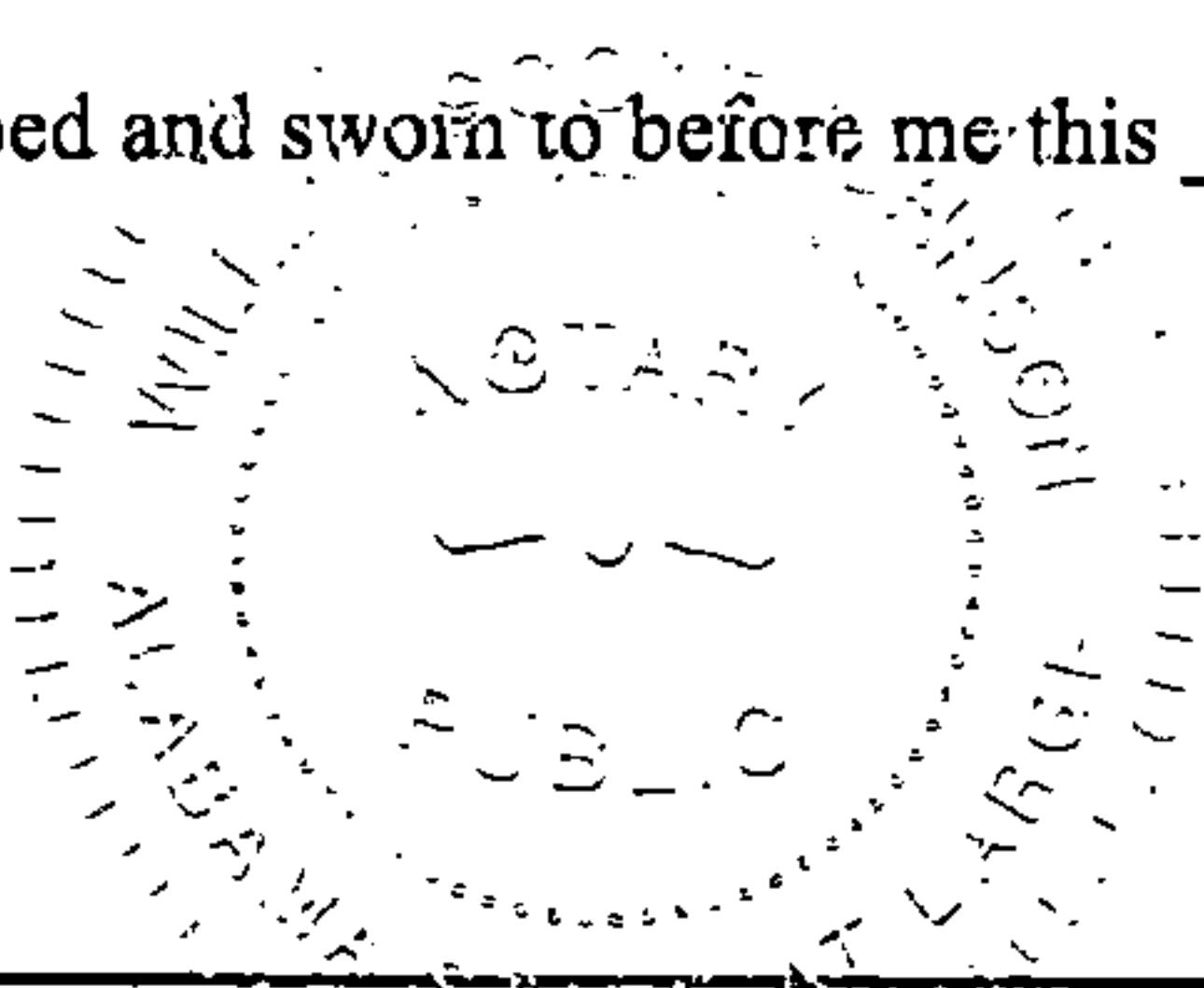
## OATH OF OFFICE

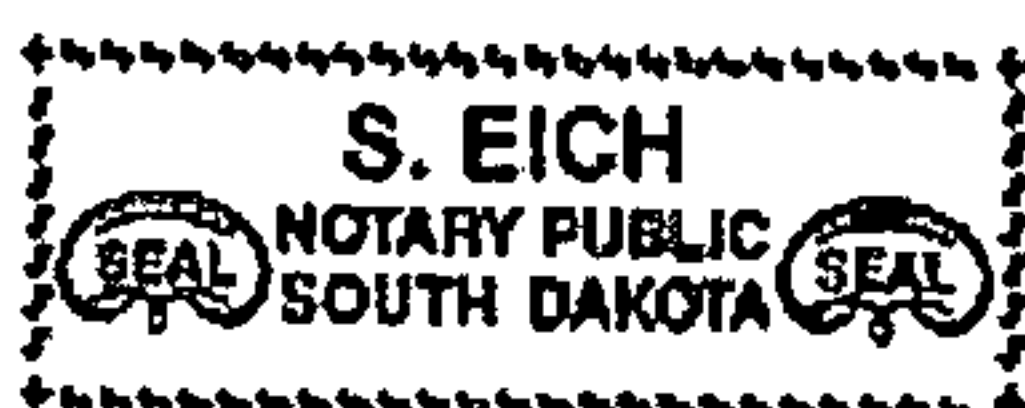
