



Know all men by these presents, that in consideration of the sum of Forty Thousand Dollars and 00/100 (\$ 40,000.00), the receipt of sufficiency of which are hereby acknowledged, that **Justin Glass and Amanda Glass, a married couple**, hereinafter known as GRANTOR, does hereby bargain, grant, sell and convey the following described real property being situated in Shelby County, Alabama, to **Curtis Lee Cofer, Jr., and Anita Gay Cofer, a married couple**, hereinafter known as the GRANTEE;

*Lot No. 443, according to N. B. Dare's Map of the Town of Calera, Shelby County, Alabama.*

Subject to any and all easements, rights of way, covenants and restrictions of record.

This deed was prepared with the benefit of a title search performed by Shelby County Abstract & Title Company, Inc., under policy # MV-2019-25857, and a survey was not performed. The legal description was taken from that certain instrument recorded as Instrument # 20150424000134150, in the Probate Judge's Office of Shelby County, Alabama.

A purchase money mortgage was recorded simultaneously herewith in the amount of \$34,000.00.

TO HAVE AND TO HOLD to the said GRANTEE as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common, together with every contingent remainder and right of reversion.

And we do for ourselves and for our heirs, executors, and administrators covenant with the said GRANTEES, their heirs, and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all person.
