(herein referred to as **GRANTOR(S)**), do grant, bargain, sell and convey unto

William Taylor Hanks and Katherine Stockton Hanks

(herein referred to as **GRANTEE(S)**), as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:

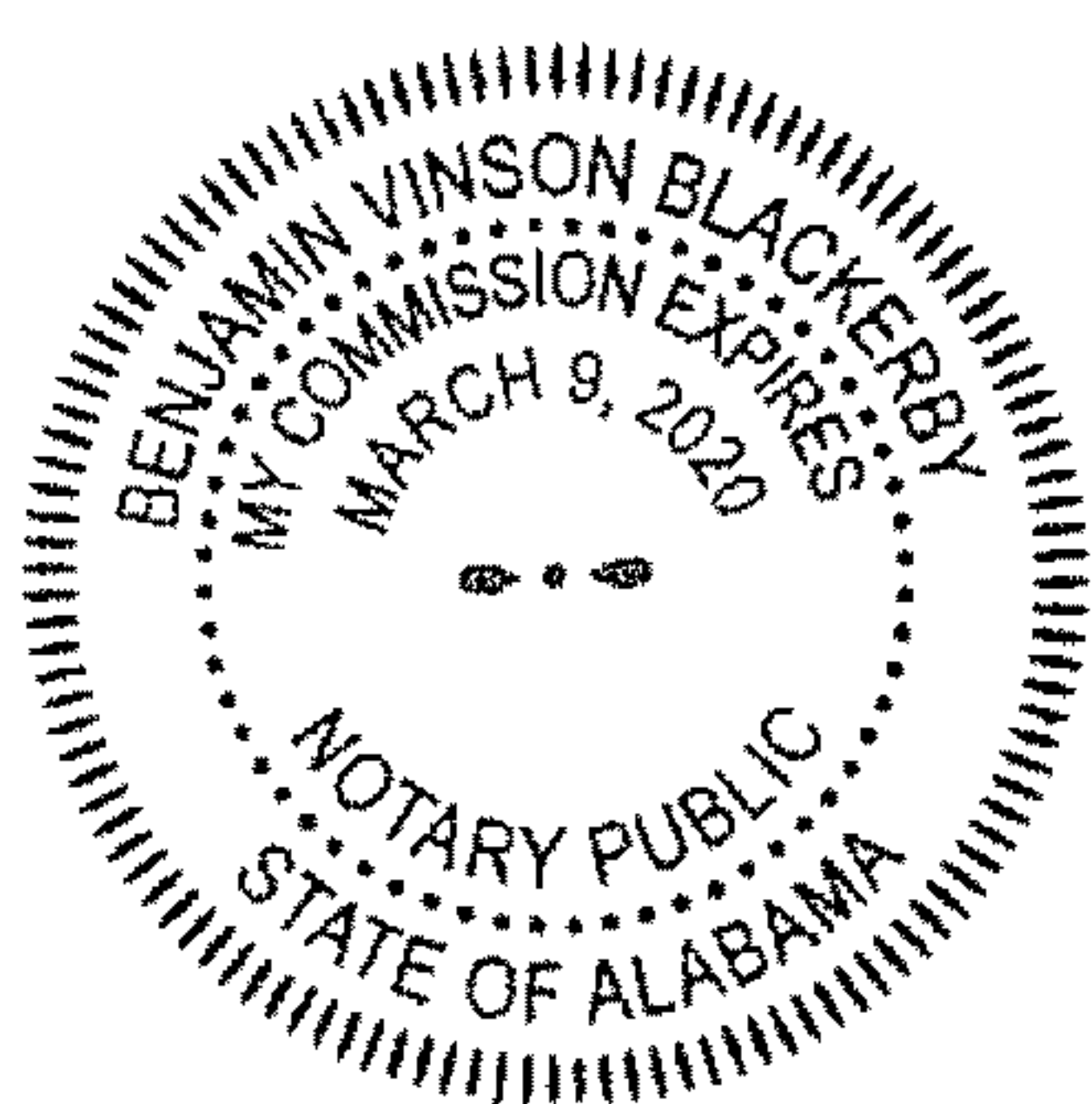
