**ARTICLES OF ORGANIZATION
OF
NICHOLS OUTFITTERS, L.L.C.**

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, **Thomas C Hudson, Jr.**, acting as member of a limited liability company under the laws of Alabama, hereby adopt the following Articles of Organization for Nichols Outfitters, L.L.C. (hereinafter referred to as "the Company"):

ARTICLE I

NAME OF COMPANY

The name of the Company shall be Nichols Outfitters, L.L.C.

ARTICLE II

PERIOD OF DURATION


The period of duration for the company shall be fifty (50) years unless terminated or extended by written Agreement of the members.

ARTICLE III

OBJECTS AND PURPOSES

The objects and purposes for which the Company is organized are:

1. To operate a wholesale and retail sporting goods, hunting, fishing and outfitting company. To buy, sell, market, repair, build, construct, dismantle, de-construct, salvage, refurbish all types sporting goods including, guns, hunting and fishing equipment

and other equipment and other personal properties associated with the sporting, hunting and fishing industries; to buy, sell, lease, rent or manage all types of commercial and residential real properties or salvage materials; to act as a consultant or rental agent for all types of commercial and real properties; to act as a developer, contractor or subcontractor for the development, construction, maintenance, repair, refurbishing of all types of commercial and residential real properties.

2. To transact any and all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act, as such Act may be amended from time to time.


3. To have and to exercise all powers necessary or convenient to effect the above purposes.

The foregoing paragraphs of this Article III, and each phrase thereof, shall be construed, in their broadest sense, as purposes and powers of the Company in addition to those powers specifically conferred upon the Company by law, and it is hereby expressly provided that the foregoing specific enumeration of purposes and powers shall not be held to limit or restrict in any manner the powers of the Company otherwise granted by law. Nothing herein contained, however, shall be construed as authorizing the Company to carry on the business of banking or that of a trust company, or the business of insurance.

ARTICLE IV

REGISTERED OFFICE AND REGISTERED AGENT

The location of the initial registered office of the Company is 1380 McCain Parkway, Pelham, AL 35124. The name of the initial registered agent is **Thomas C Hudson, Jr.**. The mailing address for the Company and the registered agent is 3100 Morgan Road, SE, Bessemer, AL 35022.

ARTICLE VII

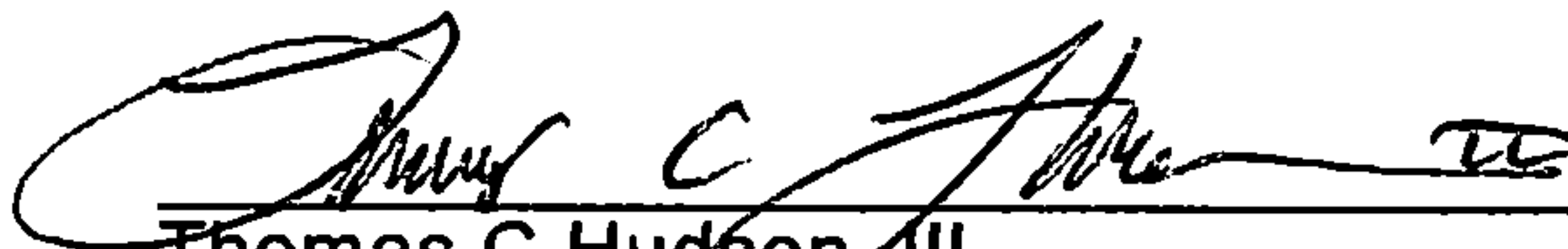
CONTINUATION UPON CERTAIN EVENTS

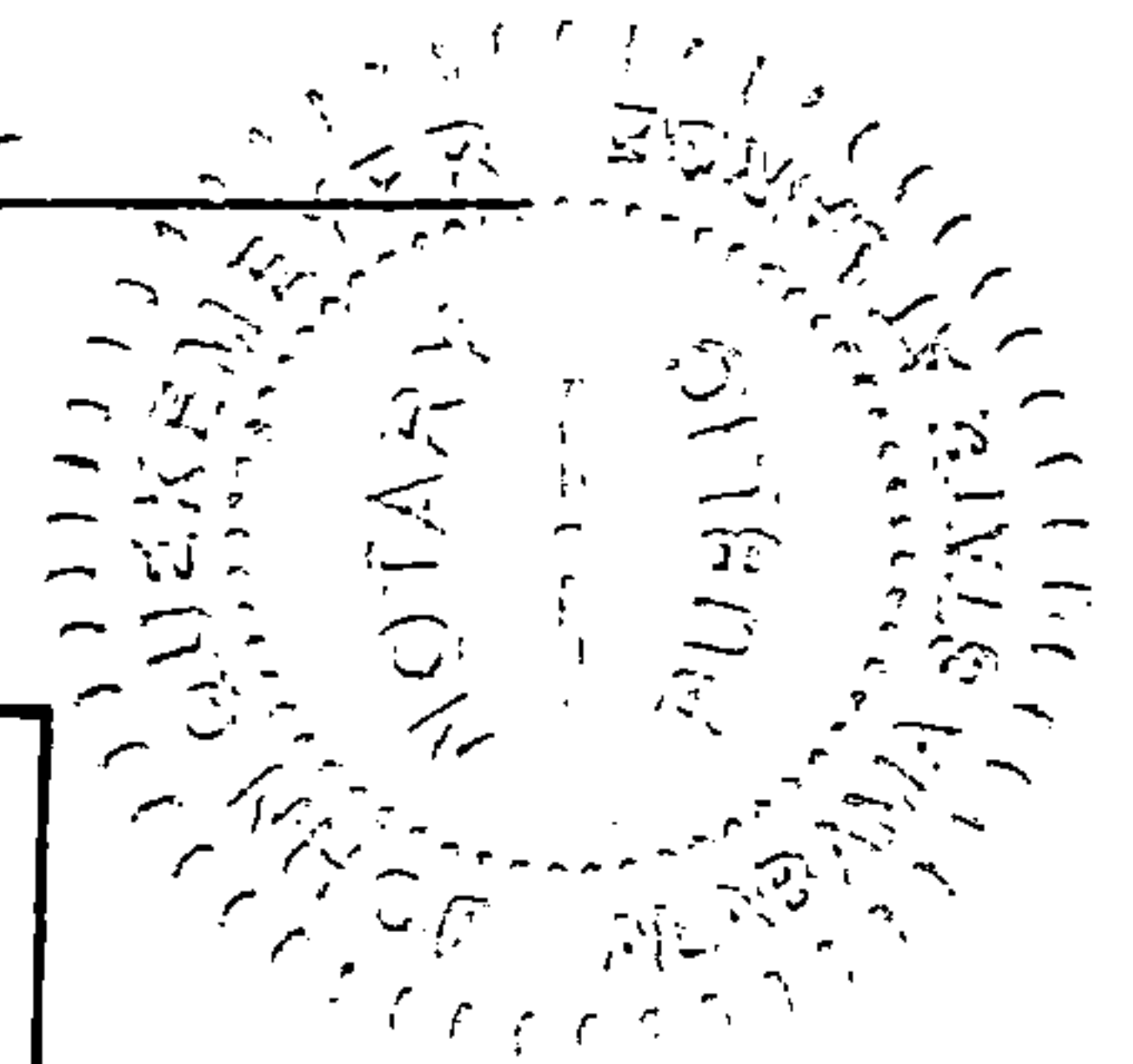
