KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Hundred Fifty Thousand And No/100 Dollars (\$150,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Bonnie R. Marion, an unmarried woman (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Taylor Sinclair Propp and Christina Ann Propp (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 120, according to the Final Plat of Hayesbury, Phase 1, as recorded in Map Book 28, Page 89, in the Office of the Judge of Probate of Shelby County, Alabama.

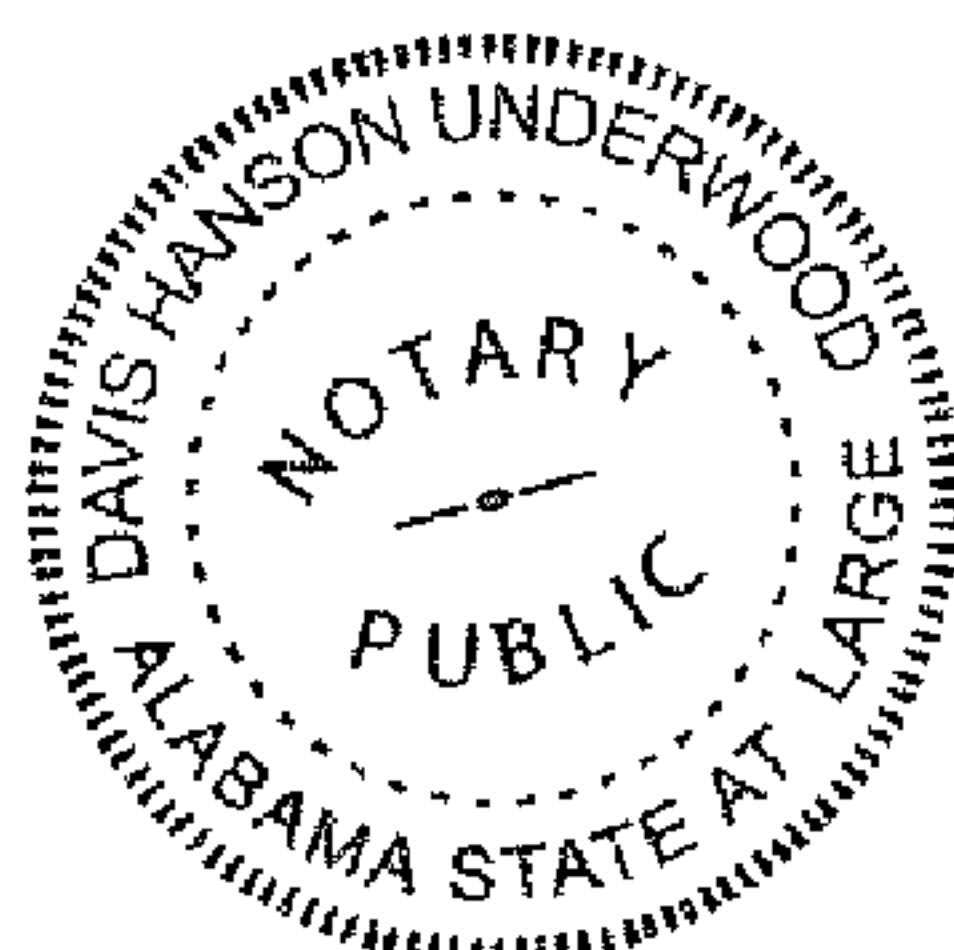
