CERTIFICATE OF FORMATION
OF


ARTICLE VII

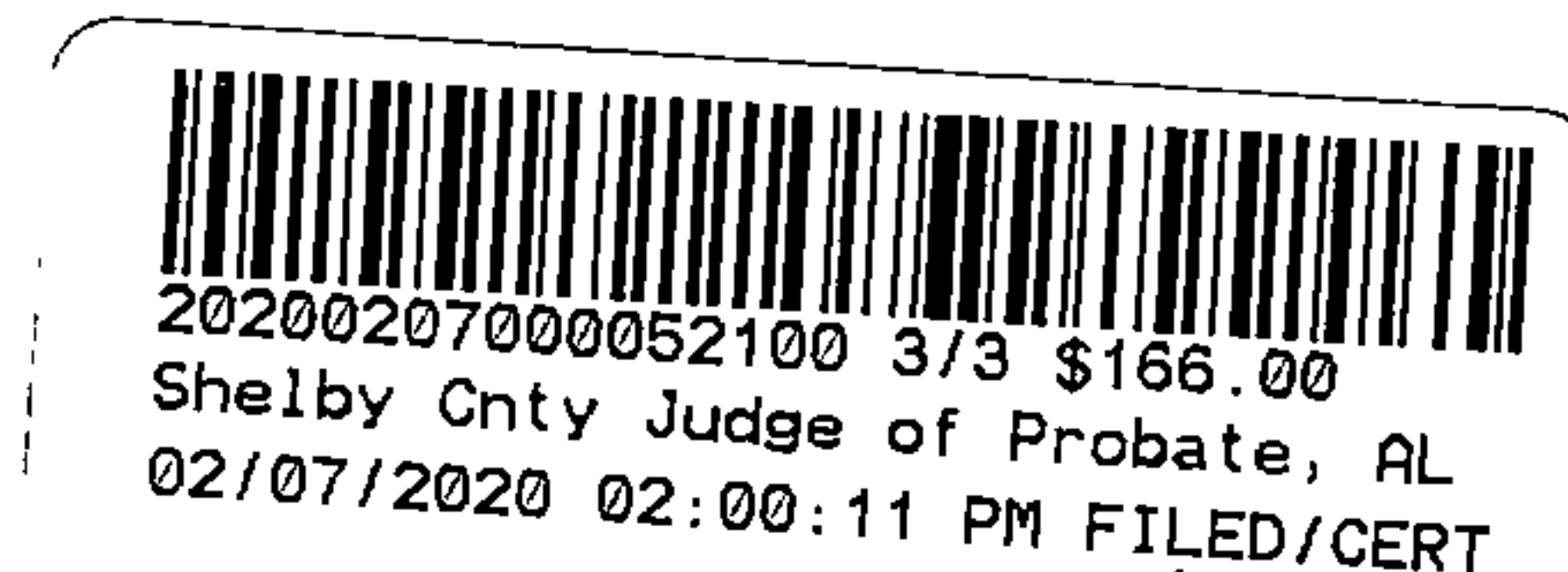
