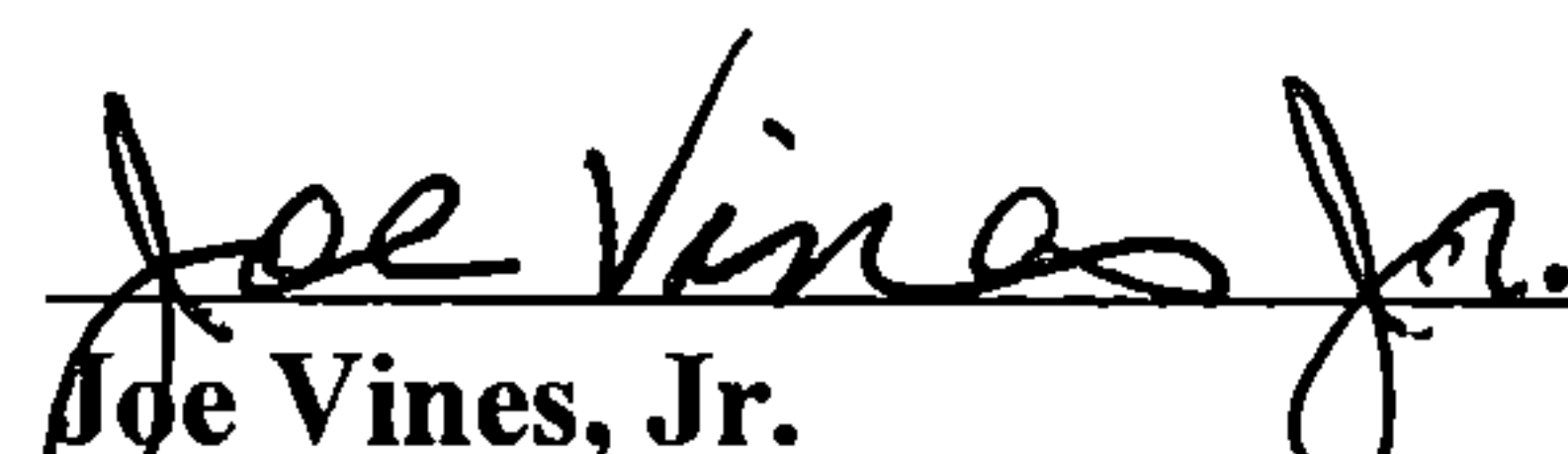
We are the only heirs of *Joe Cephus Vines*, a deceased person, who died intestate on or about 30 September, 1986, without any estate being probated.

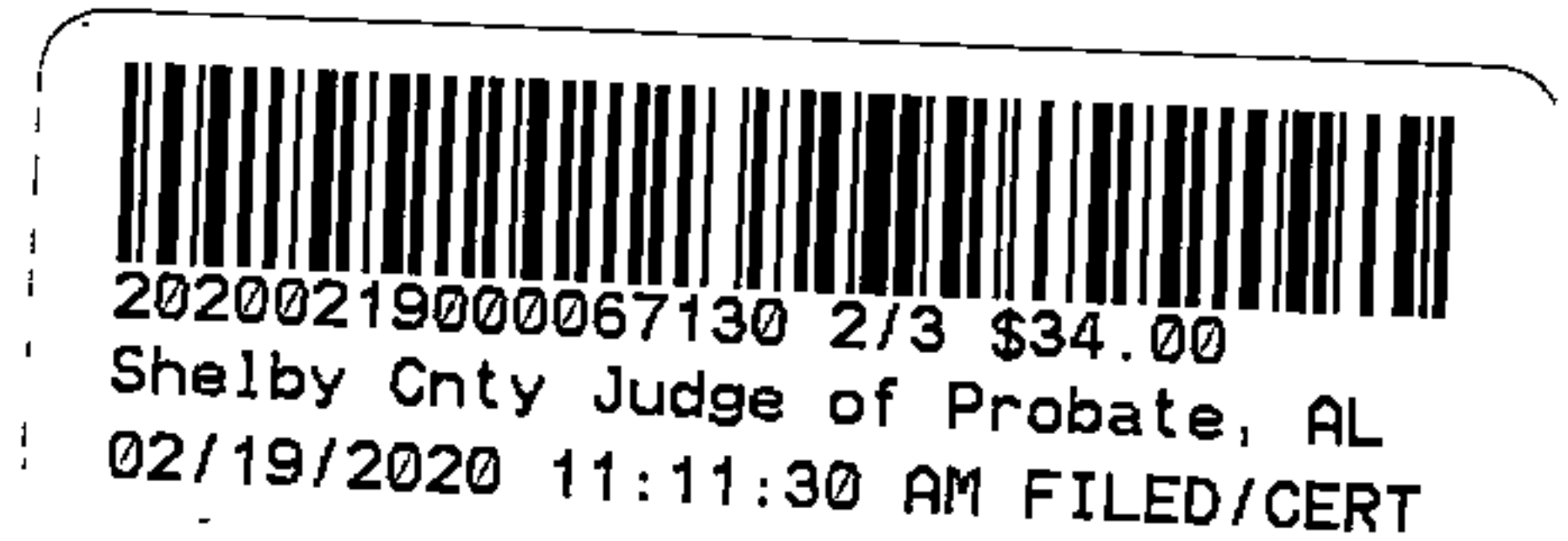

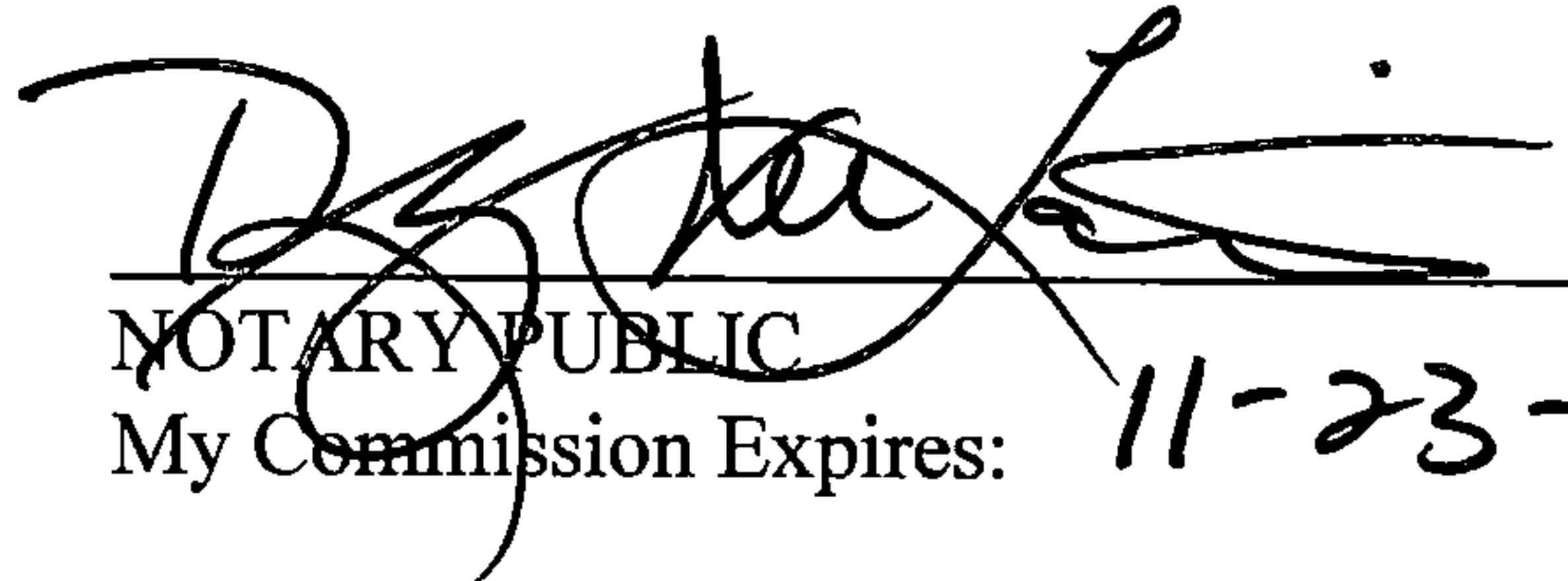
