From the Northwest corner of the Southwest ¼ - Southeast ¼ of Section 11, Township 18 South, Range 1 East, Shelby County, Alabama and proceed South along the West boundary of said quarter-quarter section for 82.00 feet to the point of beginning; thence South 31 degrees 27 minutes 30 seconds East 295.67 feet; thence South 80 degrees 07 minutes 59 seconds West 156.62 feet to a point on the West boundary of the aforementioned quarter - quarter section; thence North along the West Boundary of said quarter-quarter section for 279.05 feet, back to the point of the beginning.
