

**Certificate of Trust

This Certification of Trust is made pursuant to Ala. Code § 19-3B-1013. The currently acting Trustees of the Proverbs 13:22 Trust dated August 20, 2013, declare as follows:

1. The Settlers are Jerry L. Satterwhite and Jean S. Satterwhite. The trust is revocable by the Settlers, acting jointly and not separately.
2. The Trustees of the trust are Jerry L. Satterwhite (whose address is 141 Skyline Circle, Indian Springs, Alabama 35124) and Jean S. Satterwhite (whose address is 141 Skyline Circle, Indian Springs, Alabama 35124). The signature of one Trustee is sufficient to exercise the powers of the Trustee.
3. The tax identification number of the trust is the Social Security number of either Jerry L. Satterwhite or Jean S. Satterwhite.
4. Title to assets held in the trust will be titled as: Jerry L. Satterwhite and Jean S. Satterwhite, Trustees of the Proverbs 13:22 Trust dated August 20, 2013, and any amendments thereto.
5. An alternative description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
6. Excerpts from the trust document that establish the trust, designate the Trustee, and set forth the powers of the Trustee will be provided upon request. The powers of the Trustees include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests.
7. The terms of the trust provide that a third party may rely upon this Certification of Trust as evidence of the existence of the trust and is specifically relieved of any obligation to inquire into the terms of this trust or the authority of my Trustee, or to see to the application that my Trustee makes of funds or other property received by my Trustee.
8. The trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.

The statements made above are accurate and the trust has not been revoked or amended in any way that would cause the representations in this Certification of Trust to be incorrect. All of the currently acting Trustees of the trust are identified above and are signatories to this Certification of Trust.

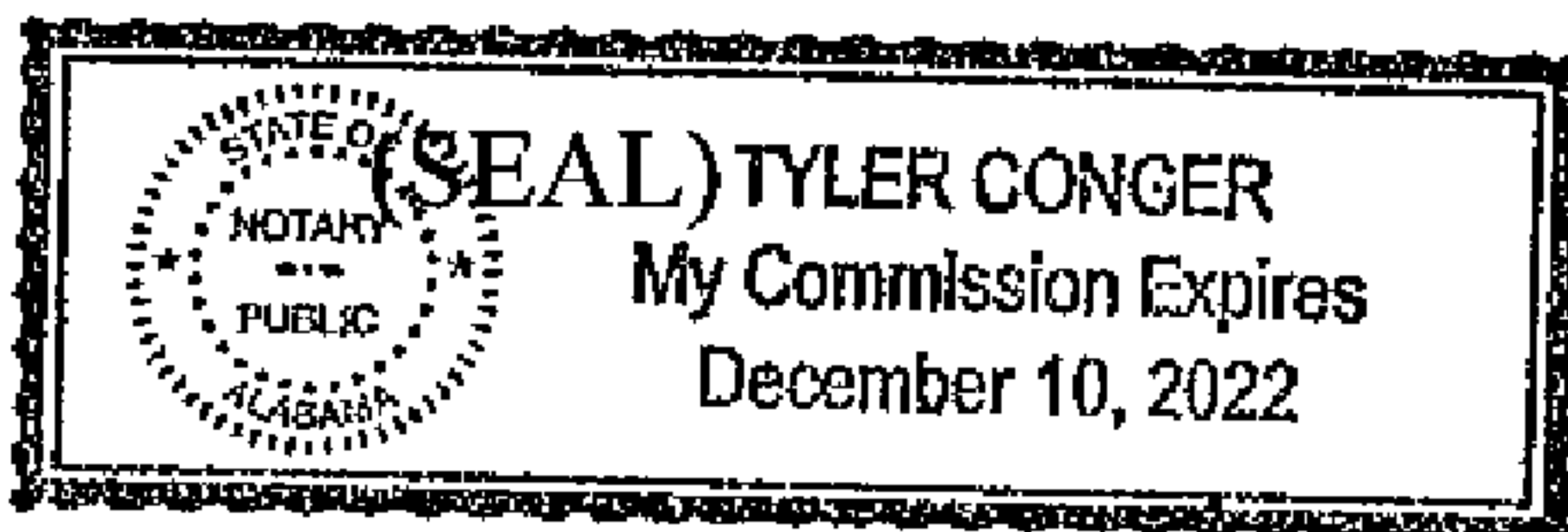

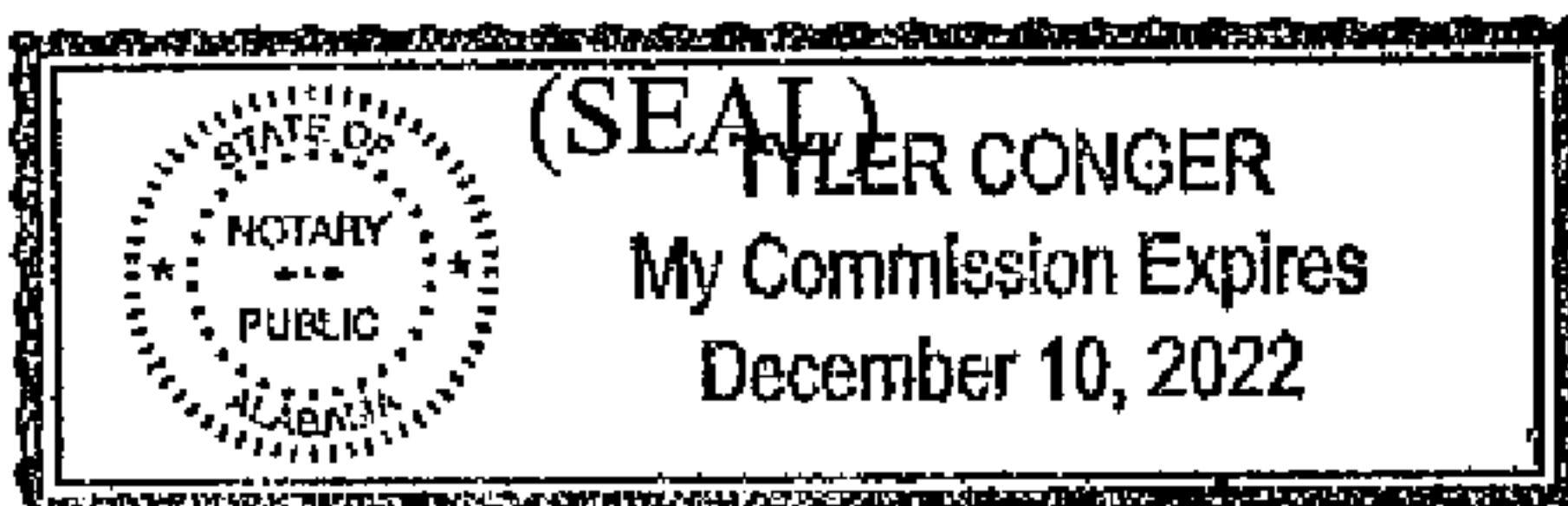
