IOW ALL MEN BY THESE PRESENTS, That the undersigned **Brook Hills Baptist Church, Inc., A/K/A The Church at Brook Hills** (hereinafter known "Grantors", whether one or more) for and in consideration of One and No/100 Dollar (\$1.00) and other good and valuable consideration paid to Grantors in hand Alabama Power Company, a corporation, the receipt and sufficiency of which are hereby acknowledged, do hereby grant to said Alabama Power Company, its coessors and assigns (hereinafter the "Company"), the following easements, rights, and privileges:

ne easements, rights and privileges granted hereby shall apply to, and the word "Property" as used in this instrument shall mean the real property more particularly escribed in that certain instrument recorded in <u>Instrument #1992-14567</u>, in the Office of the Judge of Probate of the above named County.
