

ARTICLES OF LIMITED LIABILITY ORGANIZATION OF

ARTICLE I

Name

ARTICLE VI

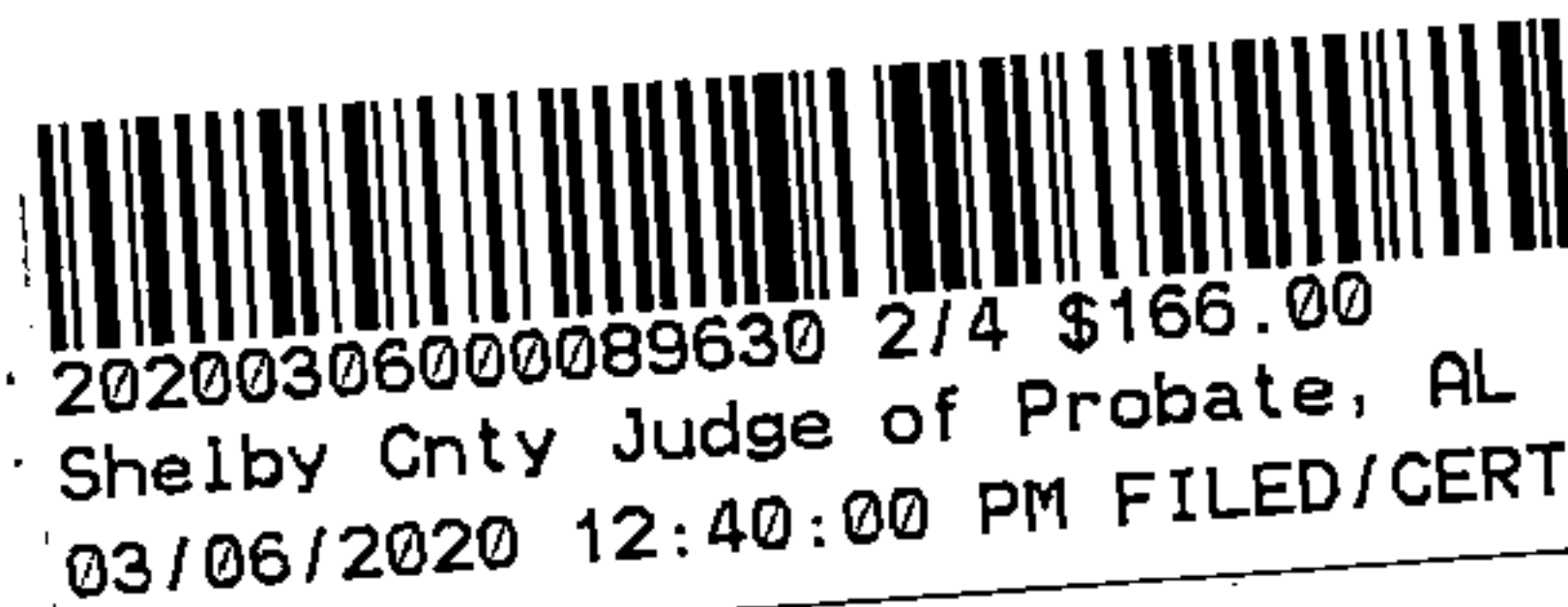
Admission of Additional Members
