KNOW ALL MEN BY THESE PRESENTS,

On this March 13, 2020, That for and in consideration of **ONE HUNDRED EIGHTY THOUSAND AND NO/100 (\$180,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **TERESA CUNNINGHAM, PERSONAL REPRESENTATIVE OF THE ESTATE OF MAREE BLACKWELL, DECEASED (SHELBY COUNTY PROBATE CASE NO. PR-2016-000200)**, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **JODY GLEN FREDRICKSON**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

That certain of tract of land described as commencing at the Northwest corner of the Southwest Quarter of the Southeast Quarter of Section 16, Township 19 South, Range 2 West, and run thence South 1 degree and 45 minutes East a distance of 178.7 feet to the South right of way line of Little Cahaba Valley public road for the point of beginning of the tract herein conveyed; run thence South 1 degree 45 minutes East a distance of 420 feet; run thence North 54 degrees and 15 minutes East for a distance of 456 feet; run thence in a northwesterly direction to a point on the South right of way line of Little Cahaba Valley public road, which said point is North 54 degrees and 15 minutes West 210 feet from the point of beginning of the lot or tract herein conveyed; run thence South 54 degrees and 15 minutes West a distance of 210 feet to the point of beginning. 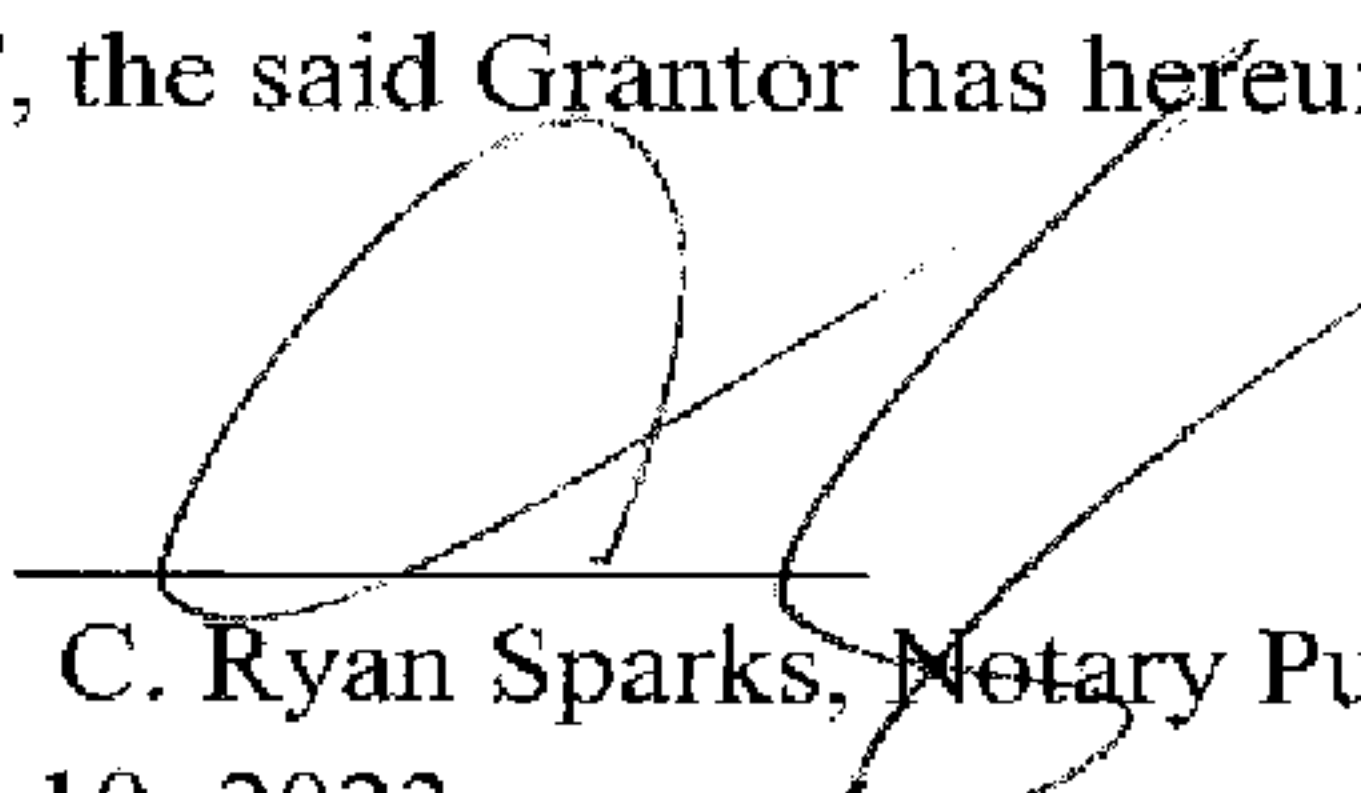

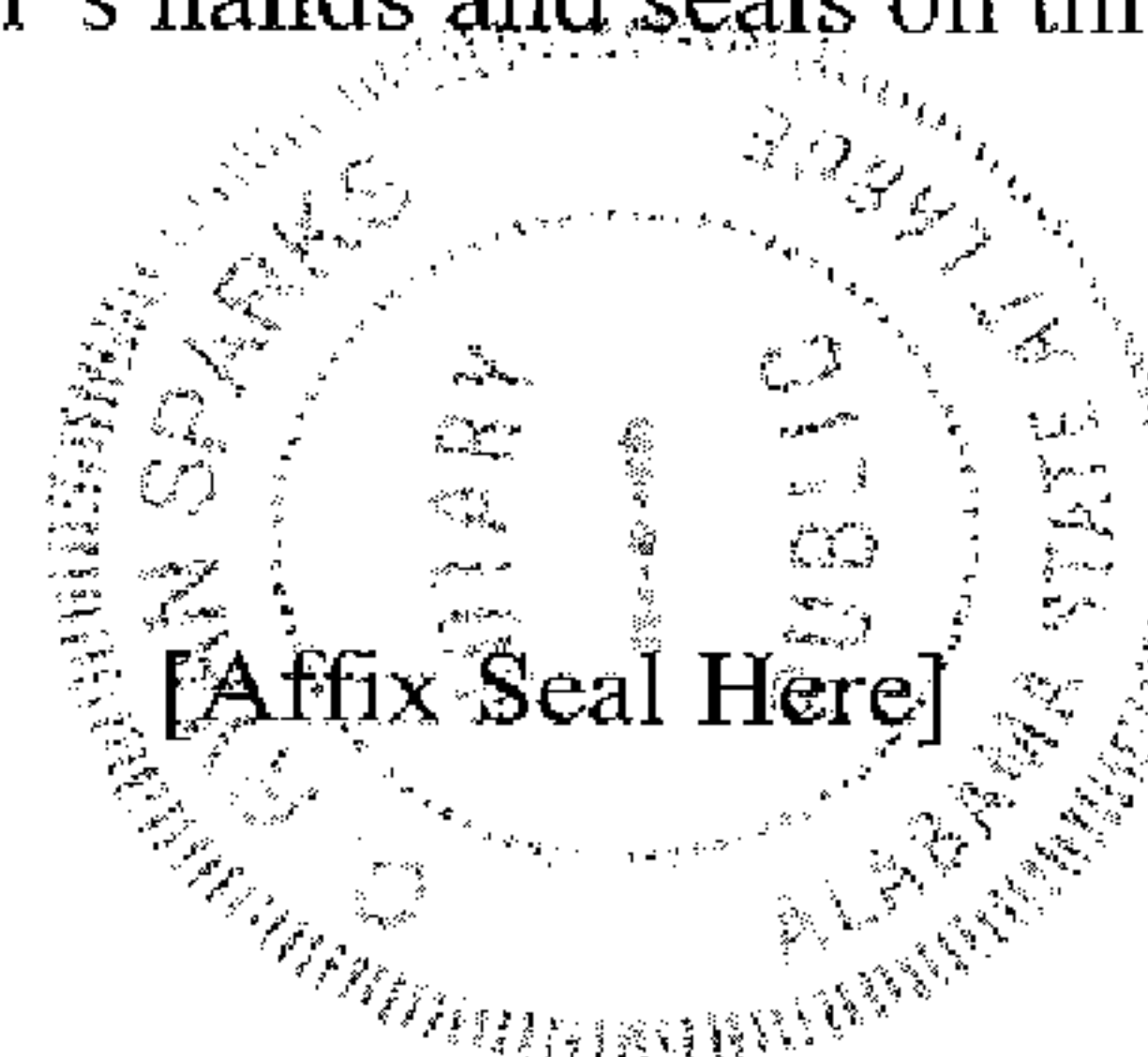
