


**AFFIDAVIT REGARDING CERTIFICATION OF TRUST
FOR THE JEFFERSON R. COBB IRREVOCABLE TRUST**



 - B. The following persons contributed money, funds, real property or personal property to the trust: JEFFERSON R. COBB.

4. The JEFFERSON R. COBB IRREVOCABLE TRUST, has a definite beneficiary. The same person is not the sole trustee and sole beneficiary.
5. Excerpts from the trust agreement that establish the trust, designate the Trustee and set forth powers of the Trustee will be provided upon request. The administrative and/or managerial powers of the trustees are shown on the Powers of Trustee, and include the power to acquire, sell assign, convey, pledge, encumber, lease, borrow, manage and deal with real and personal property interests.

 - A. The following trustee has the authority to sign documents and instruments: ROBERT M. COBB AND DAVID M. WOOLDRIDGE.
 - B. ROBERT M. COBB AND DAVID M. WOOLDRIDGE cannot act alone and may not exercise such powers by his signature.
2. The conditions for the succession of the successor trustees are vacancy.
3. The social security number assigned to the trust is the social security number JEFFERSON R. COBB.
4. Trust property should be titled as follows: JEFFERSON R. COBB IRREVOCABLE TRUST.
5. To the best of the undersigned's knowledge, the trust has not been revoked, modified or amended in any manner that would cause the representations and statements contained herein to be incorrect.

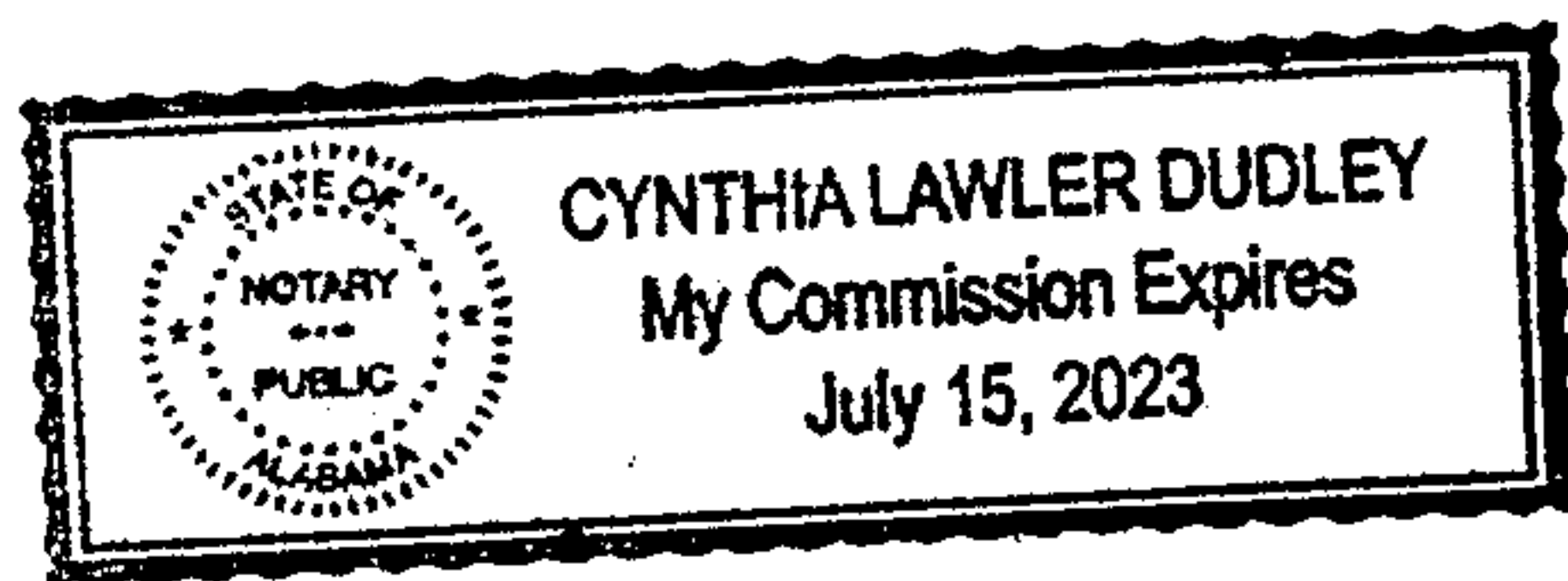
