Know All Men by These Presents: That in consideration of **Two Hundred Fifty-Two Thousand Five Hundred and 00/100 Dollars (\$252,500.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **DAVID L. SMITH and ALLISON L. SMITH, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **SHANNON L. COLEMAN and MICHAEL SCOTT COLEMAN** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 5, Block 4, according to the Survey of Indian Hills, 2nd Sector, as recorded in Map Book 4, Page 91, in the Probate Office of Shelby County, Alabama.

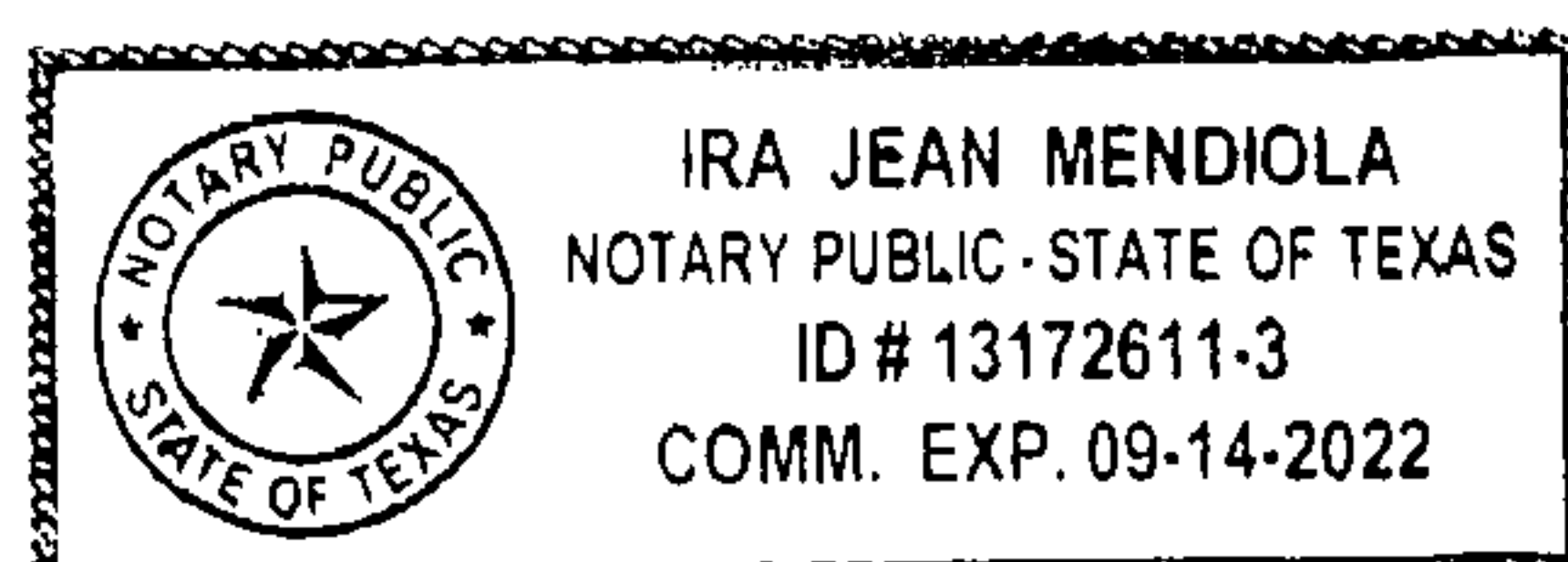


