

Affiant states that his/her relationship to the Decedent was that of Cousin / family (state relationship to decedent).

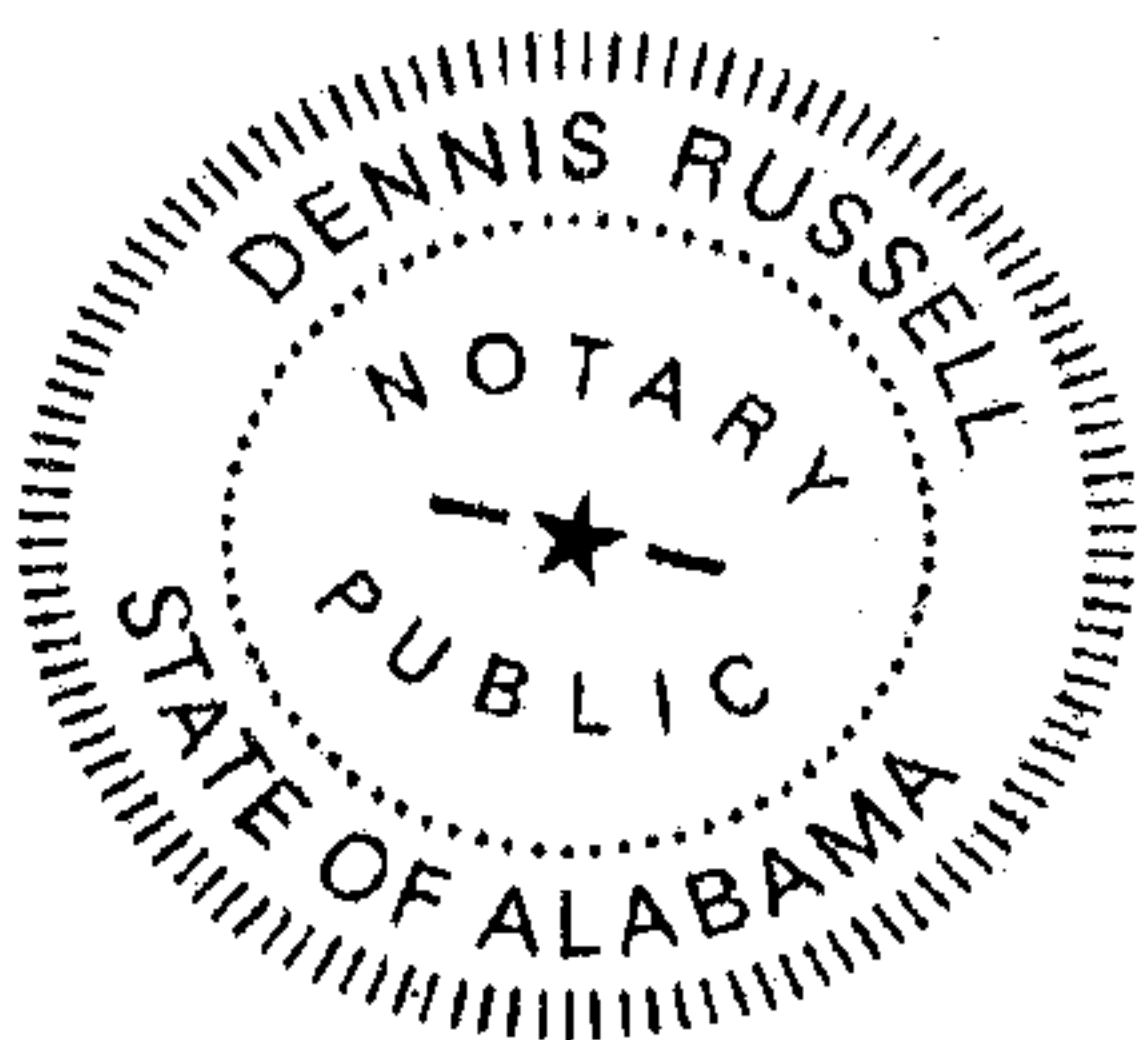


