## **CERTIFICATE OF FORMATION**

**of**

### **3AV INVESTMENTS, LLC**

Pursuant to the Provisions of Section 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Certificate of Formation.

#### **ARTICLE I NAME**

The name of the limited liability company is 3AV INVESTMENTS, LLC (the "Company").

#### **ARTICLE II DURATION**

The Company term shall commence on the date of the filing of the Certificate of Formation in the office of the Probate Judge of Shelby County, Alabama, and shall continue until dissolved (a) upon written consent of all of its members; (b) as provided in any operating agreement entered into by the members; or (c) as required by law.

#### **ARTICLE III PURPOSES**

The purposes for which the Company is organized are to engage in the transaction of any or all lawful business or activity for which limited liabilities companies may be organized under the laws of Alabama.

#### **ARTICLE IV REGISTERED OFFICE; REGISTERED AGENT**

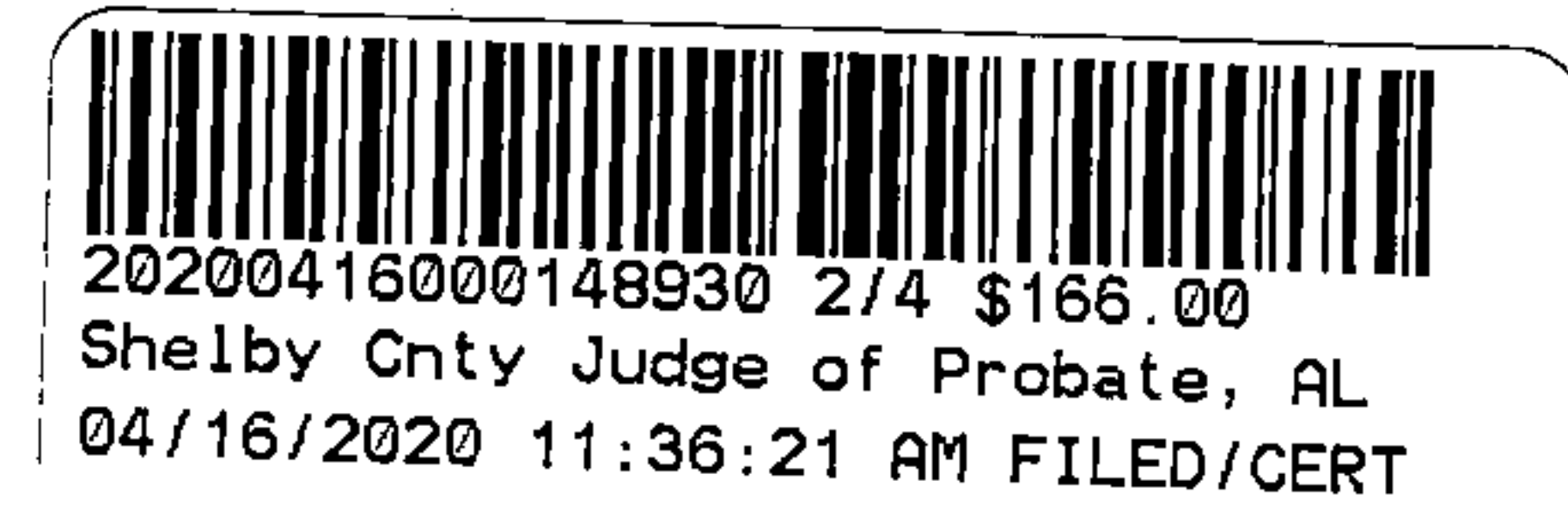
The location and street address of the initial registered office of the Company shall be 1625 Wingfield Drive, Birmingham, Alabama 35242, and its registered

**ARTICLE VI  
ADMISSION OF ADDITIONAL MEMBERS**

The Company shall have the right to admit additional members upon the unanimous consent of the members of the Company and the terms and conditions of their admission shall be set forth in the Company's Operating Agreement.

**ARTICLE VII  
CESSATION OF MEMBERSHIP**

The cessation of membership of one or more members will not result in the dissolution of the Company. The members of the Company shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Company if (i) there are at least two remaining members or at least one remaining member and a new member is admitted; and (ii) the legal existence and business of the Company is continued by a written consent of all of the remaining members within ninety (90) days after the occurrence of the event of disassociation or as stated in the Articles of Organization.

**ARTICLE VIII  
AMENDMENT**


Other than as set forth herein, the Certificate of Formation or the Company's Operating Agreement may be amended by the approval by the affirmative vote of a


majority of the Members. Without the approval of all the Members, no amendment may be made to the Certificate of Formation or the Company's Operating Agreement which shall: (i) change the limited liability of the Members; or (ii) change the term set forth in Article II above.

## **ARTICLE IX MANAGEMENT**

The Company shall be managed by the members. The members may designate an operating Manager or Managers.
