ORDER

P., and be joined as parties in these proceedings since property interests of each of them were implicated. There being no objection stated and for good cause shown the motion is due to be granted.

Further, based upon argument and stipulation of the parties present and agreement of the parties;

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

1. WILLIAM SHYANE SCHRADER, STEPHEN MATTHEW SCHRADER, and CLAUDE JAMES SCHRADER, II, are hereby added as party Defendant/Cross-Claimants in these proceedings adopting all allegations and prayers for relief contained

and set forth in the Cross-Claim filed by Faye N. Schrader, widow of Claude James Schrader, deceased, against Timothy B. Schrader.

- 2. The Quit Claim Deeds attached to the Cross-Claim filed in this matter and which were recorded in the Shelby County probate land records as Document No. 20180226000059250 and Document No. 20180226000059260 on 2/26/2018 and which were signed and-executed by Faye N. Schrader, Claude J.-Schrader, II, William Shyane Schrader, and Stephen Schrader are HEREBY declared VOID and set aside. Clerk is requested to file a copy of this Order voiding the subject Quit Claim Deeds in the Shelby County Probate land records.
- 3. Co-Defendants, Faye N. Schrader, within 90 days is directed to pay to Timothy B. Schrader the sum of \$1,550.23 representing the amount of taxes paid by him for the years 2017, 2018, and 2019 regarding the land at issue in this litigation. Said payment shall be made payable to Timothy B. Schrader and delivered to the chambers of Judge Patrick Kennedy no later than April 28, 2020 at which time Timothy Schrader will be notified the check is available to be picked up.


