(herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Faith Nichole Carlin and Frank Logan Chambers, III
(herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **SHELBY** County, Alabama, to-wit:

Lot 1517, Chelsea Park 15th Addition, according to the map or plat thereof, recorded in Plat Book 50, Page(s) 62A and 62B, in the Office of the Judge of Probate, Shelby County, Alabama.

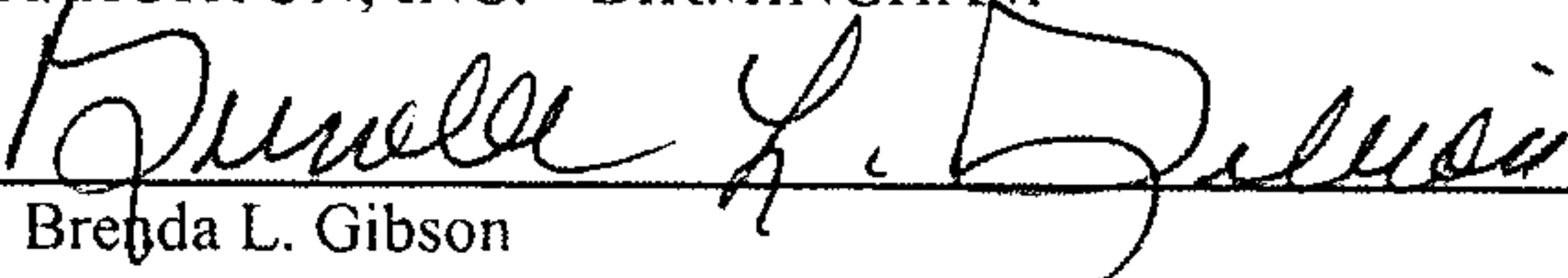

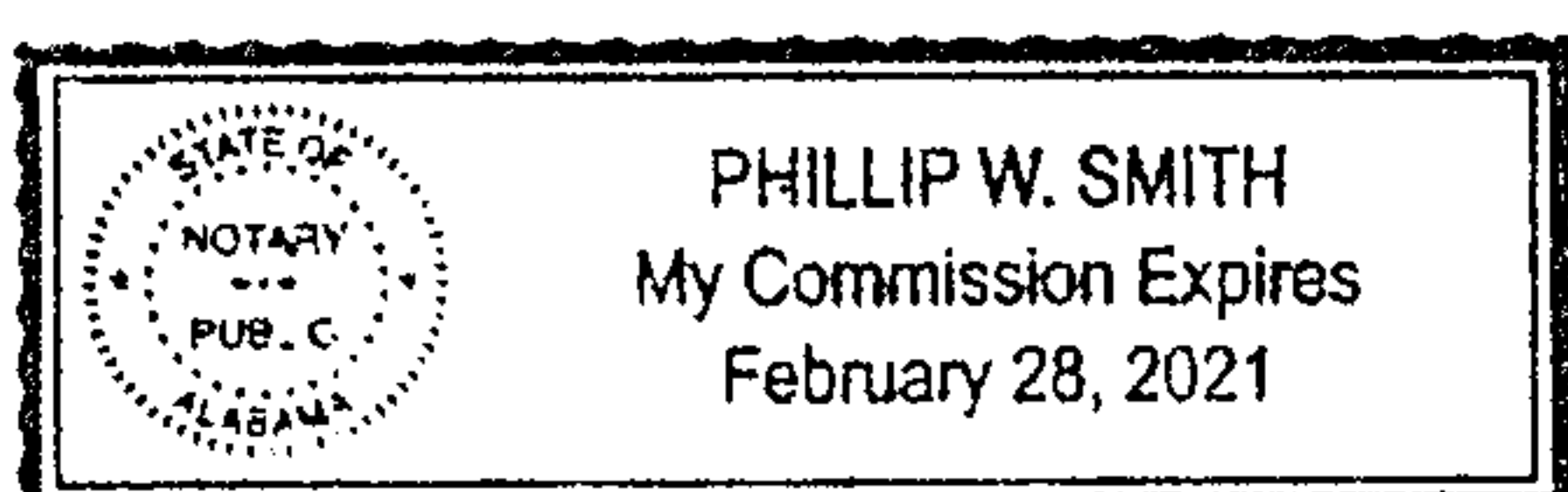

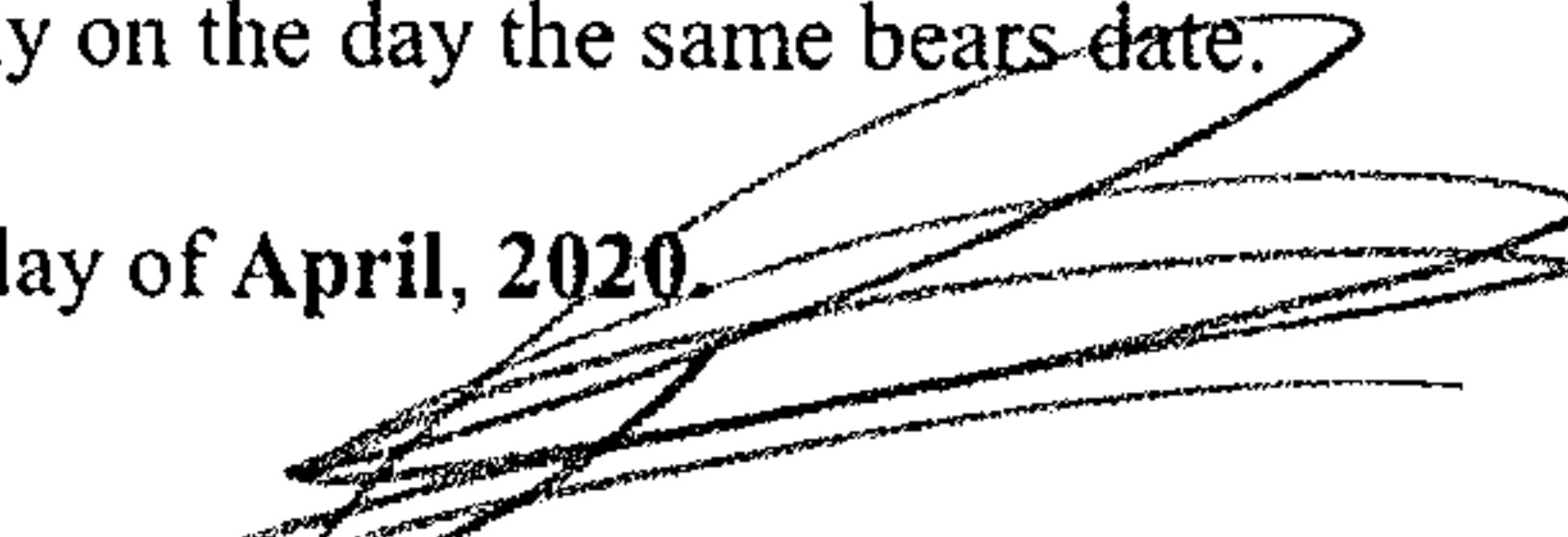
