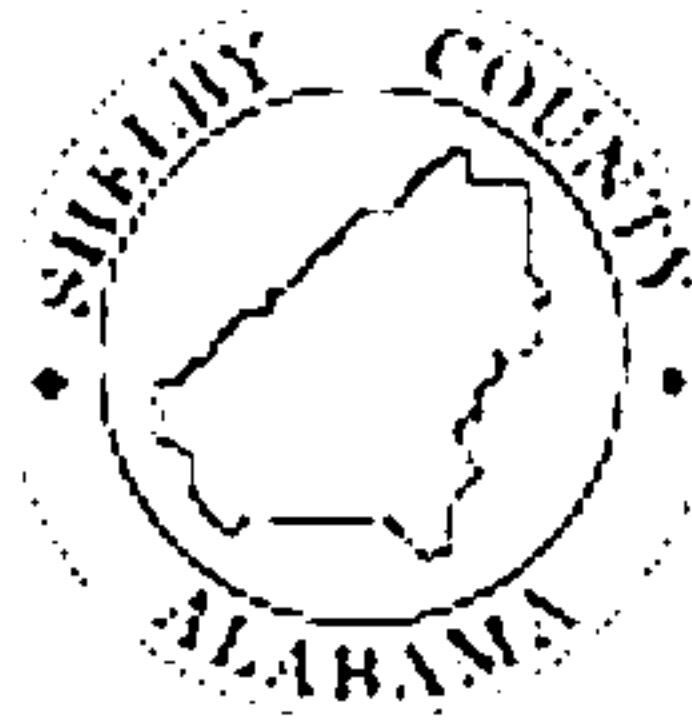

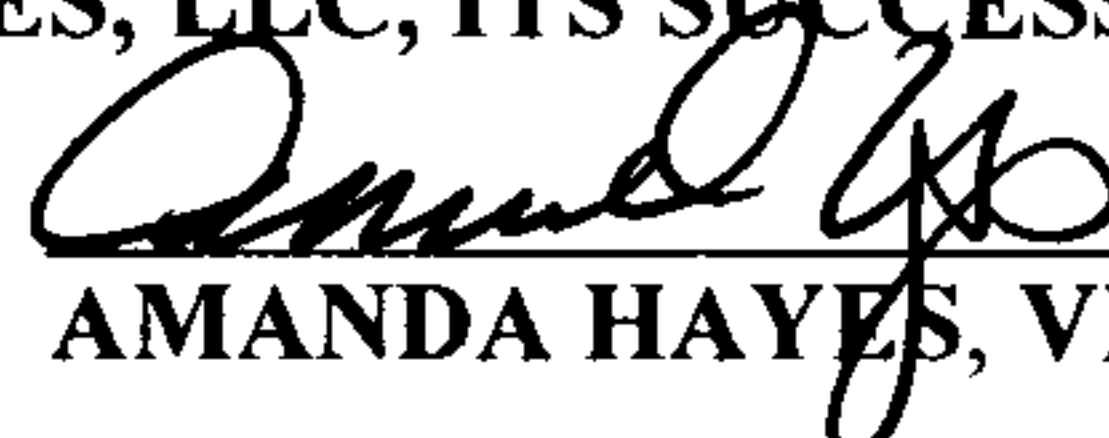


RELEASE OF MORTGAGE

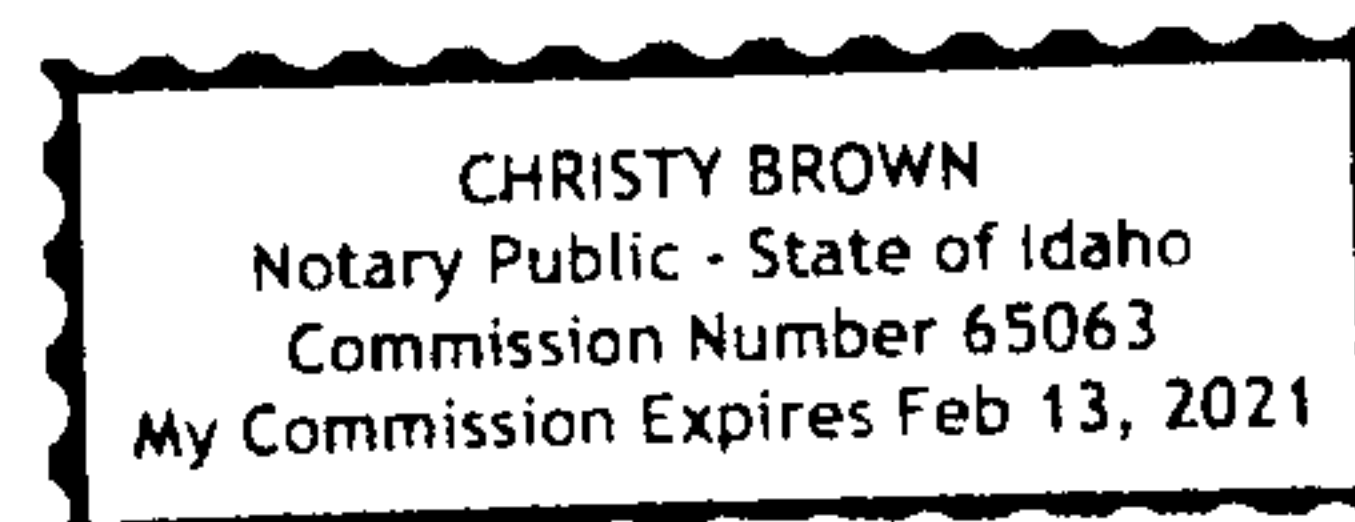
