

SUBORDINATION AGREEMENT

SUBAGREM 1/2

WHEREAS JAIME P SWEENEY and NATHAN SWEENEY, wife and husband hereinafter referred to as the "Borrowers" (whether one or more), has applied to Avadian Credit Union, hereinafter referred to as the "Lender") for a loan not to exceed \$327,000.00 to be secured by a mortgage on the property hereinafter described; and

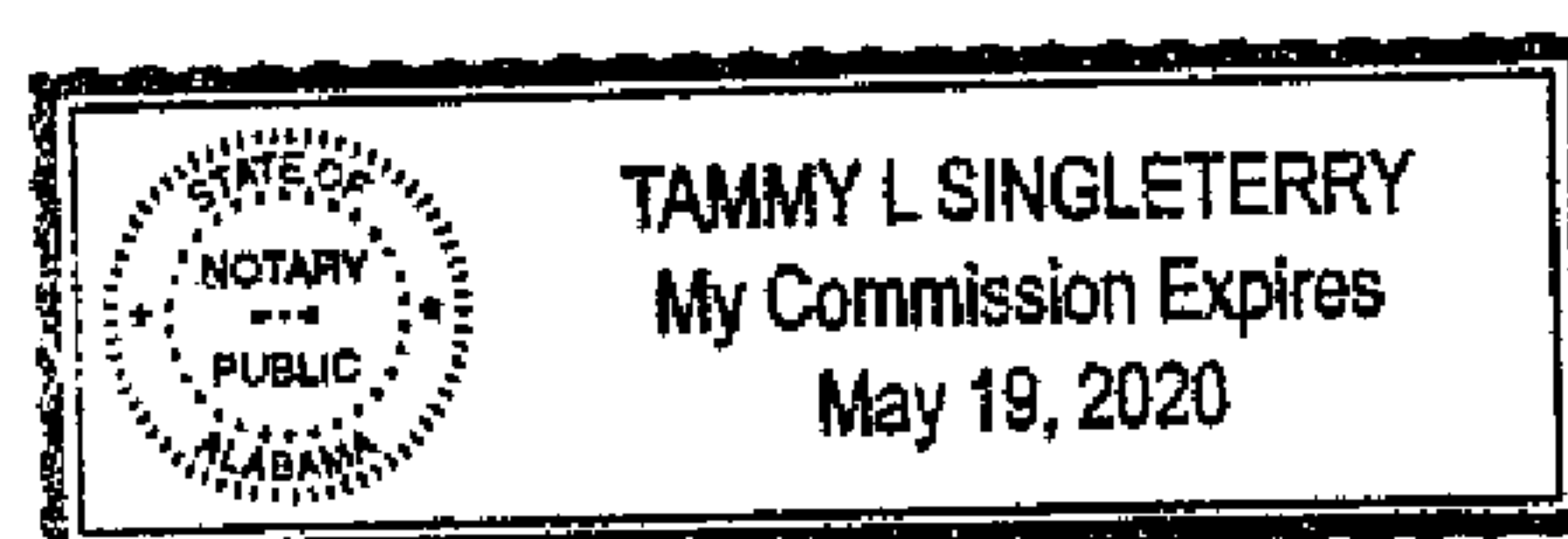

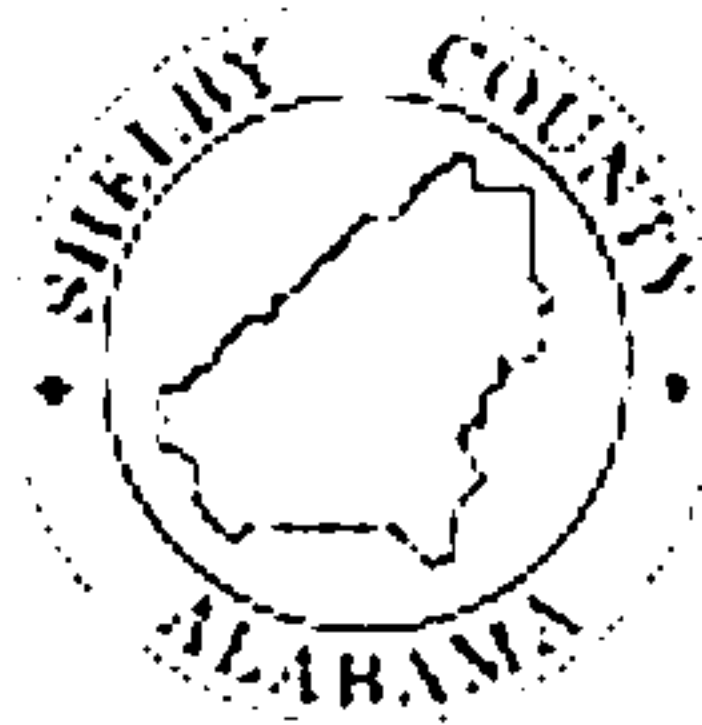
