(herein referred to as GRANTOR, whether one or more) does grant, bargain, sell and convey unto

(herein referred to as GRANTEEs, whether one or more), the following described real estate situated in **SHELBY**
County, Alabama, to-wit:

Associates, Inc., on September 16, 1998, approved by the Montevallo Planning Commission and City

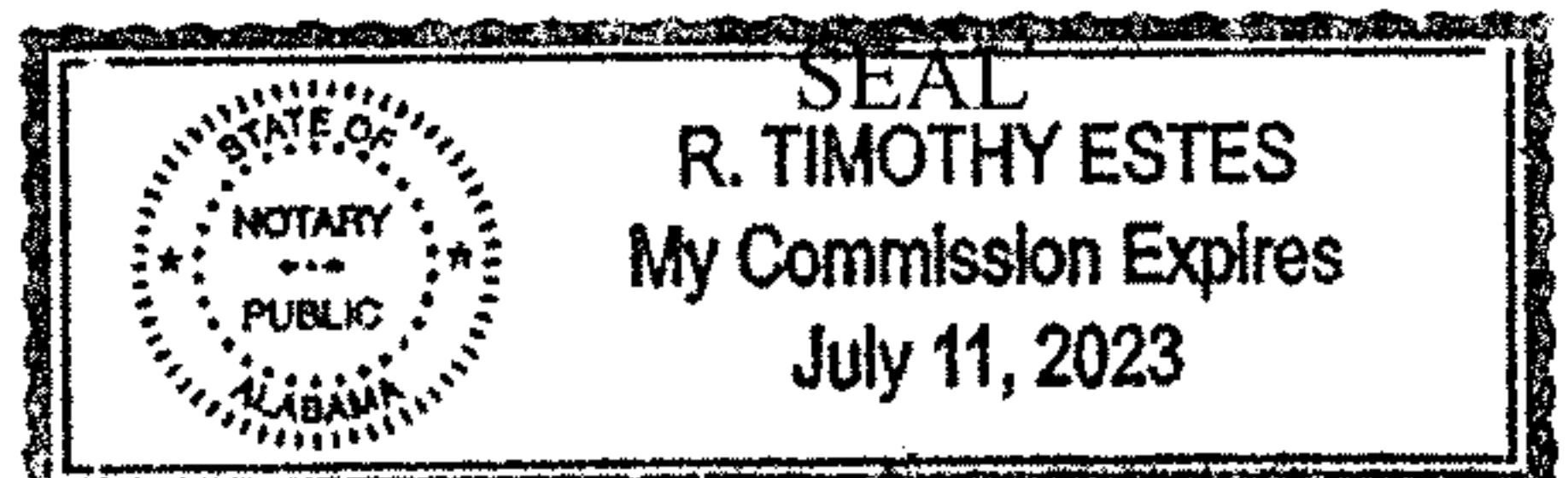

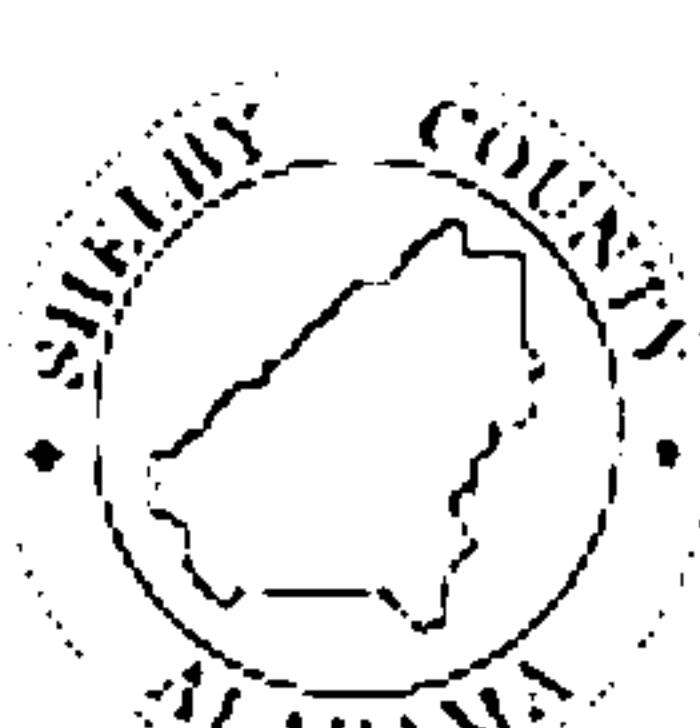
