**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**STATE OF ALABAMA  
COUNTY OF SHELBY**

**KNOW ALL MEN BY THESE PRESENTS,**

That for and in consideration of **THREE HUNDRED FORTY SEVEN THOUSAND FIVE HUNDRED AND NO/100 (\$347,500.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **DAVID E. BAILEY and KERRI M. BAILEY, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **JOHN MONTGOMERY and CYNTHIA MONTGOMERY**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 230-A, according to the Resurvey of Lots 228, 229, 230, 231, 232, and 233, Final Plat, The Woodlands, Sector 2, 4 & 5, as recorded in Map Book 30, Page 96, in the Probate Office of Shelby County, Alabama, LESS AND EXCEPT the following from that certain deed filed of record in Instrument #20040806000442440 further described as follows:

Begin at the most northerly corner of Lot 230A – a Resurvey of Lots 228, 229, 230, 231, 232 and 233 Final Plat the Woodlands Sectors 2-4 and 5 as recorded in Map Book 30, Page 96, Shelby County, Alabama; thence S 47 deg – 23'-25" W, 176.37'; thence N 48 deg-46'-48" E, 156.25'; thence N 41 deg-13'-12" W, 5.0' to the Point of Beginning.

Subject to:

1. General and special taxes or assessments for the year 2020 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 30, Page 96.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


