AGREEMENT FOR AMENDMENT OF PLAT NOTE
FARMINGDALE ESTATES SECTOR FOUR

THIS IS an AGREEMENT between the Town of Harpersville, Alabama, hereinafter referred to as "Town";

AND

SDH BIRMINGHAM LLC, a Georgia limited liability company, and Clayton L. Branum and Aurora M. Mitchell, hereinafter collectively referred to as "Owners".

WHEREAS, Owners are the owners of all Lots, as shown on the final plat of Farmingdale Estates Sector Four, which Plat was recorded in Map Book 39, Page 120, in the Probate Office of Shelby County, Alabama; and

WHEREAS, the Farmingdale Estates Sector Four plat contains the following note on the face of the Plat:

"NOTE: SECTOR FOUR HOMES SHALL HAVE A MINIMUM FINISHED FLOOR ELEVATION OF 2 FT ABOVE TOP OF CURB ON FARMINGDALE LANE."

(the "Note"); and

WHEREAS, the Owners and the Town have determined there exists a need to delete said Note because the requirements in the Note are not required by the Town; and

WHEREAS, the Town has no objection to deleting the Note and the Town has duly approved the deletion of said Note;

NOW, THEREFORE, in consideration of the mutual terms, conditions and promises hereinafter set forth, the Town and Owners agree as follows:

1. The above recitals and representations are true and correct.
2. The Town and Owners hereby agree that the Note is hereby deleted.
3. This Agreement shall be recorded in the Probate Office of Shelby County, Alabama, to evidence the agreements and representatives of the parties as set forth herein.

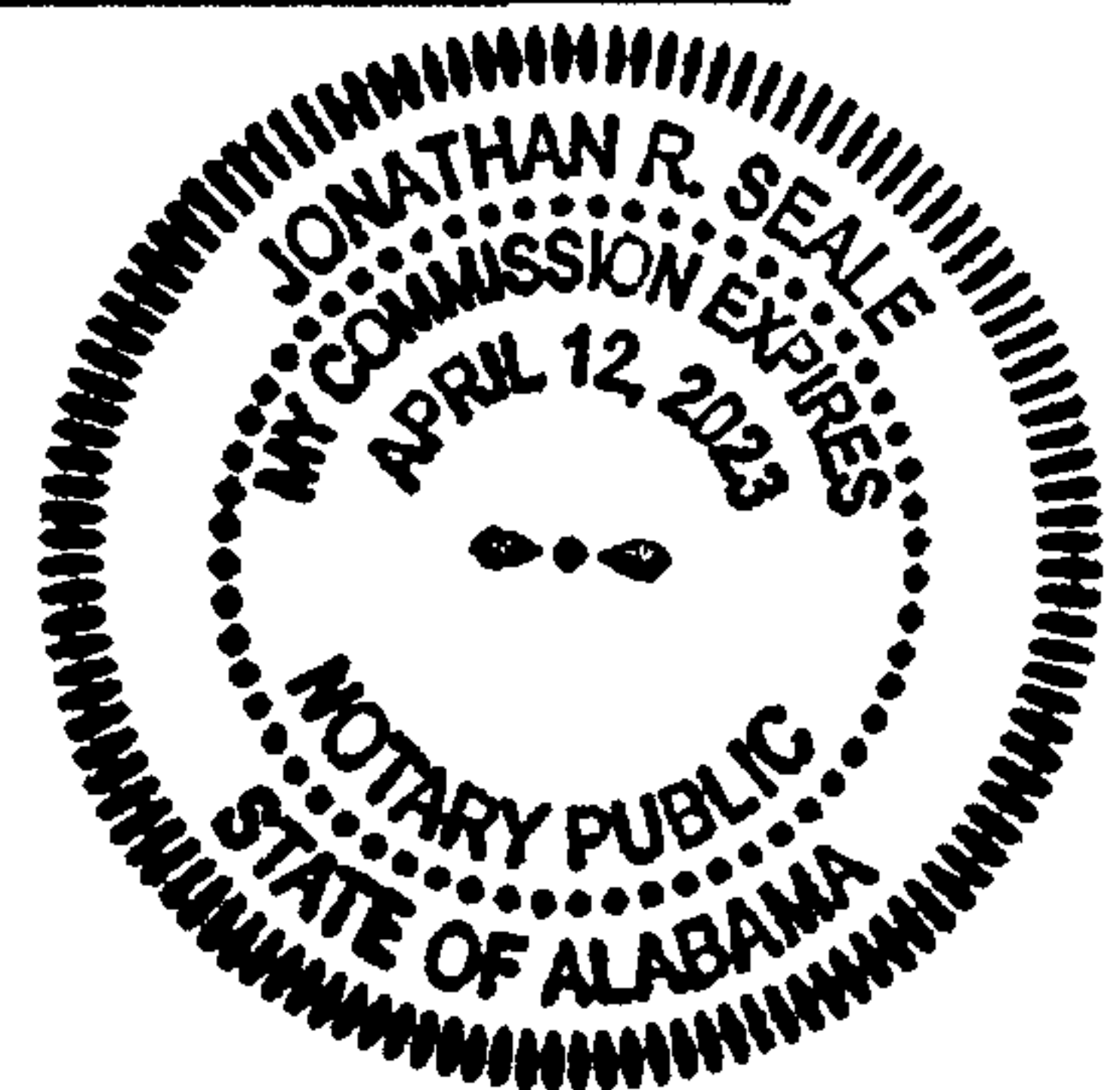

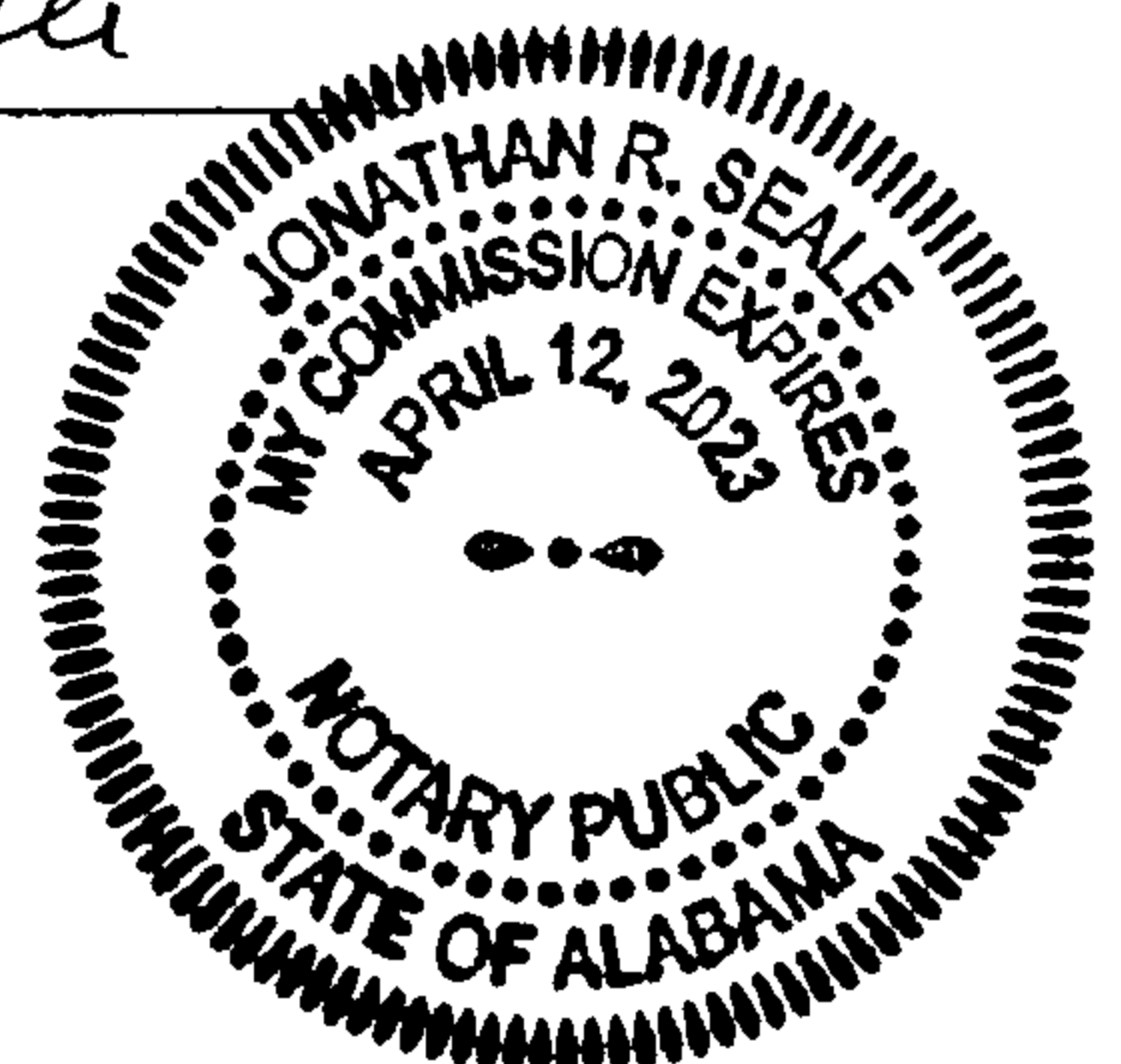

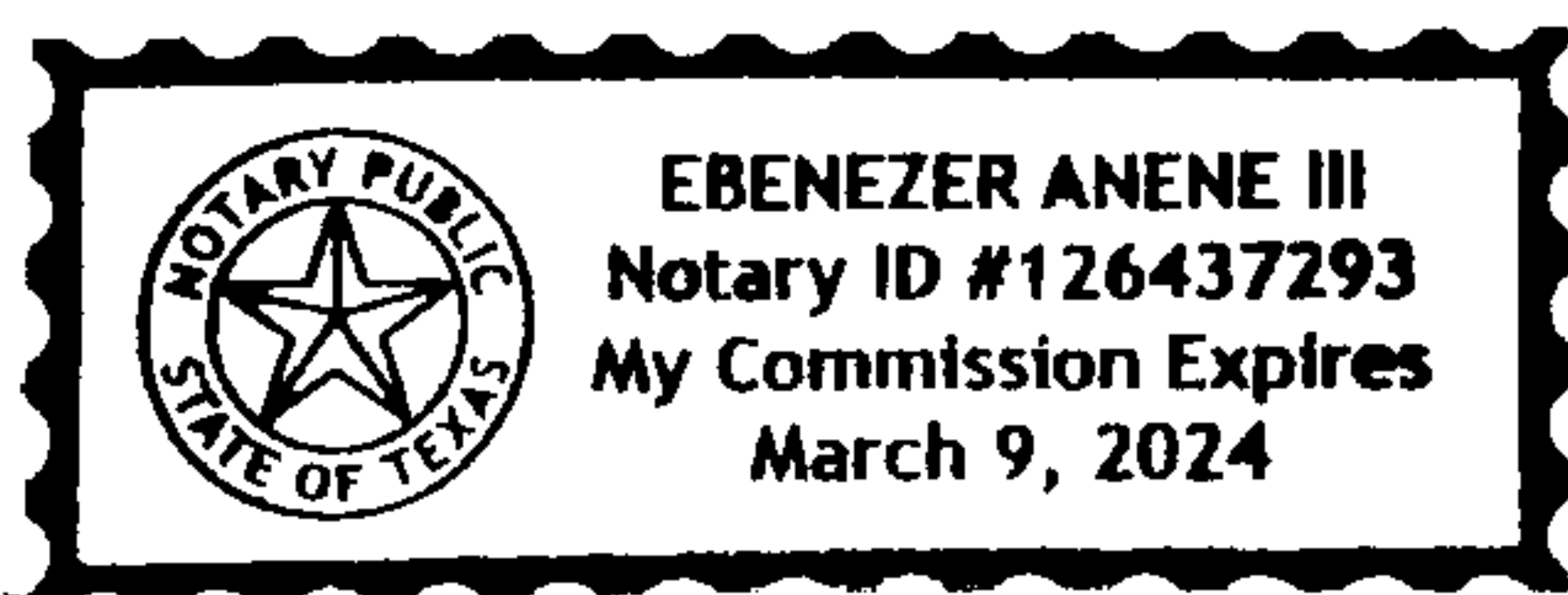
