That in consideration of the sum of **Two Hundred Forty Five Thousand Dollars and No Cents (\$245,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Christopher R. Wood and Rachael Wood**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Joel Miller and Brenda Miller**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, ; to wit;

Lot 50, according to the Survey of Hidden Springs, Sector 1, as recorded in Map Book 27, Page 69, in the Probate Office of Shelby County, Alabama.

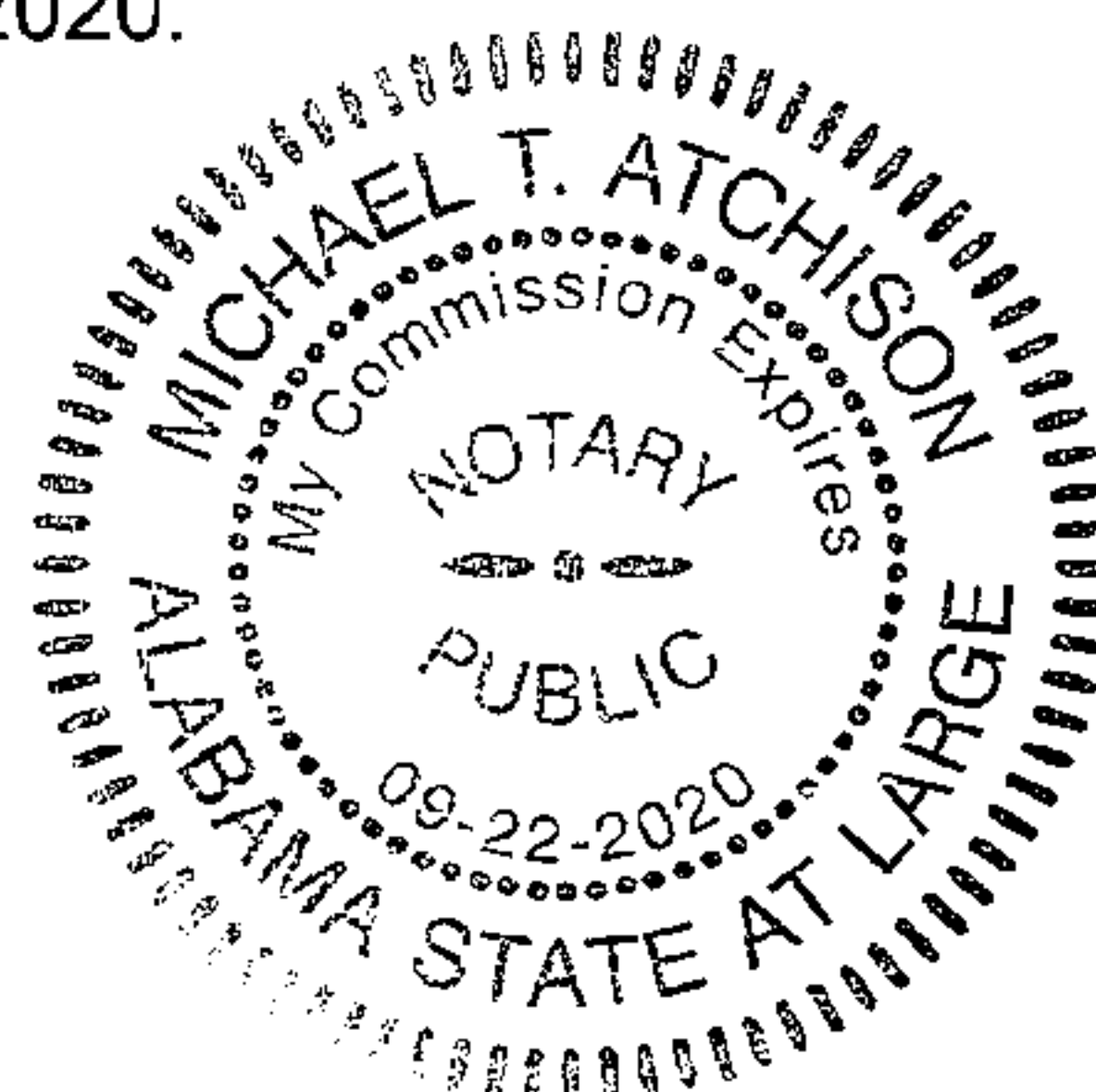

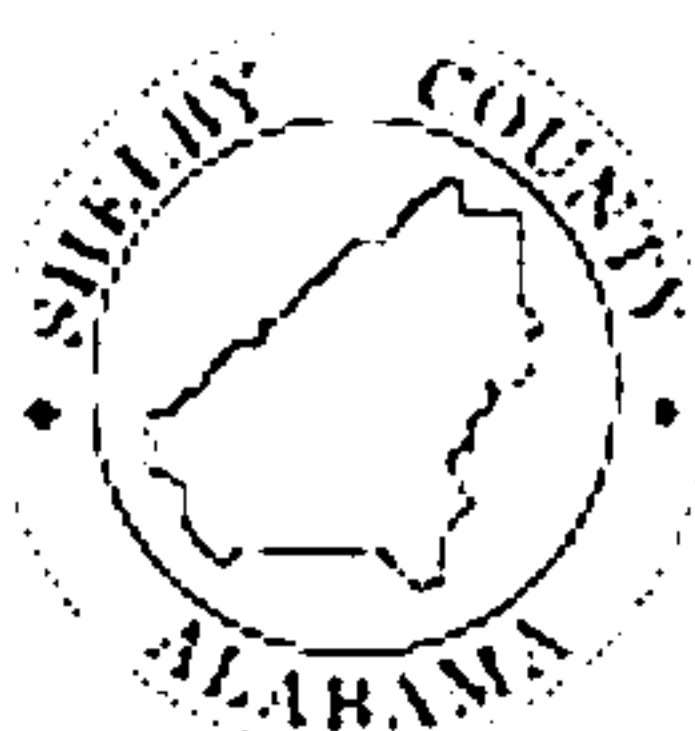
