**NOTICE OF ATTORNEY'S LIEN**

Said lien originates from paragraph six (6) of the "Second Amended Final Order" filed in the Domestic Relations Division of the Circuit Court of Shelby County on January 18, 2019, case numbers 58-DR-2015-900468.01, 58-DR-2015-900468.02, and 58-DR-2015-900468.03. Said paragraph reads as follows:

*"That the motion for Guardian Ad Litem fees, filed by Theresa Terrebonne, is hereby granted. The Guardian Ad Litem (GAL) fees shall be paid in the amount of \$10,000.00. The Plaintiff shall be responsible for Thirty Percent (30%) of said fee and the Defendant shall be responsible for Seventy Percent (70%) of said fee. Said amount shall be paid to Theresa Terrebonne within Sixty (60) days of the executed agreement or upon the sale of the residence located at 432 Ramsgate Drive, Maylene, AL 35114, whichever occurs first."*

The aforementioned "Second Amended Final Order" was subsequently filed in the Probate Court of Shelby County on April 30, 2019 to secure further this lien.

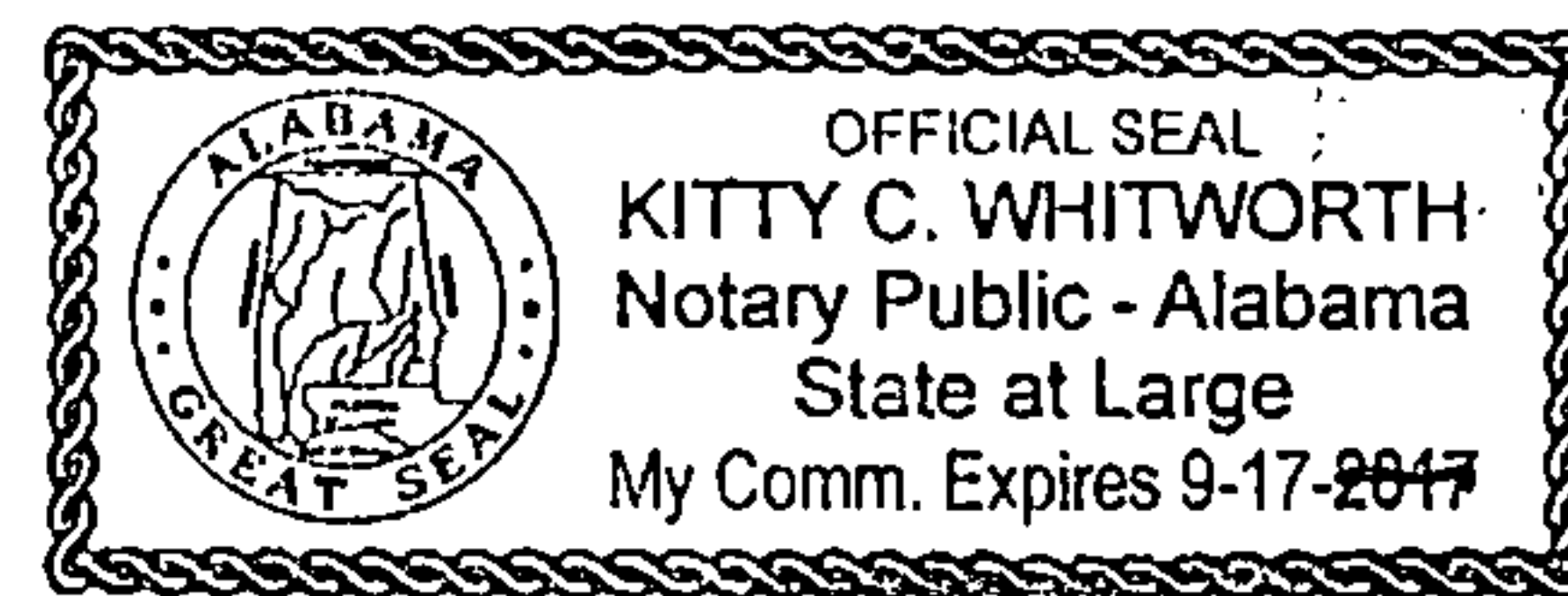
