9. The affiant requests entry of judgment by the Court.

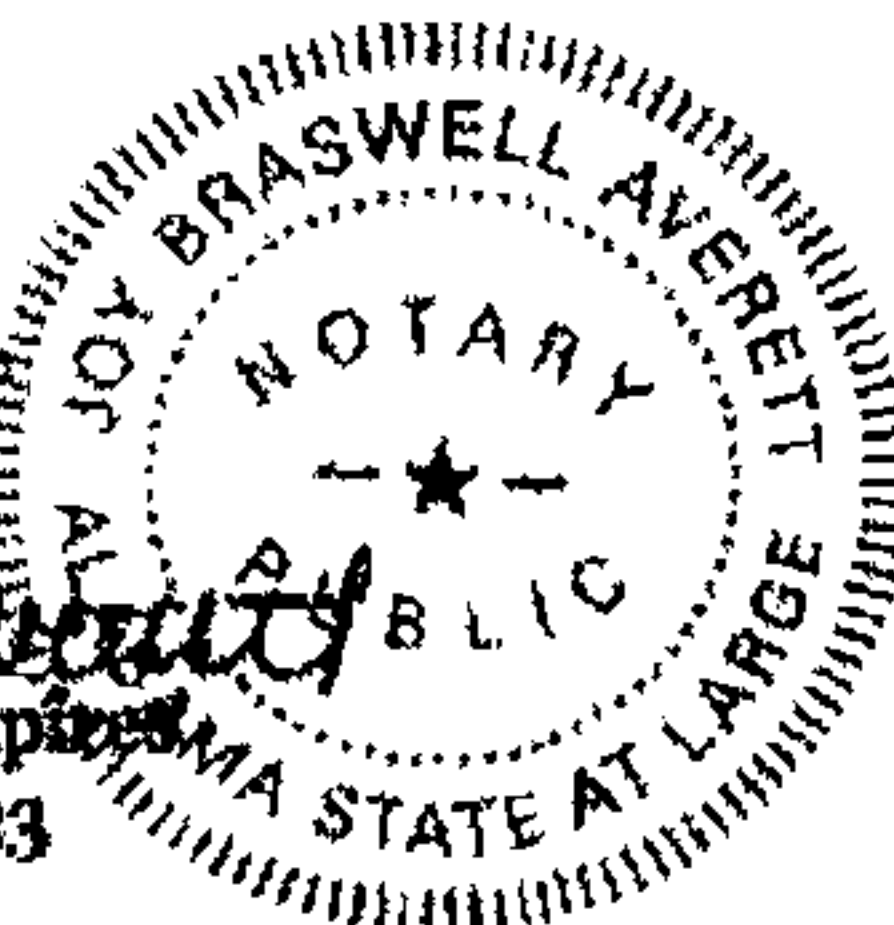

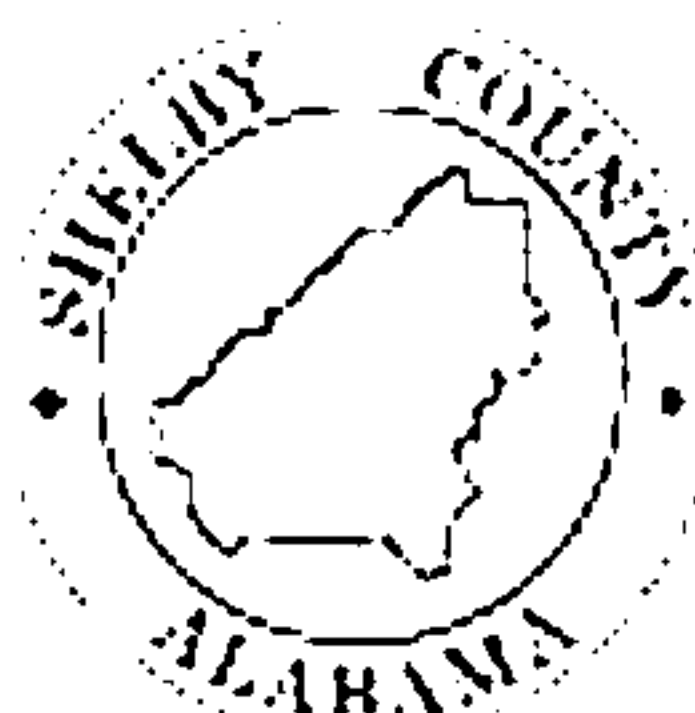
