Subject to: Easements, Restrictions and Rights-of-Way of record.

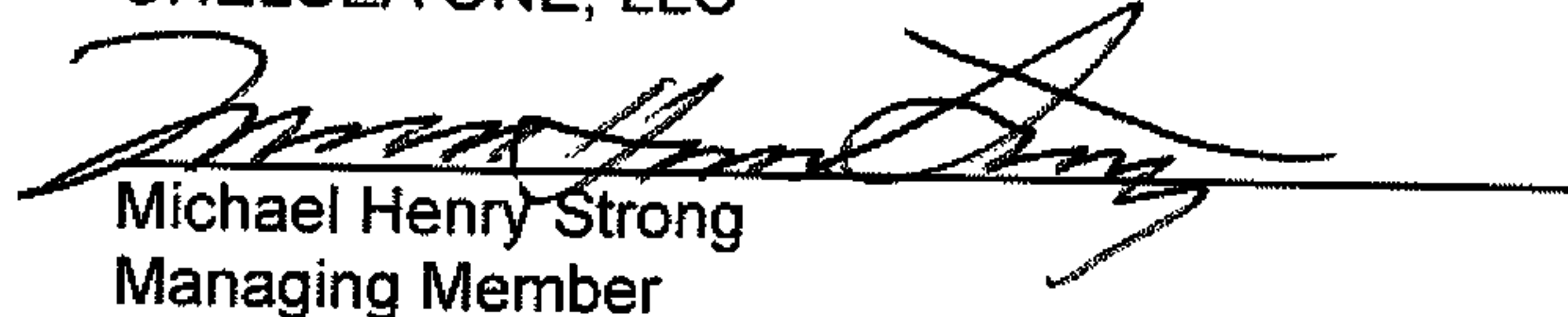

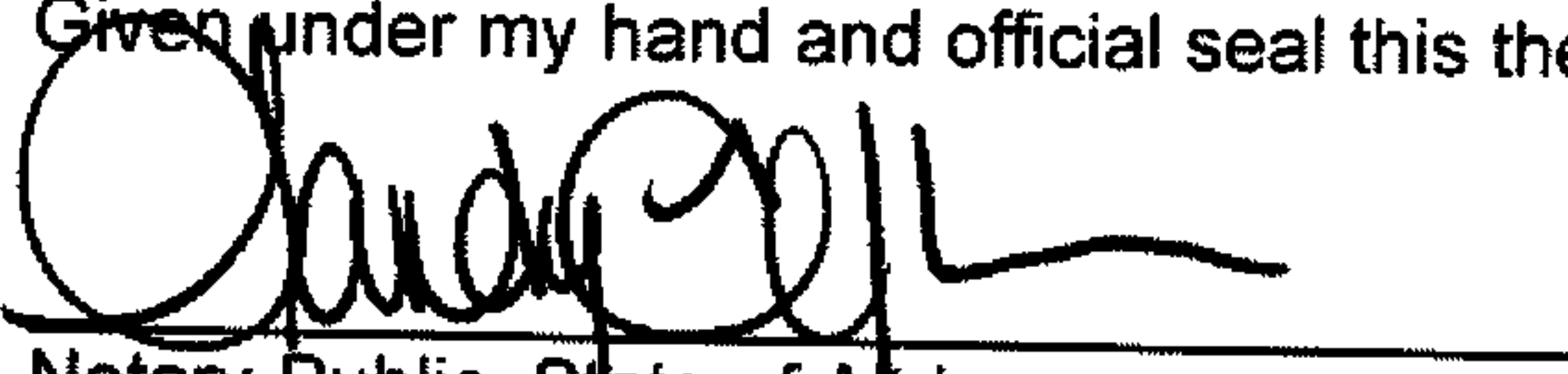

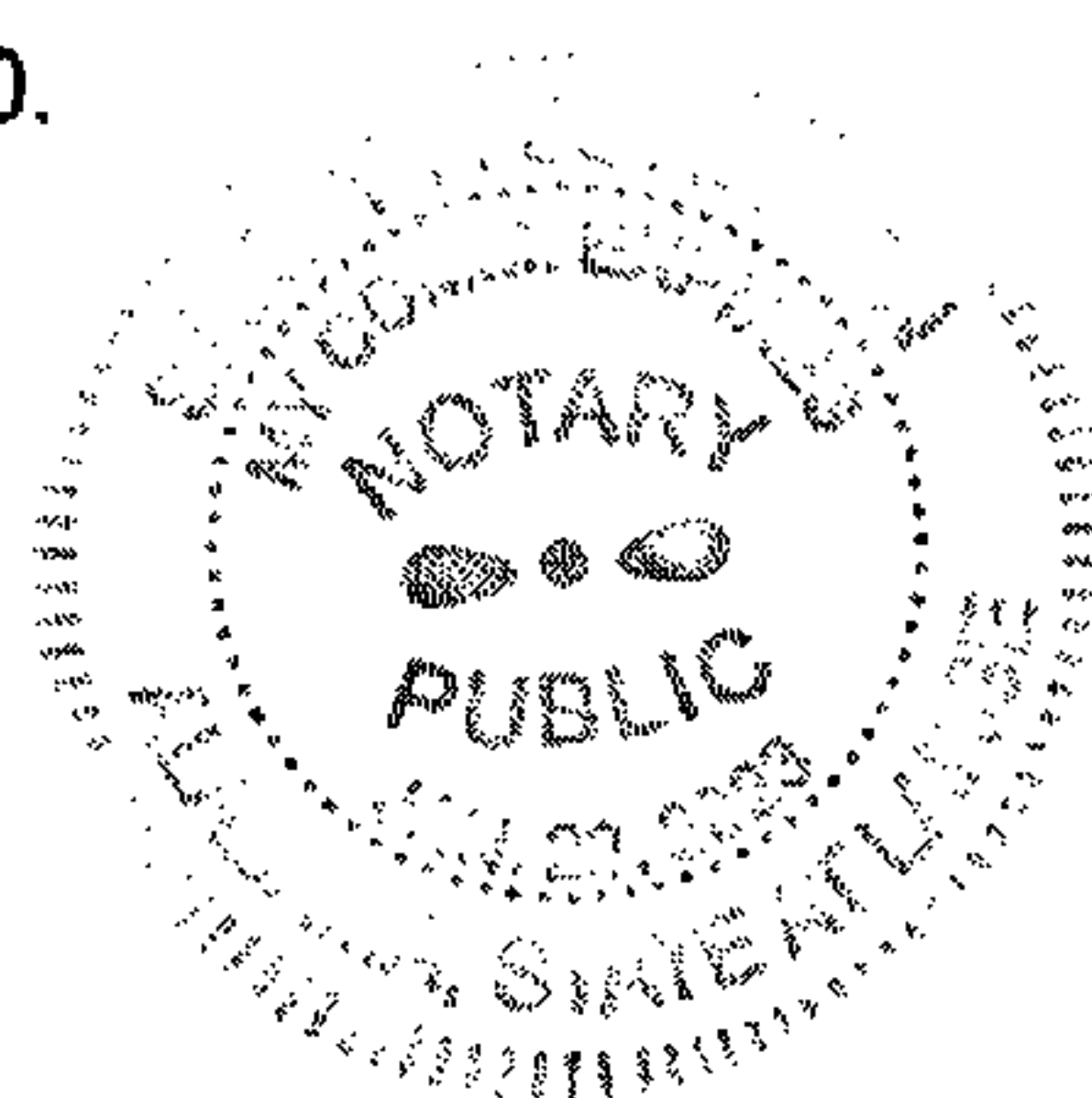
