That in consideration of the sum of **One Hundred Forty Seven Thousand Five Hundred Dollars and No Cents (\$147,500.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Robert Irwin, a single man** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Gratton Berens and Tessa N. Berens**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

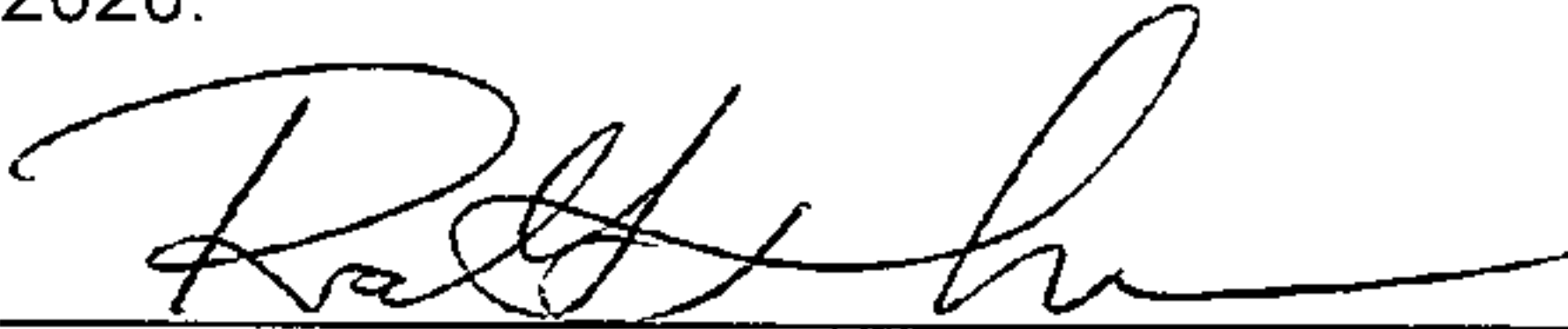
Property may be subject to all covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded.

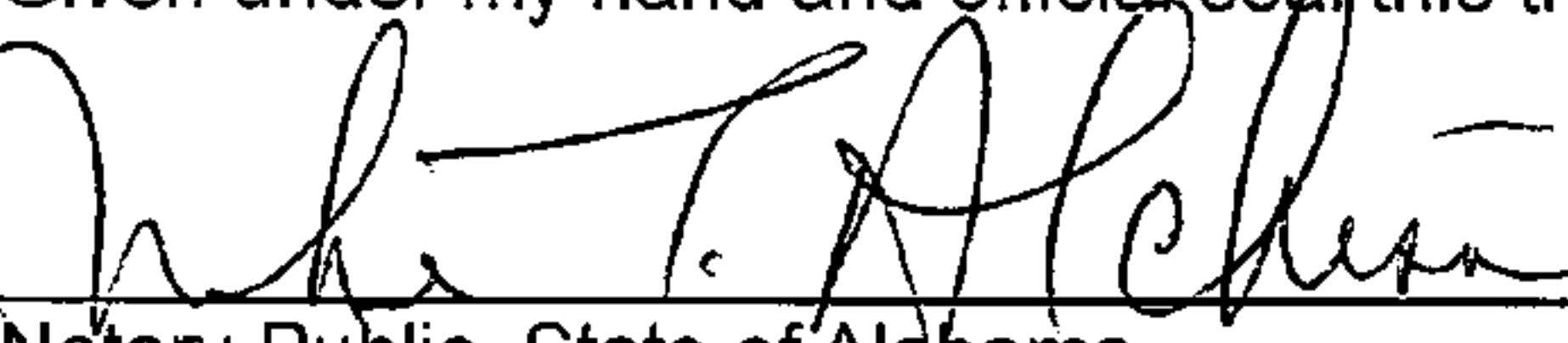

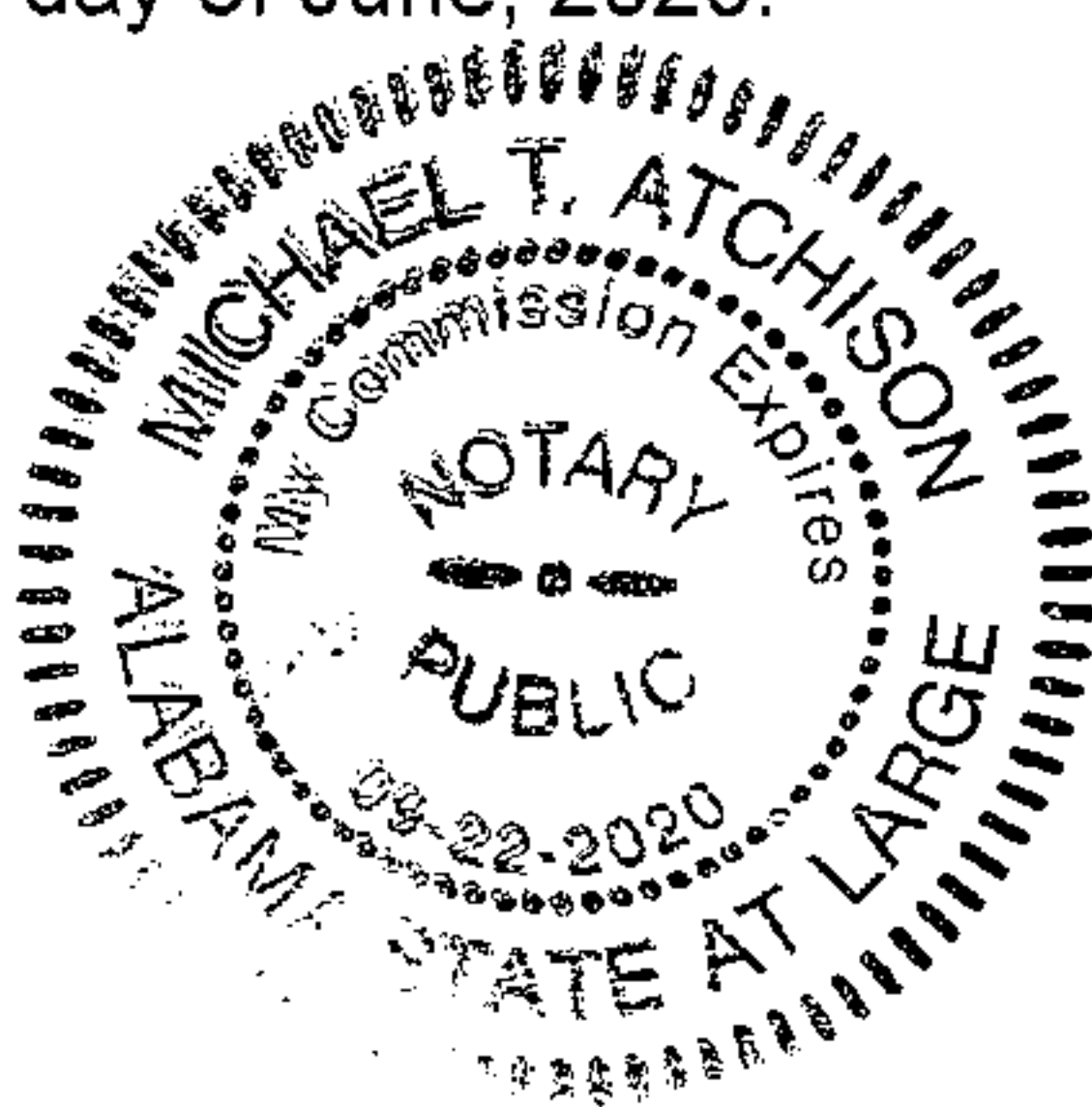

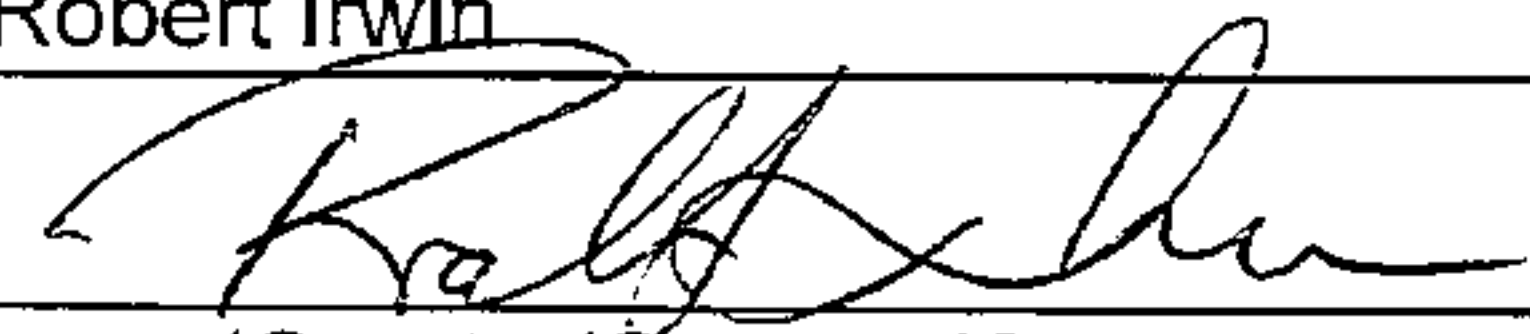
