

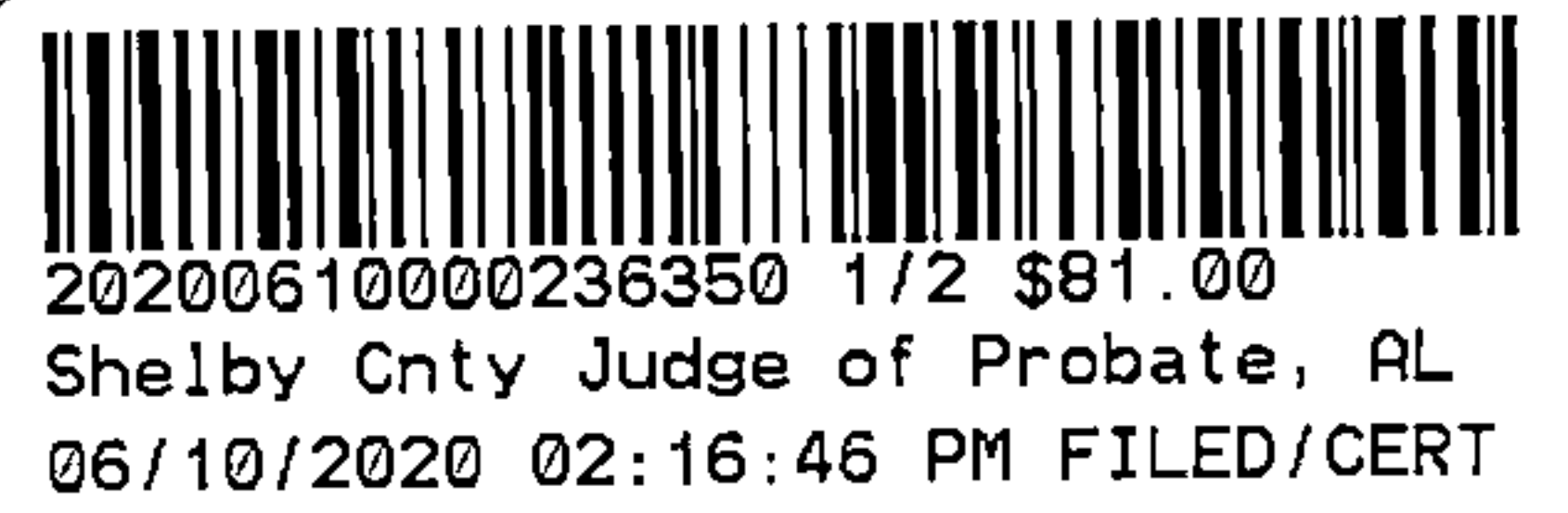

KNOW ALL MEN BY THESE PRESENTS, That in consideration **FIFTY FIVE THOUSAND DOLLARS AND NO CENTS (\$55,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, we, **Tracy A. Chew, a married woman (herein referred to as Grantor)** grant, bargain, sell and convey unto **Tracy A. Chew, Mary Olivia Francine Chew and Bonnie Grayson Chew IV (herein referred to as Grantees)**, the following described real estate, situated in: **SHELBY County, Alabama, to-wit:**

Lot 2, according to survey of Alexander Family Subdivision, recorded in Map Book 43, Page 3, Probate Office of Shelby County, Alabama.

SUBJECT TO:

1. Ad valorem taxes due and payable October 1, 2020.

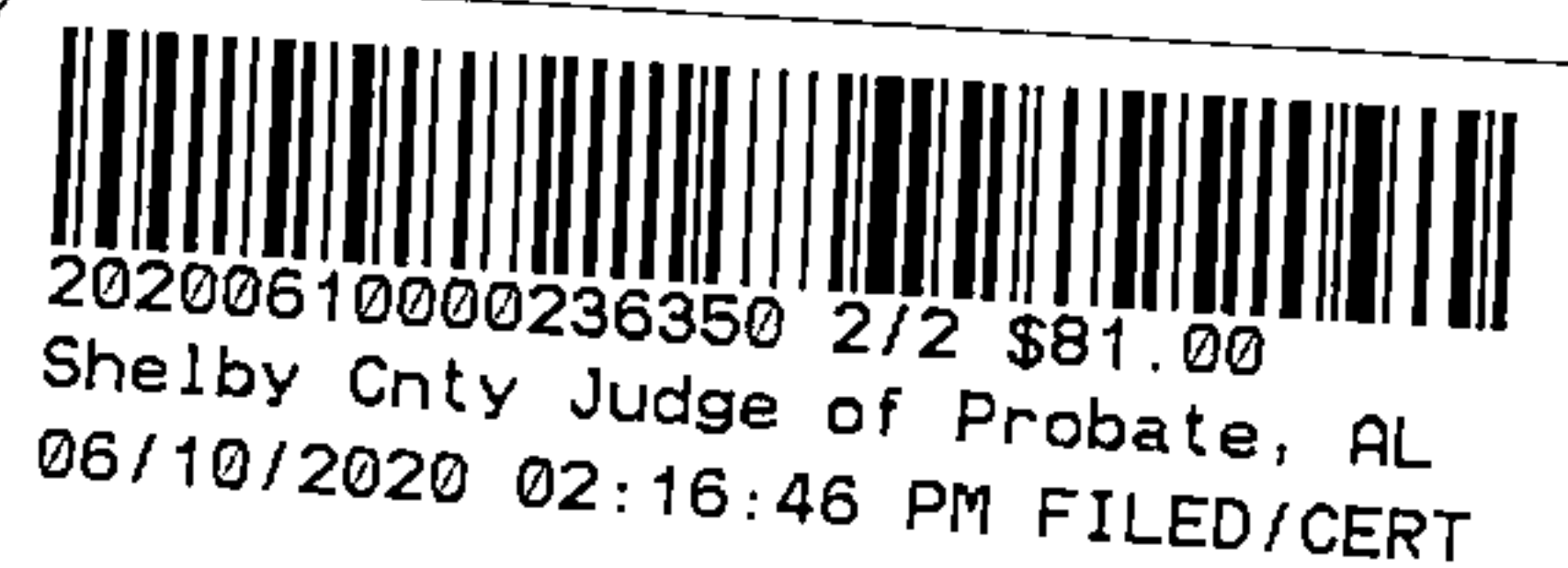
