
**ARTICLES OF ORGANIZATION
OF
PAYTON TRUCKING LOGISTICS, LLC**

In accordance with the provisions of Section 10-12-1, et seq. of the Code of Alabama (1975), the undersigned hereby adopts the following limited liability company articles of organization.

Article I – Name

The name of the limited liability company is PAYTON TRUCKING LOGISTICS, LLC (herein the “Company”).

Article II - Duration


