WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA

KNOW ALL MEN BY THESE PRESENTS,

That for and in consideration of **TWO HUNDRED SIXTY THOUSAND AND NO/100 (\$260,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **EDWARD A. BULL and JERRI C. BULL, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **JEREMY FALLETTA and BRANDY SKINNER FALLETTA**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 51 according to the Survey of Royal Oaks Third Sector First Addition as recorded in Map Book 8, Page 26, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2020 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book , Page .
7. Building setback line of 30 feet reserved from Royal Court as shown by plat.
8. Public utility easements as shown by recorded plat, including 7.5 foot easement on the Southeasterly and a 10 foot easement on the Northeasterly side of subject lot.
9. Restrictions, covenants and conditions as set out in instrument recorded in Misc. Book 44, Page 709.
10. Easement to South Central Bell as shown by instrument recorded in Deed Book 329, Page 432.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.




