Subject to mineral and mining rights if not owned by Grantor. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.


\$263,215.00 and \$56,900.00 of the purchase price herein above has been paid by a purchase money mortgage loan closed simultaneously herewith.

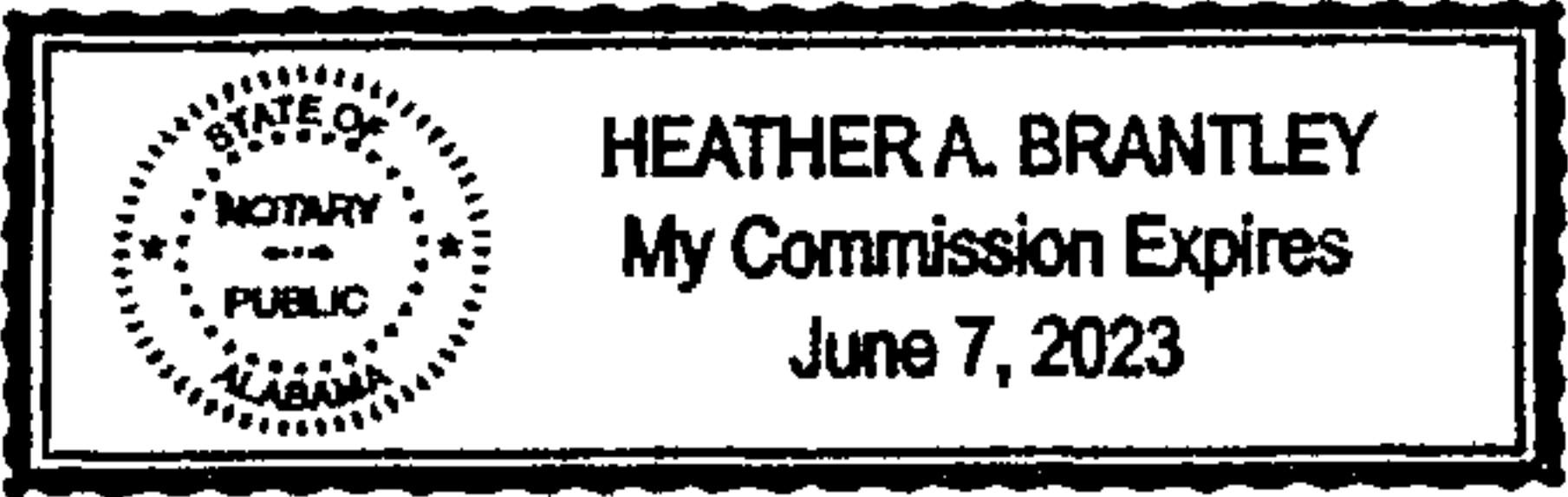




