

**ARTICLES OF ORGANIZATION  
OF  
CP CARD LLC**

KNOW ALL MEN BY THESE PRESENTS: That we, Paul McCarthy, and Curtis Falany, desiring to form a limited liability company for the purposes set forth herein and in conformance with the Alabama Limited Liability Company Act, do establish:

1. Company Name: That the name of the limited liability company is CP CARD LLC.
2. Duration: That the period of duration of this limited liability company is perpetual from the date of filing hereof with the State of Alabama, unless sooner dissolved as provided by Alabama law.
3. Purpose: That the purpose for which this limited liability company is organized is primarily to engage in consulting and printing of sports cards and any other services that are permitted by law, within and without the state of Alabama as the laws of Alabama and other states permit.
4. Principal Place of Business: That the address of its principal place of business shall be 490 1<sup>st</sup> Street SW, Alabaster, AL 35007, Shelby County, Alabama until other space is found.
5. Registered Agent and Office: That the name of its registered agent, who does Consent to Appointment as Registered Agent, is Paul McCarthy and the mailing address of the agent at the registered office is P O Box 170745, Birmingham, AL 35217.
6. Initial member(s): The name and address of the initial member(s) are:

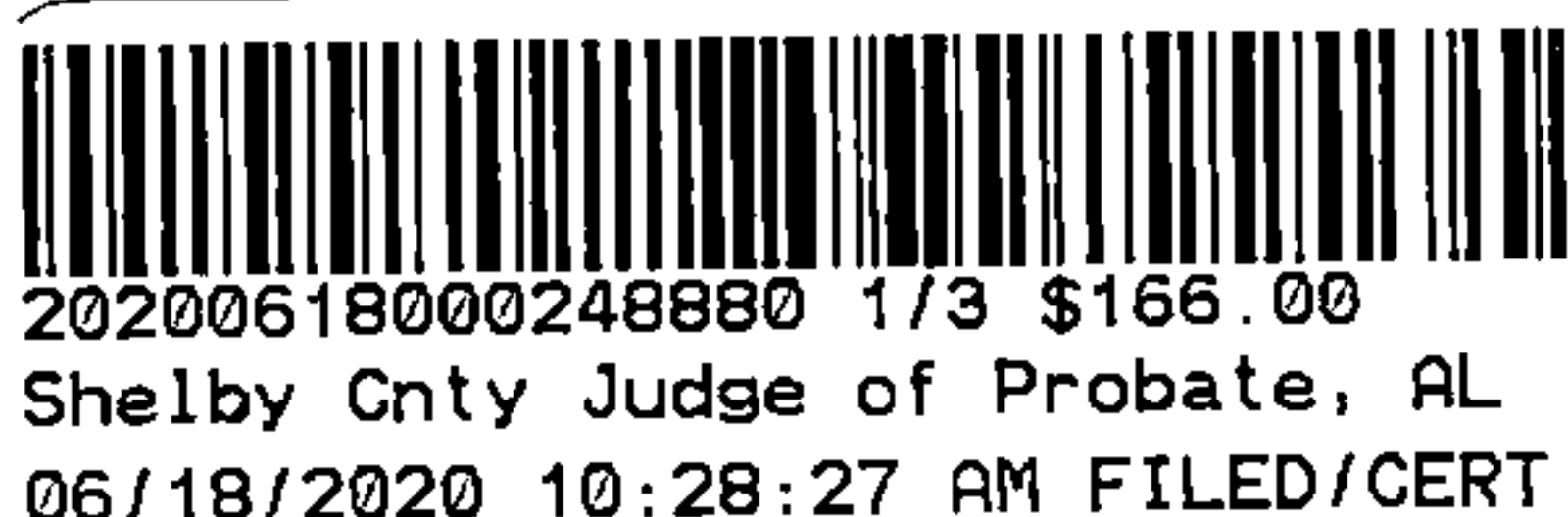

7. Capitalization: That the total capital contributions of each Member, which is his respective undivided interest in personal property having at least a value totaling Two Hundred (\$200.00) and 00/100 dollars should be allocated at follows:

Paul McCarthy – 50%  
Curtis Falany – 50%


8. Additional Liability of Members: That no additional capital contributions will be required.
9. Admission of Additional Members: That additional Members will be admitted or expelled only with the unanimous consent of all Members entitled to participate in management and upon such terms as are unanimously agreed to by all Members entitled to a dividend upon dissolution or liquidation.



10. Continuity of Life: That the remaining Members of the limited liability company may only have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other even which terminates the continued Membership of a Member in this limited liability company if they unanimously elect to do so. The return of capital and the distribution of profits shall be determined from the Company's books, as of the effective date of withdrawal, based on generally accepted accounting practices, and paid as soon as practicable without diminishing the prospects of the Company's ventures and subject to the limitation of the Alabama Limited Liability Company Act.

11. Management: The business of the company shall be conducted under the exclusive management of its Members, or outside managers if its Members unanimously elect, who shall have exclusive authority to act for the company in all matters. The Members may from time to time designate certain Members as Officers to act for the Company in certain matters as specified by the "Operating Agreement". Any provision that is not inconsistent with the law for the regulation of the internal affairs of the Limited Liability Company is permitted to be set forth in the operating agreement of the LLC.


