

#### CERTIFICATE OF FORMATION OF

Pursuant to the Provisions of Section 10A-5A-2.01 to 10A-5A-2.06, Code of Alabama (1975), the undersigned being a natural person of at least 18 years of age and acting as the organizer of the limited liability company hereby being formed hereby adopts the following Certificate of Formation for the limited liability company.

#### **ARTICLE I**

#### Name


