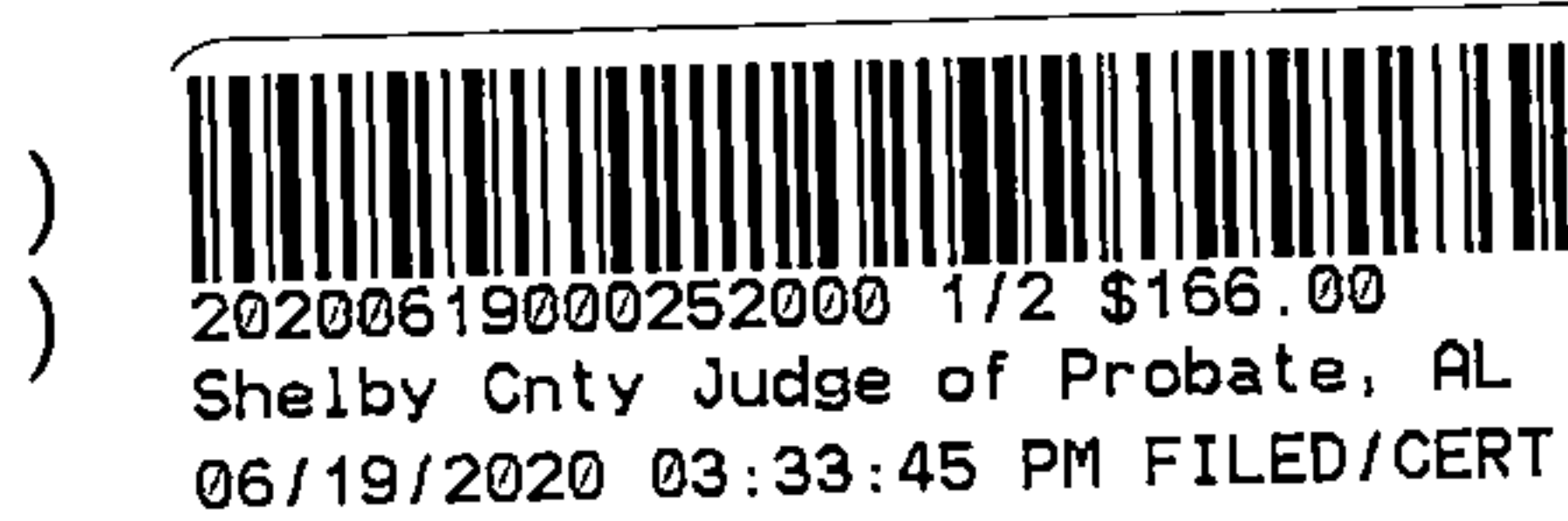

**CERTIFICATE OF FORMATION
