**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**KNOW ALL MEN BY THESE PRESENTS,**

That for and in consideration of **TWO HUNDRED TWELVE THOUSAND AND NO/100 (\$212,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **KATHY CARLSON GOSPODARECK (WHO IS ONE AND THE SAME PERSON FORMERLY KNOWN AS KATHY WHITMAN) and KEITH GOSPODARECK, wife and husband**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **CALEB J. OEDER and MAKENZIE R. SNYDER**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 11, Block 3, according to the Survey of Plantation South Second Sector, Phase No. 1, as recorded in Map Book 9, Page 115, in the Probate Office of Shelby County, Alabama.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.



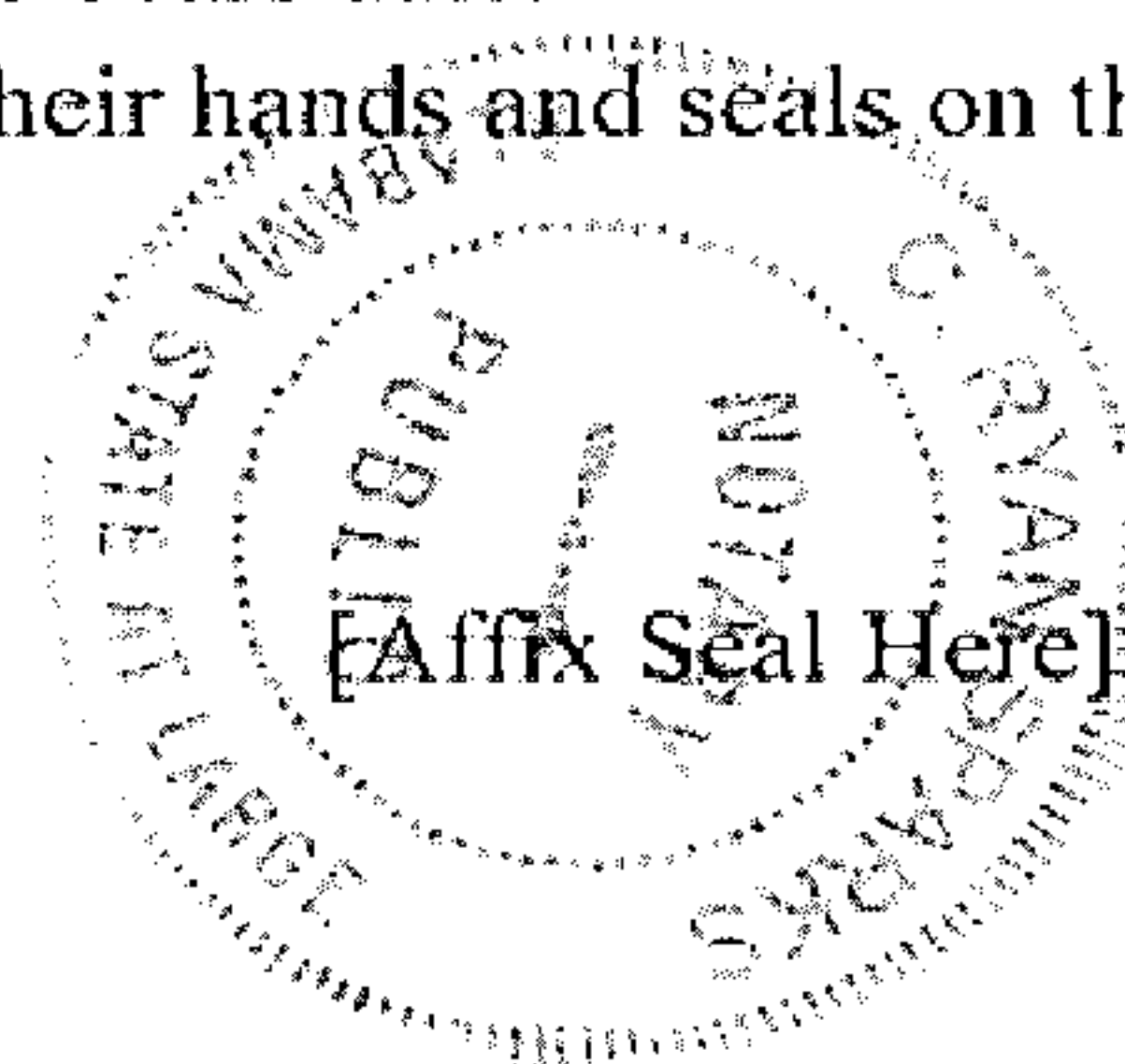
