KNOW ALL MEN BY THESE PRESENTS: That in consideration of **Six Hundred Thirty-Eight Thousand Five Hundred and No/100 Dollars (\$638,500.00)** and other good and valuable consideration, to the undersigned grantor, in hand paid by the grantees herein, the receipt where is acknowledged I, **W. Casey Duncan, as Conservator of the Estate of Theodore Martin Kluz, Shelby County Probate Court Case No.: PR-2019-000645** (herein referred to as grantor), grant, bargain, sell and convey unto **Jeremy Walker Young and Elise D'Alessio Young**, (herein referred to as grantees), for and during their joint lives, and upon death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:
